At the Primary Elections for the Office of Emperor, four individuals were selected as Candidates for Emperor 1973. The Candidates are Don Berry, Ron Ernst, Elizabeth Lane, and Marcus Manulis.

The Primary Elections were held on August 30, at seven locations in San Francisco, one in the East Bay, and one in the Peninsula. Approximately 450 individuals and 100 businesses cast votes in the two part Primary Election system.

The Candidates will now go before a panel of judges in private individual interviews. The five judges will individually rate the Candidates on the basis of clarity of stated ideas, personal appearance and presentation, leadership ability, and other areas to be defined by the judges themselves.

At the Coronation, to be held September 29, at California Hall, the Candidates will be presented to the audience. Each Candidate will be asked the same question relevant to the issues in the Gay community today. The audience as individuals will vote, in a carefully monitored system, on the basis of spontinuity, general appeal, and personal judgement.

Combining judges decisions and audience selection, San Francisco will Elect its first Emperor.

GAY LIB LEADER SLAIN By Don Jackson

Ralph Schaffer, 45, one of the co-founders of the GAY LIBERATION FRONT and prominent journalist was found dead from bullet wounds August 29.

Schaffer's body was found lying in a pool of blood by Morris Kight and GAY COMMUNITY SERVICES CENTER Director Don Kilhefner at the Gaywill Funky Shoppe in Hollywood. Schaffer was the non-paid manager of the shop, which is operated by the GAY COMMUNITY SERVICES CENTER to raise money for Gay charitable purposes.

Morris Kight said he became alarmed when repeated phone calls to the Gaywill during business hours Monday failed to get answered. Kight called Kilhefner, and the two went to the shop, where they found Schaffer's body.

No clues as to the motive or identity of the murderer or murderers has been found. Schaffer was last seen alive Saturday, August 26, and died sometime between then and the time he was found dead Monday afternoon.

A coroner's inquest is being held to determine the time and exact cause of death. Two bullet wounds were observed by Kight and Kilhefner, so their is little doubt that he did not die from natural causes.

In addition to operating the Gaywill, Schaffer was employed as a news correspondant for the Liberation News Service, a news service for some 350 underground, campus and alternate newspapers. In addition to writing Southern California Gay news for LNS, Schaffer was a more or less regular

writer for GAY SUNSHINE of San Francisco, GAY of New York and the LOS ANGELES FREE PRESS.

Schaffer had been closely associated with Morris Kight for many years before the GAY LIBERATION FRONT was organized in 1969. For many years, Schaffer lived in Kight's downstairs apartment.

Schaffer was instrumental in organizing demonstrations and planning strategy for GAY LIB, and was active in organizing the first two Christopher Street West parades in Hollywood.

During 1971, he was the key figure in a landmark Gay welfare rights case, in which it was ruled that being a self-professed homosexual is not adequate grounds for denying public assistance. Later the same year, he ran the Liberation House, a home for homeless Gay youth in Hollywood.

One of Schaffer's ambitions was to get some of his writings published in book form. Ironically, an anthology containing some of his writings is being published in September. Another will come out in November.

Schaffer had a close every-day relationship with the persons who made up the inner sanctum of GAY LIBERATION, including a number of San Franciscans — Tony de Rosa, Angela Keys Douglas, Rev. Robt. Humphries, John Platania (Heavenly April), and Don Jackson.

The appointment of Don Collins came as a surprise to most observers of the Gay scene.

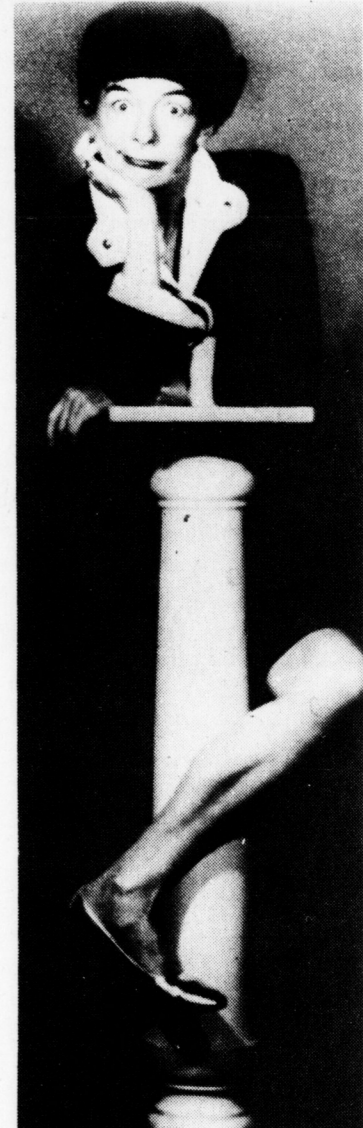

V.D. HOLDS ARE UNCONSTITUTIONAL ...B.J. BECKWITH

In a first, attorneys, clergy, news-men, police, and doctors met to change the current system of Venereal Disease Quarantine Holds, which according to S.I.R. Legal Committee Chairperson, B.J. Beckwith, the originator of the meeting, are unconstitutional, in that they deny the person the right to bail.

Attending the meeting called by Attorney Beckwith, were Dr. Brath, director of the Venereal Disease Control Program for the City and County of San Francisco (and Jim Ashe's supervisor), reporter Don Collins of the *Advocate*, Attorneys, Beckwith, Evander Smith and the person who did all of the research in the matter, assistant Legal Committee Chairperson, Jay Mayhall, and representing the S.F.P.D. was the head of the Police Legal Division, Sgt. David Roche. Reverend Ray Broshears was there as the chairperson of the S.I.R. Lay-Legal Committee and also from the Tenderloin Citizens Council. The meeting, held in the fifth floor office of Sgt. Roche at the Hall of

Justice, has proven to be a historic landmark event for the Gay community and for the City as well, in that an accord was reached concerning the discriminate manner in which the S.F.P.D. members have been applying the V.D. Quarantine hold.

Sections 3053 and 3195 of the California Health and Safety Code were referred to, as the laws which establish the V.D. holds, and also the City and County Health Code, Section 73. Beckwith pointed out that V.D. holds are all too often placed on persons discriminately by certain members of the S.F.P.D. as a form of "punishment", because they are homosexuals. This was quickly agreed to, by Evander Smith and Reverend Broshears. As Beckwith pointed out, V.D. holds are placed on persons who have been arrested for "masturbating at a urinal", and as he asked of Dr. Brath, "how can a person masturbate himself, catch V.D.?", to which the kindly doctor stated that it was impossible. Dr. Brath was critical of the system in which V.D. holds are applied by the S.F.P.D., and stated that the S.F.P.D. has "apparently abused this system." Sgt. Roche concurred that

there have been abuses by members of the S.F.P.D. in certain cases, and stated that new guidelines were needed in the matter. Dr. Brath then asked Beckwith to draw a new set of guidelines on the matter, remembering to include women in the matter, lest we be accused of being MCPs (male chauvinist pigs), to which Beckwith, and Appeal Attorney specialist, Mayhall, agreed this they would do, and submit it with the guidelines drawn up, spelling out specifically just who can and cannot be held for the V.D. quarantine.

The meeting, as most pleasant meeting, was, in the opinion of Beckwith, a most productive one, and, he stated, a far better way to settle things than just going to court for the sake of going to court. Beckwith stated that the new guidelines will be given to the B.A.R. as soon as they are ready, which will be on September 6th, and as soon as Dr. Brath signs the order, they will become the order of the day for officers when booking a person, male or female.

ADVOCATE reporter Collins stated that he was pleasantly surprised at the harmony exhibited in the meeting and that he felt that this was a major step for the struggle for individual rights.

GOD, JESUS AND DON JACKSON VS. AWAKE, JEHOVAH'S WITNESSES AND THE WATCHTOWER

The Watchtower Bible and Tract Society (Jehovah's Witnesses), publisher of AWAKE Magazine, issued a press release denying that they advocate the genocide of homosexuals.

Gary McLaughlin, a member of the Jehovah's Witnesses and spokesman for AWAKE issued the press release, which said in part: "All of the publications of the Jehovah's Witnesses indicate that it is wrong to practice homosexuality, based upon God's word as recorded in the Bible. Jehovah's Witnesses, however, do not advocate genocide of any group of people... We have no interest in the death of any homosexual other than at the hand of God."

The statement went on to say that Awake merely quoted passages from the Bible, "clearly showing that homosexuality is disgusting in God's sight and those who practice it are deserving of death."

"Let me stress that we do not now, nor have we ever... called for the genocide of any group of individuals, no matter how disgusting their conduct is in the sight of God."

The statement was prompted by an article in the BAY AREA REPORTER (Death for Homosexuals Vol. 2 No. 14, July 12, 1972). The B.A.R. article was picked up by the Underground Press Syndicate and its 450 member

newspapers and by the Earth News Service (200 radio stations).

The Rev. Robert Campbell, pastor of the Jehovah's Witness Kingdom Hall at 1414 Hyde Street was contacted by telephone for comment. Rev. Campbell said "It is not AWAKE who says homosexuals should be put to death, God says homosexuals should be put to death."

When asked when and where God says that homosexuality is disgusting or that homosexuals should be put to death, Rev. Campbell said "In the first Chapter of the Book of Romans and in the 18th Chapter of the Book of Leviticus.

A careful examination of the references discloses that neither of the references contains any mention of homosexuality, nor is God quoted in either reference. Romans is an opinion piece by an early church leader. Leviticus is a sectarian book of the Jewish penal law.

The Jehovah's Witnesses have blasphemously attributed statements to God which God simply did not make. God feels very strongly about such falsehoods - so strongly that the last thing he ever said warned against putting words in his mouth. In the 22nd Chapter of Revelations, the last chapter in the Bible, God says:

"This is my solemn warning to all who hear the prophecies in this book? if anyone adds anything to them God will add to him every plague mentioned in the book? if anyone cuts anything out of this Book, God will cut off his share

of the tree of life and of the Holy City."

It is AWAKE, McLaughlin, Rev. Campbell and the Jehovah's Witnesses who are disgusting in God's sight, and He says so. The above quote tells us what God has in store for these false prophets.

Let us examine the two references to see how AWAKE has distorted, added to and cut from the word of God.

Nowhere in the Bible is a single word to indicate that God disapproves of homosexuality. The subject is not mentioned anywhere in the Gospels, nor for that matter anywhere in the Bible. The word HOMOSEXUAL and the concept of homosexuality were invented by Dr. Magnus Hirshfield during the 1890's. Neither the word nor the concept of homosexuality were known in Biblical times.

The Book of Romans is a book reflecting the opinions of Paul of Tarsus, the author of the book. The first chapter mentions a number of vices that Paul felt are "deserving of death." The list includes greed, malice, depravity, heterosexual men leaving the natural use of women for the use of men, envy, treachery, spite, slander, rudeness, arrogance, boastfulness, disobedience to parents and a score of other vices.

The vast majority of mankind, including the vast majority of Jehovah's Witnesses are addicted to one or more of these many vices.

AWAKE has never said that

businessmen are "deserving of death" because of greed. It has never said that disobedient children or rude taxi drivers are "deserving of death". It did not even say that "men who leave the natural use of women" are "deserving of death." It said "homosexuals are deserving of death". Paul says not one word on the subject. It is simply a fabrication by AWAKE.

Romans was not written by God, but by St. Paul, a homosexual. And he was not talking about homosexuals — for homosexuals the use of women is not natural; the use of men is. Paul was condemning heterosexuals who turn from the natural use of women — natural to them, to try to pervert their natural heterosexual orientation. Nowhere in the Bible is there even a hint that homosexuality is unnatural, and in fact, evidence indicates that Paul believed that for a homosexual to attempt to change his God given sexual orientation was a sreat as a sin as vice-versa. Although Paul never condemned homosexuality, he condemned heterosexuality on numerous occasions

saying things like "It is good for a man not to touch a woman."

AWAKE's other favorite quote is from the 18th Chapter of Leviticus. It reads "For a man to sleep with mankind as with woman is an abomination, they shall be put to death."

God is not the author of Leviticus. It does not pretend to be about religion at all. It is merely the Jewish criminal law code. It provides criminal penalties for such things as eating pork, duck, shrimp and horse meat, and silly things like "If an oxen fall into a hole it shall be put to death." Then it provides things like a death penalty for contractors who build houses that fall in, an eye for an eye and a tooth for a tooth and other simplistic brutalities.

Jesus condemned Leviticus on numerous occasions. Once he repudiated Leviticus by saying: "It is written an eye for an eye and a tooth for a tooth, but I say unto you that whoever shall smite thee on thy right cheek, turn to him also the other. Leviticus says that a thief should be punished by amputation of the hand.

Jesus said "If a thief will take away thy cloak give him thy coat also."

Yet a third time Jesus chastized the quoters of Leviticus. As He was entering Jerusalem He encountered a woman who was about to be punished for adultery in accordance with Leviticus — "An adultress shall be taken outside the city wall and stoned to death." Jesus saved the woman from the Jehovah's Witnesses of his day by saying "He of you who is without sin cast the first stone." Later, during the third Century, St. Augustine forged in the phrase "go thy way and sin no more." Augustine, like the Jehovah's Witnesses had the nasty habit of attributing his own bigotry and hates to Jesus.

AWAKE never mentions any other verse in Leviticus. It has singled one verse out to quote because it feeds the hate, malice and other vices "deserving of death" of its editors and writers.

Ironically, the Levitic injunction against men sleeping with men was unknown to the ancient Jews. In fact, homosexuality was widespread, respectable and approved. Many of the Jewish kings had male lovers — such as David and Johnathan.

The Hebrew word for sodomite meant homosexual rape and human sacrifice connected with the worship of the Mother Goddess. Sodomites would parade through the streets seeking out handsome males to be raped and sacrificed (Genises 19).

King James, because of his hate of the homosexual Norman Kings of England, had the Bible translators translate the Hebrew word for sodomite incorrectly as "men who lie with mankind." The mistranslation was purposely made to show King James disapproval of homosexuality and the Norman Kings with which it was closely identified. Thus, a religious sanction against the brutal and savage rapes and sacrifices of the Mother Goddess was converted into a condemnation of homosexuality. The Jehovah's Witnesses are not the first ones, to misconstrue, forge and add onto the Bible to further their personal malice and bigotry.

Jesus also commands his followers to obey the laws. The Jehovah's Witnesses have violated not only God's command

not to add to the Bible, but the laws of the State of California, other states and the United States as well.

AWAKE's calls for putting homosexuals to death have inflamed readers and caused numerous acts of violence resulting in serious injuiries to persons and property.

Shortly after the first of AWAKE's incitements, AWAKE readers assaulted and beat Gays marching in the Christopher Street West Parade in Los Angeles last June 25. Since then, one Gay church has had its Sunday services three times interrupted by shit and piss-throwing, knife-wielding Jesus Freaks and AWAKE readers. One teenage boy suffered serious permanent injury and hospitalization as a result of a knife attack by a Jesus Freak. The boy was stabbed as he sat praying in church.

In San Francisco, AWAKE readers have been so crazed and incited to violence by AWAKE that they have run through the streets of the city with clubs, beating the patrons of Gay bars and persons on the streets who appear to be Gay. Reports of similar incidents are coming in from New York, Atlanta, Los Angeles and a score of other cities.

I call on the Jehovah's Witnesses to repent. I demand that AWAKE retract its untrue and blasphemous statement that "homosexuality is disgusting in God's sight." I demand that AWAKE cease and desist from publishing inflamatory statements that are likely to

incite further violence.

If my demands are not met, I will ask the New York Police Department to bring criminal charges against the staff of AWAKE. I will ask the U.S. Department of Justice to issue an order for the suppression of AWAKE under provisions of the Civil Rights act which prohibit the publication of inflamatory material which incites violence against minority groups. Lastly, I will file a complaint with the San Francisco Police Department, asking for the arrest of vendors selling AWAKE on charges of inciting violence.

The doctrine that fulfillment of sexual desires is sinful is un-Christian. Jesus never said a word about sex being sinful. In fact, he condemned antisexual guilt cults. The notion that sex is filthy or sinful came into the Christian religion during the 3rd Century due to the militation of worshippers of the anti-sex goddess of Babylon, who wanted Christianity to absorb their religion. Anti-sexualism is Babylon, the great harlot from which all disgusting things come.

There are 21 dead men who were close to me in life. All except one of them are dead, not because of disease, accident or old age, but were murdered by the anti-sex cult. Maddened by their own frustrated sexual desires, Jehovah's Witnesses and similar guilt wallowing cults have forced many of my friends to be oppressed, guilt ridden and

depressed to the point where they could take it no more and so took their own lives.

August 29, when I received the news release from the Earth News Service on the Jehovah's Witness Statement, I got a sinking feeling in my stomach, and a premonition that very soon an important figure in the Gay Movement would be assassinated by someone maddened by AWAKE'S poisonous incitation.

Ralph Schaffer was a beloved brother which whom I, and others, worked closely in creating the Gay Liberation Front. I spent hours with him every day. We worked closely together in writing stories and doctrine. Although his murderers may never be apprehended, in my heart I know he was murdered by the hate spread by AWAKE.

Now, Jim asked me why I wasn't more active in a certain Gay person's campaign for public office. Well, Jim, I was all set to work for his election, despite the fact that he was a lawyer. But,

when I questioned him, he expressed no knowledge of, nor even showed the slightest qualification for, the office he was seeking. I had to disbelieve his motivation for running for that office. While being homosexual should not be a deterrent to public office, being homosexual is not an all encompassing qualification for holding public office either."

Now Mr. Foster, what repeated attacks have I made on you? And what lies have I written about you?

Mr. Foster states in paragraph two "We have not consulted the law books to decide whether we have been libelled."

So, dear Jim Foster I have researched the law for you.

From *Summary of California Law* — Witkin, seventh edition; the recognized contemporary authority for guiding lawyers, we quote from the section on Torts: "(a) General Principles. 'Libel is a false and unprivileged publication by writing, printing, picture, effigy or other fixed representation to the eye, which exposes any person to hatred, contempt, ridicule, or obloquy, or which causes him to be shunned or avoided, or which has a tendency to injure him in his occupation.' (C.C. 45; cf. Rest., Torts §568(1).)"

"Mere expressions of opinion or severe criticism are not libelous if they clearly go only to the merits or demerits of a condition, cause or controversy which is under public scrutiny, even though they may adversely reflect upon the public activities or fitness for office of individuals who are intimately connected with the principal object of the attack. (95 C.A.2d 584.)"

"...hair-splitting analysis of language has no place in the law of defamation, dealing as it does with the impact of communications between ordinary human beings... (52 C.2d 550.)"

"...Truth of the statements made is a complete defense against civil liability for defamation, regardless of bad faith or malicious purpose. (Rest., Torts §582; Washer v. Bank of America (1948).)"

"Those whose lives are matters of public interest, and those who become involved in an incident of public interest, cannot complain of the normally expectable publicity which results. (See Rest., Torts §867)."

From my research it appears to me that you, Jim Foster, libelled me, but that I did not under any stretch of the imagination libel you.

So the questions arise: Why your attack? What is it that you wish to accomplish?

Foster continues with paragraph three, four and five on the Stokes campaign and raps it up with paragraph fourteen which we quote as follows "We give unstintingly of our time and money."

From the sworn affidavit of Earl Rick Stokes on his campaign contributions and expenses as filed with the Secretary of State of California, there is listed an expense of salary to Jim Foster of \$875.00 as a campaign manager. Also listed is a \$20.00 expense to "S.I.R. rental of headquarters." The place that S.I.R. sub-leased to the Rick Stokes campaign costs S.I.R. \$350.00 per month according to a phone conversation I had with George Coffman the S.I.R. office manager.

Well-well-well... I don't think any comment is needed here. But, Mr. Foster is an affront to those of us who

really have given unstintingly of their time and money.

On to paragraph six we quote; "Unity is a beautiful idea; everyone is in favor of it. Diverse opinions make it impossible to achieve. In our opinion, unity is less important than achieving civil rights for Gay people."

Now isn't that a beautiful statement? What in hell does it mean? I guess it means that unless we unify under the Banner of Jim Foster we aren't going to have unity and Jim Foster will make certain we don't. But your guess is as good as mine, so you write me as to what that paragraph means.

Paragraph seven; "The overwhelming defeat of Messrs. Thayer and Broshears' candidacies at the last membership meeting despite the active support of the nay-sayers, indicates that the positive thinking S.I.R. members realize which of their leaders accomplish things for Gay Rights."

Come on, Jim, that is an out right misrepresentation of the facts.

I am quoting from Kevin Macree's letter to the "Insider" on that one.

"Item: "The S.I.R. Constitution reads in part that 'all members shall be notified by mail of the time and date of each election,' but the President allowed the 50 members present at the last meeting to vote down this provision and hold elections for VECTOR and Community Center Chairmen, even though no notice was mailed. The President backed up his position on the advice of one of our past Legal Committee Chairmen who said, 'Go ahead and do it, it would take a Court Order to change the election.' So 50 members, with the concurrence of the President have scrapped part of our Constitution. Doesn't anyone care?"

So in effect we had a secretive election that shut creative persons out of S.I.R.

Paragraphs eight, nine and ten contain meaningless rhetoric that any member of S.I.R. can refute, but really re-read paragraph eleven.

"In a few weeks, we hope to have a brochure of legal motions and arguments that will make it easier, and cheaper, for lawyers to better defend

our arrested brothers. Soon, we also hope to begin the most professional attack possible on the constitutionality of existing laws. Through the Whitman-Radclyffe Foundation, we are trying to fund this project with donations that are tax deductible. We estimate that it will cost about \$15,000."

That's a real funny one! The most professional attack possible on the Constitutionality of existing laws is a Brandeis Brief. That's upwards of \$50,000.00 to pursue. But legal motions and arguments are available in law summaries, and specific legal research on nearly any case he speaks of can be accomplished for less than \$200.00 from outstanding research lawyers.

So what is Foster talking about? Just who is the Whitman-Radclyffe Foundation?

This foundation is not registered at the California Secretary of State's office because I checked.

This foundation is not registered at the San Francisco County Clerk's office because I checked.

Where is it registered Mr. Foster?

Who are the employees of this

foundation?

What is the Federal Income Tax number of this foundation?

It is at this point that I find the ground around the Foster-bird is sticky with guano. I have no stomach for the many questionable activities of Mr. Foster.

If someone cares to personally approach me I shall be happy to supply them with the affidavits and xeroxed copies of information on Jim Foster that I have received.

The question to Mr. Foster is; Why are you concerned about my personal responsibility when you haven't the slightest concern over your own responsibility.

What bothers me tremendously is that persons like Mr. Foster have read out or drummed out of S.I.R. many creative, worthwhile and responsible Gay persons.

My concerns are, as I believe the concerns of nearly all homosexuals are, to gain equal legal, political, and social status for all homosexuals.

I along with most homosexuals in San Francisco have worked too long and hard; have given to much in time and money; to allow petty ego trips or sick thievery trips or back-biting bitchery to stop us now.

If you can't measure up Jim Foster, and it appears that you can NOT measure up, then step aside before the growing parade of homosexuals on their way to achieve their human rights runs you over.

VICE SQUAD ENTRAPMENT PLAN GOES HAYWIRE, PUBLIC SEES ALL

On Thursday morning, 1 AM, August 17th, Toby and his friend Lefty were leaving the apartment of a friend on Geary Street, when a young dude-like character approaches Toby and inquires as to bars and wants to know "where the action is". Toby stated that he did not know, and Lefty told the "dude" to leave Toby alone, whereupon the "dude" says some hostile words and reaches back, as if reaching for a gun or a knife and Lefty proceeded to swing at the Dude, whereupon, two other "dudes" came out of nowhere, and proceeded to grab Lefty, only then identifying themselves as policemen. After handcuffing him, they, according to witnesses and Lefty himself, threw Lefty to the ground, hitting him and kicked him in the face several times, as well as other "parts," demanding to know what apartment they had come from, and where had Toby ran to when he ran back into the building. Witnesses stated that they were shocked by what took place and stated that they were ready and willing to go into court on behalf of Toby and Lefty. Toby was taken in on a charge of "female impersonation" (even though he was in all-male attire), and "solicitation", (even though the policeman, unidentified, according to witnesses stopped Toby and spoke to him first). Toby was released in Court that morning, but Lefty was not released until he was O.R.ed by Rev. Ray Broshears near five that afternoon. The charges against Lefty are "Battery on a police officer" and "resisting arrest", (he neither knew the man was a cop, nor the other two when he tried to get away from them).

Telephone calls to the building on Geary by men identifying themselves as SFPD Special Services (Vice Cops) Officers, have threatened the manager, telling him not to let those characters visit in the building again or we'll declare your apartments a "red-light" house and shut you down. And in addition telling the manager to throw out another person, whom they "suspect" to be drag-queen, or else they would shut him down if he didn't.

Both Lefty and Reverend Ray stated that this case would be fought all the

way, that they had to do so, as a matter of principle, to let the Vice-cops know that such high-handed tactics will not be tolerated in the Tenderloin any longer.

On Thursday, a well know Tenderloinite, Sugar, was picked up for merely leaning against a car, and charged with "trespassing", for as the cops stated, the car didn't belong to Sugar. This violated Sugar's probation, so he was sent back to prison. A true police-gestapo action. Beat-officers complain that "pressure is being put on us by the big businessmen, such as Swig and Lurie and the Downtown Association. If we don't bust you, we'll be docked pay"

I feel it necessary to correct a statement made in a B.A.R. article by Don Jackson. We all realize that controversial material creates interest and response, but the statement that

"transvestitism is incurable" is not only inaccurate but damageable to those who might otherwise seek assistance if they feel anxious or depressed about this behavior. I and others have assisted successfully a number of men, homosexual and heterosexual, who wished to discontinue transvestitism as a mode of expression.

Transvestitism is a symptom often associated with repressed expression of homosexuality. Heterosexually oriented males are particularly anxious about expressing their homosexual feelings but even overt homosexual behavior does not always mean acceptance of homosexuality. This anxiety can be expressed unconsciously in transvestitism. Some individuals, by learning to relate more directly and gratifyingly with persons of the same sex, find transvestite cross-dressing no longer necessary.

Congratulations to Chuck Thayer for his incisive and provocative article regarding the Shed (B.A.R. 23 Aug. 72); though I don't concur completely with his "line of attack" I endorse his ultimate conclusions, and would add that this establishment affords little credit to the gay community. From personal experience I can relate of a myriad of incidents which raise a credibility gap as between what the Shed says and what it does. (As a point in fact your readers might be interested in the attached letter which was excerpted in the *San Francisco Examiner* of Monday 28, Aug. 72.) Quite frankly the sooner this enterprise is abated the better will be the relations between the police, the straight residents, and the gay community in the Castro Market Area.

Also, Don Cavallo's account of the travails of Toad Hall are most worthy of amplification. He is absolutely correct in stating that the Eureka Valley Merchants Association is the *bete noir* in this continuing battle for recognition of responsible oriented gay rights. However, as I noted in an earlier edition of B.A.R., not all of the 51 members of this amalgamation of merchants (and 51 out of more than 200 businesses in the District is hardly a representative majority)

are as parochial or narrow minded as is their "up-tight" Directorate or their acting President and long-tenured secretary. As a service to our Community, I shall furnish, upon request, the names and addresses of those whom we should selectively boycott, as well as those whom we should support. (Most who know me, and know of my community activities, will recognize the fact that I am in a position to pin-point both our friends and our enemies.)

Through various conversations with both gays and straights I have found that this struggle transcends ideological and political differences. We must not allow a handful of ignorant bigots (and that is really what they are) to destroy what so many of us have worked too long to create; i.e., an atmosphere of mutual respect and co-operation which has been breaking down the barriers of blind - and in many instances religious inspired - prejudices.

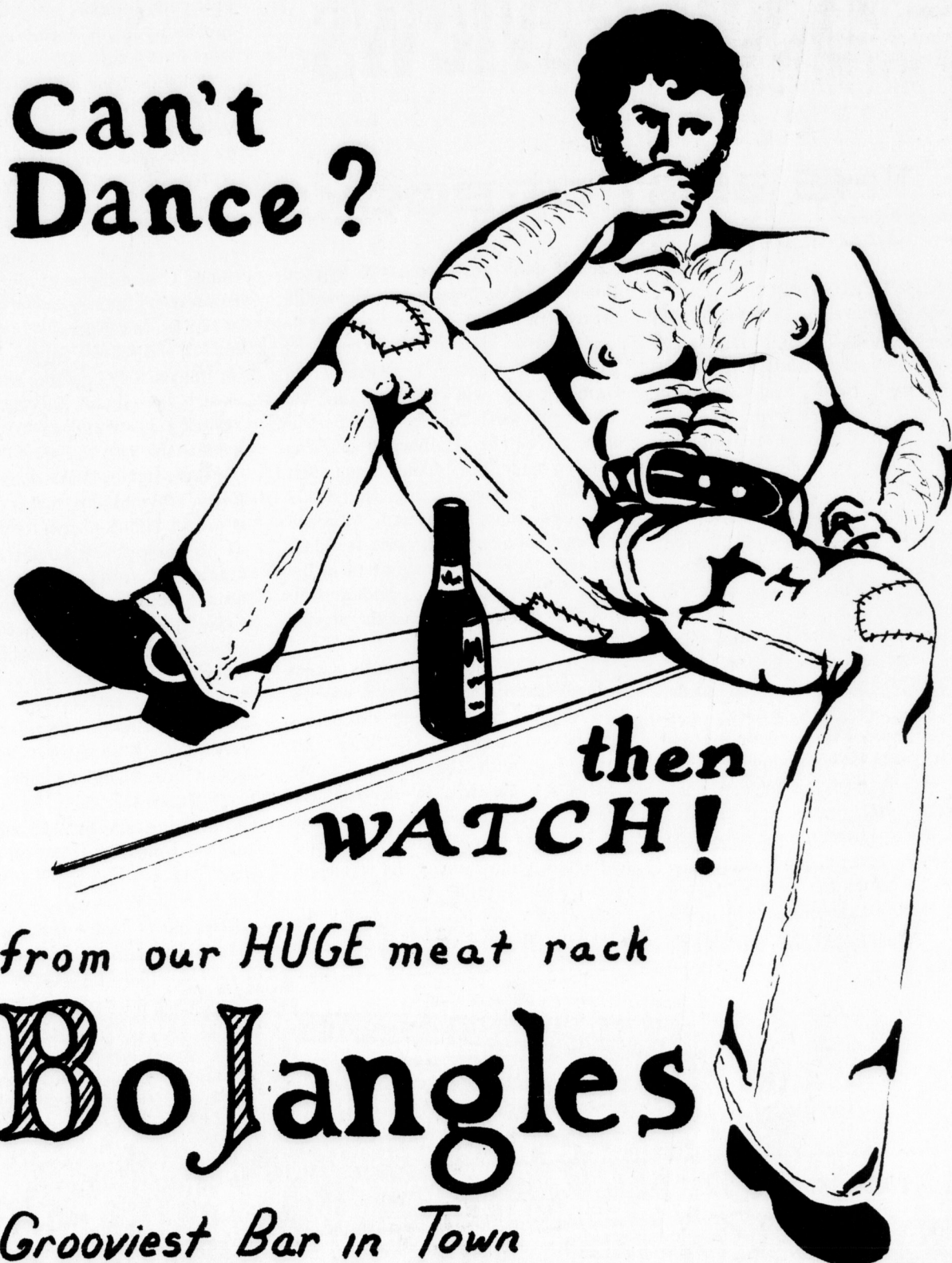

Book Reviews

THE BEST OF BOOKS

THE QUIET CRUSADER

John Hallowell is the author of "Bodies Beautiful." His novel has just been released as a Bantam paperback original. Andy Warhol read it, gave it its title, and is even now trying to obtain the financial backing of a major studio to make this gripping story Warhol's first Hollywood Epic. "Bodies" is the story of Casey, masculine and attractive, who arrives in Hollywood straight from Vietnam, very determined to make it big and to use hustling as a means of getting there.

Hallowell's first book was "The Truth Game," a collection of short reportage on the Hollywood scene, mostly interviews with the famous of the movie world. His interviews were far from the usual Hollywood gush, for he got to the depth of his subjects, they liked each other, mostly, and he has a flair for the dramatic. Most of his subjects, he became good and lasting friends. So much so that when he wanted to do a story on the Hollywood streets, Natalie Wood cautioned him:

"Please don't go down to Hollywood Boulevard. You'll get hurt. And you'll get recognized."

If you missed his story of Hollywood hustlers in "The Truth Game," you will soon see in the full-length novel "Bodies" that he was well into the Hollywood hustling underworld. For while doing that original reportage, a big Hollywood name was found murdered. Although this case shook-up the movie world, it was only an overnight sensation in the press, very underplayed, and quickly dropped. But from it came the present novel.

Recently John Hallowell passed through San Francisco on his way to Los Angeles. He had been visiting his family on Cape Cod. Since this coincided with the publication of "Bodies," he was in demand for interviews. As a former interviewer, now the author of a book about Hollywood and about homosexuality, he was much in demand for interviews, spoke his mind, talked about himself and his book, his future projects, and richly

enjoyed himself into the kind of tiredness you get when you do a week's work in two days.

"Bodies Beautiful" is the story of Casey, unwilling to return from Vietnam to his home in Maine, and very determined to make it big in Hollywood. He is big, beautiful, masculine. All he has to do is meet people, hustle them, score with them, ever pushing on to bigger and better things. One of the ways to make it big is to make big money. Very aware of his attributes, he places a high price on himself and delivers the goods.

Immediately he scores with a famous ex-star Jay Stuart. Jay Stuart is still attractive, presentable, and quite comfortably off. His sport is picking up one-night-stands. But when he meets Casey, Jay Stuart shakes his whole world by falling in love. He wants Casey all to himself. He cannot approve of Casey the hustler, so Casey must be broken by being pushed into the world Casey thinks he wants to follow. In a moment of perverse masochism, Jay introduces Casey to Howie-the-Pimp. Howie is the ace purveyor of flesh to the richest and the greatest. He runs a very discrete service as everybody's bosom friend and Mother. Rings on every finger, very camp, but street-wise, Mother runs a very tight shop. Howie sees the commodity in fine shape and willing takes Casey on as a favor to his old friend and customer Jay Stuart.

Having let Casey that far out, Jay then starts to try to deliver other

introductions to people who will help Casey but mostly want to help themselves to Casey if it does not crush their carefully put together world. Jay still has some power to bring the great to meet his new-found friend. He introduces Casey to famous Hollywood couples, the male members of which couples were once on very intimate terms with Jay Stuart and thus began their careers. He introduces Casey to Laura Tyler who years ago had co-starred in a movie with Jay that won both of them Oscars. Casey meets directors, agents, columnists and stars. And Casey himself falls in love with Maggie Beauchamp.

Jay makes promises and delivers. He makes requests, and Casey delivers. He gives gifts, and Casey enjoys, goes on living his life according to his own dictates, but gathers some useful advice along the way. The name game can now be in full swing, and it's anybody's guess as to who is really who. But the name game is a side issue. The story as the plot thickens gets more and more interesting and suspenseful. It ought to make a fine movie.

The plan, still in the talking stage, to make "Bodies" into a Warhol-Hollywood movie, is highly imaginative. James Mason could really do justice to the character of Jay Stuart. For Warhol wants real movie greats. He would like Rita Hayworth for the part of Laura Tyler. Jackie Bisset is just right for the part of Maggie Beauchamp. An unknown, of course, will play Casey.

Rita Hayworth as Laura Tyler is not a pipe dream. She has been a friend of the author since he interviewed her, and it was he who introduced Andy Warhol to her. This was no simple undertaking. Both Warhol and Rita Hayworth are very shy people. Warhol covers up his shyness by travelling with an entourage from behind which he can observe. His group was very much in awe of the great star. It took some doing to get the two off in a corner by themselves and away from the group. There they talked for several hours and are good friends today. For the part of Laura Tyler, for Andy Warhol, and maybe even for the author, Rita Hayworth might just come forward into the limelight once again.


In Hallowell's opinion, Arthur Blake would be just great as Mother Howie. Although the character of Howie was

not originally modelled on Blake, Blake is almost type-cast. He is the owner and impressario of a Gay showplace in Provincetown, the Crown and Anchor. This is one of the few gay places Hallowell enjoys. Blake runs a fine place. He always has a good show going, and tourists and locals, everybody mixes and mingles. There is not the atmosphere of a Gay bar, or Gay slumming. People go there to enjoy the show, and manage to do so without


dumping on each other. Blake is both star and impressario. Rings on every finger, just as rings are worn by Howie, Blake provides a setting which is both Gay and camp.

In a book such as "Bodies," it ought to follow that the author is something of a crusader. The subject, the environment, and the story lend themselves to social comment. But, just

as you will not find "Bodies" a dirty book or, really, a Gay novel, you will not find any pointed moralizing. He is simply telling a very good story about very real people, pointing up their situations of anguish which is very real to them. Hallowell's real literary mentor is Dickens, and he reads and rereads Dickens. And he does the same thing Dickens did. He tells the story of the times, presents us with warm characters and woeful situations. The main thing is the reality, the warmth, the feeling and the humor. The crusade is hidden, and, as with the Dickens era, the problems will correct as the feelings of the thinking reader are aroused. The crusade is then left entirely up to the reader.

Books about homosexuality are usually very Gay, or psychological tracts, or dirty — that is to say, titillating. They seldom approach literature. The instance of this is quite rare, Hallowell brought out, and he cited as examples only Christopher Isherwood's "The Single Man" and "Meeting at the River."

Right now, besides returning to Los Angeles and watching and waiting for developments in the film world for "Bodies," Hallowell is working on a new book. Tentatively it is to be called "Love in the Bins." The research for this book is all in the past, since the author has been in the bins. He went on what he calls a death trip. His road to self-destruction culminated when he himself called the police. He turned himself in to do three months in a California State Mental Hospital.

On this subject Hallowell is very emphatic. Mental hospitals exist as jails and orphanages. Inmates are not patients but almost criminals, definitely to be guarded from society. Hospital budgets are so cut to the quick that

medical facilities are the barest minimum. Of course the staff is quite large, but it consists of bureaucratic personnel to administrate, with clerical assistance, and guards for the patient-prisoners.

Of course there is cruelty. Such a situation can only produce all sorts of cruelties. And such treatment as there is available is usually the rashest and cruelest. Shock therapy is no picnic. Hallowell went through it, and that is why his sympathies are entirely with Senator Eagleton. Dumping the Senator has set us back fifty or more years. To have done so was the most unconsidered judgement of the century.

Hallowell's feelings on Gay-lib are also pretty emphatic. Of course he is for it. But that does not say the whole story. How this liberation is to be achieved is more to the point. He does not believe it is going to be settled in Gay bars. He does not believe it is going to be settled by outlandish behavior, by waving banners, by roudyism or public displays of the more outrageous sort. After all, there really is no place where a person of any persuasion cannot go if he wants to go. Or she. The answer lies entirely in behavior. Anyone can go into any bar in California and find Gay people present, accepted and having a good time. By flaunting homosexuality, the Gay person sets himself apart, and there is no reason why anyone who really wants to remain apart should get himself accepted.

"Bodies" is about Hollywood and hustling. It is not about Gay life as it is lived in Gay bars because these two scenes do not really meet. Only Gay people who want other Gay people go to Gay bars. The hustler lives off people who are Gay and prefer men who do not prefer other men. The orientation

of the hustler has to be predominantly and dominantly masculine, such as Casey. This presents an entirely different psychology. To Casey it was merely his job or profession, and, almost like going to a routine nine to five job, it was entirely divorced from the rest of his life. He could compartmentalize this. But anyone can see how close to the edge this segmentation can lead. Anyone leading this life leads a hair-trigger existence. At any moment the balance can tip toward drastic and unlooked for results.

John Hallowell is young, dynamic, and personable. Whether he knows it or not, he does have a message and a purpose. His cause is humanitarianism. His deep consideration is given to how people behave toward each other. Everywhere he looks, he sees the inconsistencies of social behavior. He sees the recording company executive, a man who might lead a serious and up-tightly conservative life, daily pushing the drug culture in every record his company produces. He sees people constantly dumping on each other. In all walks of life. And he sees all the sins of the world, that is, of people against other people, revolving around the all-time ogre: Money. As long as the money comes pouring in, and it really ought to pour, there is nothing that people will not do to increase the flow.

It really is very low-key to try to make people see these things by telling stories, one would think. But you have only to read the dramatic story of Casey in "Bodies Beautiful" to feel the immense impact of a very large part of the world around us.

VICE SQUAD RAID POLITICAL FUND RAISER by Don Jackson

Twenty-two persons, mostly key people in the campaign to elect a pro-Gay district attorney were arrested at a fund raising event at the BLACK PIPE in Los Angeles, August 20.

The event, called "The Summer Festival" was sponsored by HELP, INC. to raise money for a community center.

HELP President Larry Townsend reports how it happened: "Just as we were winding up the festival, a dozen uniformed officers... burst into the front patio, stating: 'Stand against the wall. There is going to be a mass arrest.'"

First to be arrested was Duane Miller, owner of the BLACK PIPE. Then Townsend. In all, 22 people were arrested, 21 of whom, including Townsend and Miller were charged with Lewd Conduct. They were, Townsend says "chained like animals and herded into a van that was made to accommodate only 10 to 12 people."

The LOS ANGELES FREE PRESS notes that the raid was not just an ordinary raid on a Gay bar — it was a raid on a political meeting. It is believed to be the largest Gay vice raid in 15 years.

Townsend insists that people weren't even relaxed enough to be talking freely, much less to be having the orgy implied by the police action.

"The reasons for these arrests are obvious", Townsend said, "A couple of fag-hating Vice cops simply took it upon themselves to attempt to stop us from opening our Center... They were also attempting to prevent our registering voters, and during the otherwise 'random' selection of victims several officers were heard to ask: 'Where's the guy who was sitting at that (voter registrar) table?'"

Morris Kight said that the raid was obviously an attempt to create dissention and to damage Bugliosi's campaign for district attorney.

Townsend, Kight, Miller and other witnesses all confirm that those arrested at "random" were mostly key people in the Bugliosi election campaign.

Among many L.A. Gay Activists the belief is firm that the incident marks the beginning of a campaign to suppress the political activities of the Gay Movement.

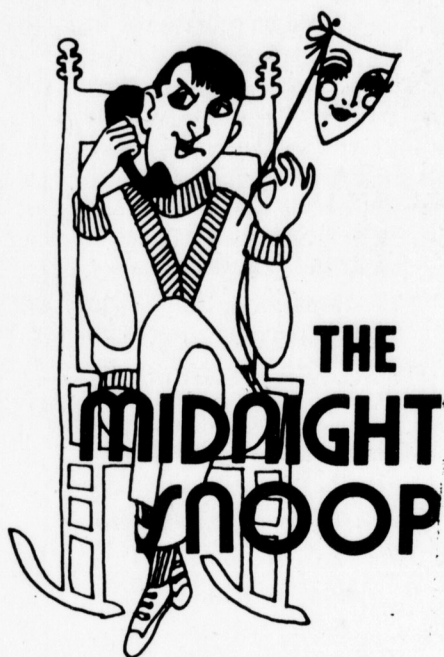

ICE FOLLIES OF '73

Being an incurable romantic, whom nobody will convince Tinkerbell is not alive and well and living in Argentina, I hid myself off one sunny afternoon to see Shipstad's & Johnson ICE FOLLIES of '73. Oh, my dear, whatever happened to the days of Donna Atwood and Donn Arden direction?! Whatever happened to splash and glamour and originality?! The first-act finale costumes are just downright tatty, the choreography the usual run-of-the-mill pinwheels and circles with "precision skating" (that

means 32 Ice Folliettes kicking in a line at approximately the same time), and as for originality... Well, if someone can explain to me what the campy gorilla number was all about, that had no ending, we'll discuss it.

The two big headliners that get top billing are Trixie Schuba, an Olympic champion, and Snoopy, who's not. Snoopy does what I assume is supposed to be a poignant vignette with a lovely lady with whom he's smitten, and a wistful Snoopy is a woeful bomb. Miss Schuba appears once in the second act and performs all the correct requirements for an Olympic champion with the animation and theatricality of a Barbie doll.

All is not dismal, however. There is a gorgeous black-and-white production

number called "Sounds and Motion," and some fine individual performances. Mr. Frick, that master showman, performs his comedy routine with ease and style that actually garnered "Barvos" at performance caught ("Bravos!" at an ice show?), Karen Kresge has spark and excitement to her skating, David Comb does a solo with his skates on fire jumping barrels that's kicky, and Ricky Inglesi has got to be the hottest hting on ice. Mr. Inglesi is a dynamo on skates, generating that thing called charisma that makes you keep checking your program to see when he comes back next. He's a sexy devil, too! As for Richard Dwyer, the backbone of the ICE FOLLIES, I've enjoyed his routine for the past ten years and it looks as if I'm destined to enjoy it for another ten.

The big flaw in this year's show is the basic theme, The Sounds of the '70's (actually, it's more like '60's). I don't go to ice shows to hear Beatles medleys and watch go-go skating. The theme is so limiting that the production numbers all begin to sound and look the same (I swear I heard "Eleanor Rigby" at least three times!). Come on, producers, let's go back to the fun days of glamour and spectacle and forget about trying to be "with it" and "modern." It's a bore.

One last note: those 32 girls that comprise the Ice Folliettes are really beautiful women, even close-up. And that's nice.

THE SAN FRANCISCO TROUPE REVIEW

This is a new group just starting out, and therefore should merit your attention and indulgence. While much of their material doesn't work, their ideas and highly original concepts bode much promise. I saw them at the ORPHEUM CIRCUS for a one-night-only stint. The cast of four opened with "Comedy Tonight," with Sam Jones changing from boy to camp drag onstage, and that pretty much sets the tone right there. They wear the cheapest wardrobe possible ("Paris Original" done in four matching black slips), switch from drag to boy constantly, have no bridge music so the show moves like a bat out of hell, no down dramatic ballads, and the general aim is one of high camp. Carol Andre's "Brass Band" is the best single number in the show, Sam Jones has a marvelous mobile face for comedy, and their tapes are beautifully made. On the negative side, I object to seeing a boy, as a boy, mime a female voice for no apparent reason, Fannie Flagg doesn't work with two people and an invisible third one (either mime all the other people or have all three onstage), why is the dance solo and "I Get Embarrassed" not camped when everything else is, and in production numbers, instead of people just wandering in and standing, why not try staging each one, either in unison with the others (as you did in "Comedy Tonight") or setting each one in an individual style different from the others? Definite staging of each number would give the whole show a crispness it currently lacks.

There are many clever and original ideas in the TROUPE REVIEW show, but it's only a beginning. Now is needed the hard work of polishing and refining these ideas until every number is cleanly and smartly executed. At the moment, the ideas are better than the execution. But it's a good beginning for a young group, and God knows our city could use some fresh faces and talent! Keep plugging, kids!!

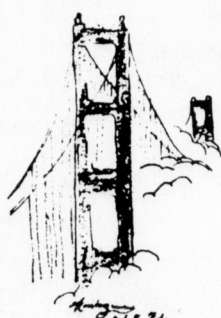

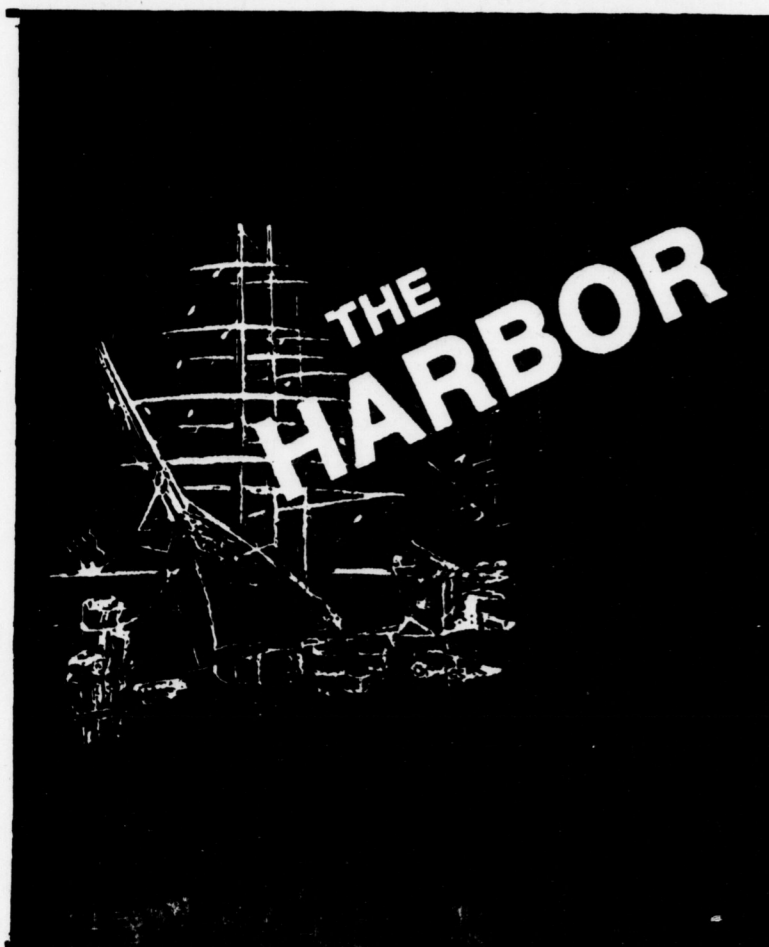

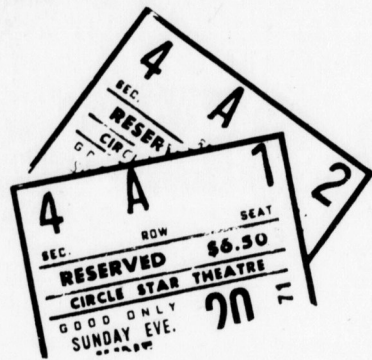

Show Reviews



Re-al-i-ty: *n. the quality or state of being real 2. something real 3. The totality of real things and events.*

NORMAN, IS THAT YOU?, which opened a Tuesday ago at the On Broadway Theater, is an unassuming middle-class Jewish play about an unfaithful wife who runs off to Montreal for a new adventure with her husband's brother. When said husband finds out, he travels from Cleveland to New York to find solace and understanding from his son, but on arriving, he finds his son is a Homosexual and is living with another man, a Catholic yet. Now we have the premise for our play, but wait, there's a new twist. It isn't middle-class Jewish, etc., the cast is Negro and the boy's lover is white and, unfortunately, that's where the trouble begins.

Sam Bobrick and Ron Clark's **NORMAN**, on its first time around in New York, didn't do well at all, even with Lou Jacobi and Maureen Stapleton as Mama and Poppa and George Abbott at the helm, it lasted only a dozen or so performances. So, now Nick Stewart

adapted their play to an all-black cast and have other productions scheduled for overseas. But why didn't he adapt the dialogue for their new cast? There were too many inconsistencies during the two acts and five scenes. True, the theatre contains illusion and fantasy, but also today it includes reality, and not once during the play was the fact mentioned that Norman's lover is white. Not one word did we hear from Daddy, who is quite alert, has been in the dry cleaning business for over twenty years (but couldn't press the pants or suit by Act III or even have a change of clothes, although he brought a huge suitcase in Act I), but was quick to note the lover was Catholic. To be sure, there were several healthy laughs in the show, but between times, things did not jell and often the pauses were deathly.

The actors themselves were hard pressed to make the most out of the material. Morris Erby, as the father, had the strongest part but was not aggressive enough in what he had to say. And, please, the pillow, Mr. Erby.

The mother, interpreted by a capable Juanita Moore, was much to sweet and not at all like a wife that had just stepped out on her husband, but

then again, she was better than the material she had to cope with.

Carl Mikal Franklin, as Norman, their window display son, showed little or no emotion in dealing with his father or lover, and could have been left out of the play altogether and just as well could be referred to for all he has to do.

As the white lover, Richard McCready as Garson was a little too flighty in the beginning, but soon settled down and gave a good reading of a ridiculous role.

Sheila Wills, as the gum-chewing prostitute bought for both boys, is fetching and coy in a small role. But the gum-chewing was a little much for an East Side hooker.

Direction, by James Wheaton, was uneven and at times cluttered. Why have Poppa place a chair on the side of the doorknob instead of under it to keep Garson from attacking him in the middle of the night? The doorknob is visible to all. The set and lighting was stable and unobtrusive.

Neil Simon writes a play a year and over the years has gained a reputation for writing plays of this sort, but Mr. Simon is a realist and constantly has his finger on the pulse of the people and times he is writing about. Mr. Stewart's adaptation avoids reality and gives you fantasy sprinkled with truth. If **NORMAN** is played in foreign countries, they must think that Negroes in America reside on the Grand Concourse or Ocean Ave. in Brooklyn. Does Ben Chambers (the father) want lox and cream cheese or a roast beef sandwich? Reality, gentlemen, reality is what the audience wants and so do Norman and Garson!

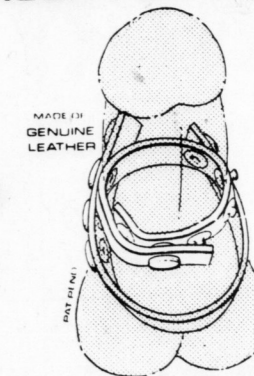

The treasurer of the YONKERS PRODUCTION COMPANY, Kevin Macree, a former president of SIR, has told GNS that the September VECTOR's attack upon the YONKERS PRODUCTION COMPANY may result in the loss of the money the Company was going to donate to SIR from the upcoming "Hello, Dolly!" production, which opens at the VILLAGE on September 8th.

The writer of the articles, a former Gay Lib member known then as David Noel Hinojosa, but known to VECTOR readers as Noel Hernandez, spent a great deal of time in making issue of the fact that the YONKERS PRODUCTION COMPANY had been formed separate from SIR. But, the Chairperson of that company, Perry George, took exception to that by saying, "VECTOR, Hernandez, and SIR, didn't say one word about the CITY PLAYERS going off and leaving SIR early last year and putting on the show, "Wonderful Town," and now "Light Up The SKY," which by the way is a good show, and soon to put on "Mame". I don't understand all this flap, in light of, the fact that, we of the YONKERS PRODUCTION COMPANY voted to give SIR \$500 and 10% of the revenue from the September run at the Village,

and the CITY PLAYERS never offered them anything to my knowledge. But neither their group or ours is obligated to give them anything. I am quite shocked at this attack by VECTOR, but, after second thought, after all the trouble we had at the VILLAGE last spring with the VECTOR editor, who made such a scene that I had to physically throw him out of the theater, I guess I shouldn't be too surprised." "But", continued Perry Goerge, "SIR has always best been known for slapping in the face those who have done the most for it. The Hernandez article is so full of half truths and untruths that I really can't answer it, but, the fact is, that the Dolly show made SIR, free and clear, at least SEVEN THOUSAND DOLLARS, and MORE, not the paltry \$4,000 as stated by Hernandez. And it is a shame that people can't find anything better to do than "slam" a fine group of people who are working to put on an even greater "Hello, Dolly!", that will, at least for the moment, stand to bring in sorely needed monies to SIR. And as a Board Member, I can say this, that every single penny is needed by SIR."

So, two fine women will be on stage for the Gay community this fall, "Hello, Dolly!" and "Mame." "Let's support our independent theater productions, and ignore VECTOR wallings," said George.

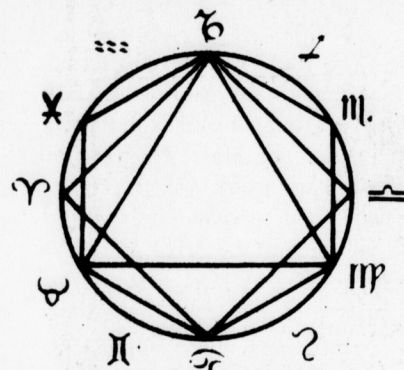

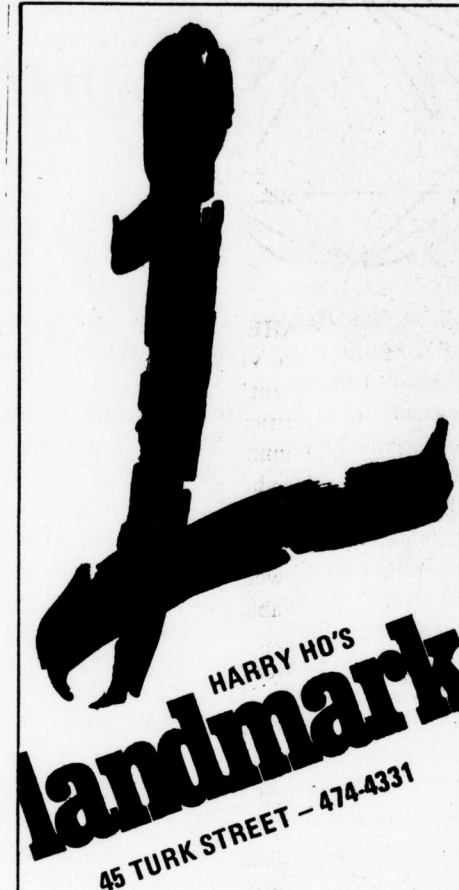

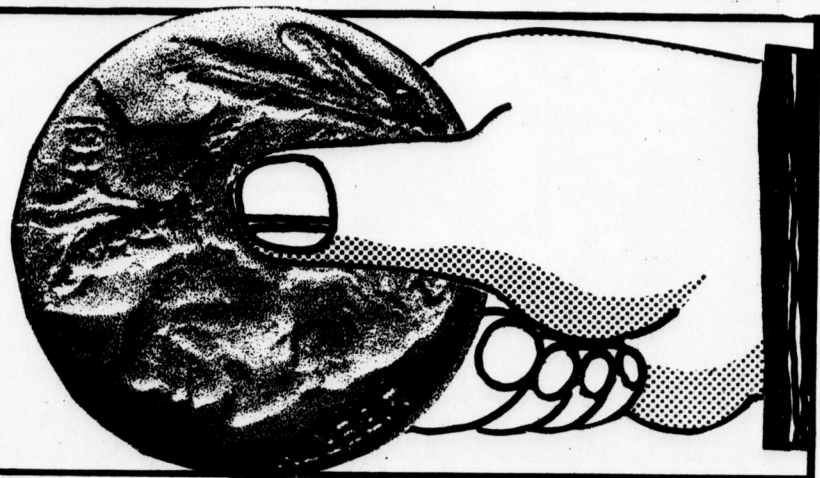

One of the big film dissappointments in my book so far this season is the upcoming, "Pope Joan" which I found to be a silly, boring film which tries to do too much too soon and ends up with too little too late.

This is the filmic version of the medieval legend of a female pope who passes for a rather effeminate man who meets her doom when she is forced to disclose her pregnancy during her papal procession - thereby giving away the fact that under those religious robes, he was a she.

The main thing wrong with the picture is that the writer, John Briley, tried to draw a modern-day parallel with lotsa flashbacks to the medieval legend. It proves to be a boring device. In the modern-day world, we have Liv Ullman as an evangelist who thinks she is the reincarnation of the legendary papal miss and her life is presented herein as a counterpoint to the events detailed in the ancient tale. We never learn too much about the modern day Liv as she is usually just a jumping off point for the questions of her noble but confused doctor (Keir Dullea) which trigger off the numerous flashbacks.

Miss Ullman tries very hard to pull it off, but nature and the dubious dialogue is against her all the way. Hopefully, her upcoming stints in "Lost Horizon" and "Forty Carats" will better showcase her

considerable talents.

Among the men in P.J.'s life are Pope Leo IV (Trevor Howard); an artist-monk (Maxmilian Schell) who takes her to Greece as a male so that she may be fully educated; and then there is Louis, grandson of Charlemagne, played by the hunky Franco Nero, who ultimately gets Joan pregnant which is the beginning of her downfall - religiously speaking. Olivia De Havilland has a cameo role as a mother superior of a nunnery and it's nice to see her on the screen again.

The film goes on for days (132 min) and if you miss a scene in modern dress, you get an instant replay in the medieval setting. Personally, I would have liked to see just one at a time - if I had to have a choice. It's skeddod to open soon (if not this week) in the Bay Area.

NOW PLAYING AT YOUR LOCAL:

BLUEBEARD-Richard Burton romps and slays thru this mini-epic which never seems to make up its mind to play it for gore or camp. Raquel Welch is a delight in her brief stint and Virni Lisi sings her way thru her very brief role before being cut-off in mid-tune. 

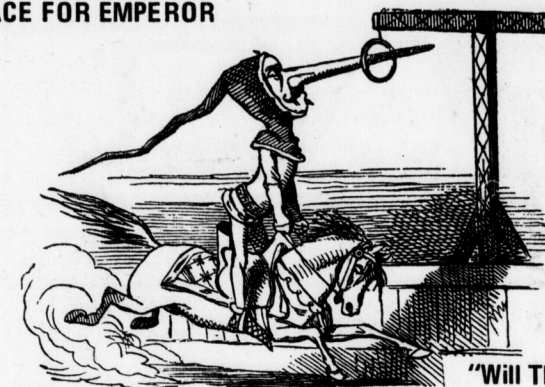

SEX LAWS FALL!

CALIFORNIA SEX LAWS FALL

The California oral copulation laws were ruled unconstitutional Sept. 12.

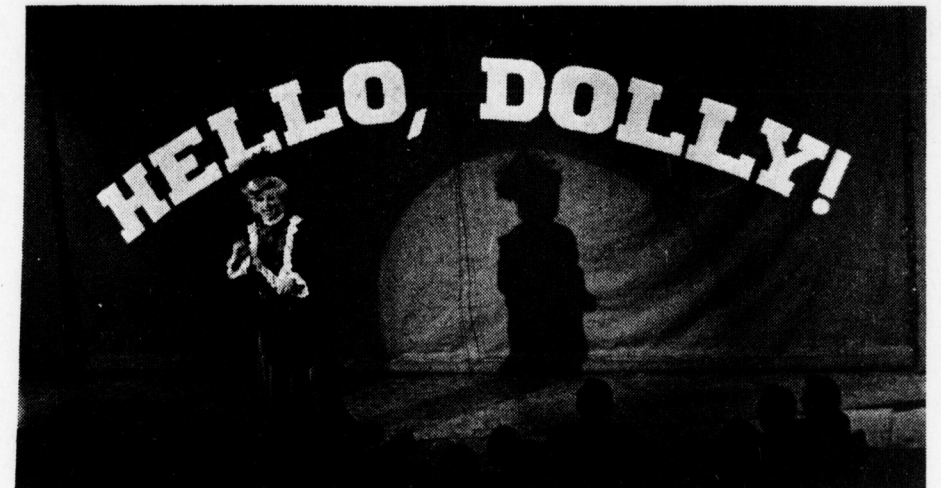
A decision issued by Los Angeles County Superior Court Judge George M. Dell declares in part: "The issue directly presented is whether or not a state can constitutionally make unlawful the consensual act of oral copulation between adults. The court concludes it cannot."

The jurisdiction of Judge Dell's court is the State of California, and the decision is binding on all law enforcement agencies in California.

And the ruling may be far more reaching than anyone realizes. Morris Kight consulted a constitutional attorney who said that all of the anti-homosexual laws may be unconstitutional. After all, it cannot be illegal to ask someone to do something that's not illegal, Kight said of the solicitation law (Sec. 647A, California Penal Code.) The same arguments can be applied to the sodomy and lewd and lascivious conduct statutes. They too, are almost surely unconstitutional.

The reason the constitutionality of California's sex laws has not been challenged before is because 97% of the victims of vice arrests plead guilty. It's enough to convince a rational person that homosexuals aren't very bright. Often as not, they plead guilty on bad legal advice given by "Gay" attorneys who have a vested interest in maintaining the sex laws. These unscrupulous lawyers advise defendants to plead guilty, often after making a "deal" with the D.A. to have the defendant plead guilty, to a lesser charge. — usually 647A (soliciting for immoral purposes).

Gay Movement lawyers say that any lawyer who advises a victim to plead

guilty to any charge is giving bad advice. Sucking cocks is not illegal. Asking someone to suck their cock cannot very well be illegal either. If you are advised to plead guilty, you would be well advised to find another lawyer.

A non-profit foundation has been set up as a law project to defend anyone charged with consensual sex offenses. If you get arrested on a sex charge, call the law project lawyers direct at 431-3980 or 548-8090.

Unfortunately, the decision is not final. It can be appealed.

What it does mean is the case can be used as precedent in any future consensual sex cases. Other Superior Court Judges are not legally bound by the precedent; however, it is very uncommon for judges to ignore a superior court constitutionality ruling. If a superior court judge should rule that the consensual sex laws are constitutional, the case would go to the appeals court. An appeal can also be filed by the prosecuting attorney.

Probably the constitutionality of the consensual sex laws will not finally be determined until a decision is made by the Supreme Court.
