

# THE POLITICAL MELODRAMA

The San Francisco Gay community has been in the throes of trying to commit suicide for the last three years. It looks as if this year we shall see whether or not our community can succeed at suicide or shall be murdered first. Rumored from the big moneyed boys of "Gotham City." is the fantastic boast that they shall control the Gay scene in San Francsico, lock, stock, and barrel, by Labor Day.

Many persons have whispered about the inroads into the San Francisco Gay community of four organizations: one based in Chicago, one based in Atlanta, and two based in Miami. Well, move over boys, someone, somewhere downtown has invited in the big time from the big city and has assured them of the needed cooperation to protect their investment.

We will only hint at the mistake that these metal moths of the night are making; it lies somewhere in that never-never-land between good taste and a small town mentality.

Speaking of miscalculations, none could be funnier than what is developing politically in San Francisco. I have been working with Citizens for Representative Government on the eleven District Plan for Electing Supervisors in our Gay city. The experience has been a shocker.

First, I want to assure all readers that the petition is well on its way to sufficiency with over 34,000 signatures already in and counted. 20,000 more signatures are needed according to the Registrar of voters to achieve the newly declared 15% of the last Gubernatorial election which will allow for mistakes and duplications. Nearly 4,000 are being turned in each week. There does not appear any way possible for our local



politicians to keep our initiative off the November ballot this time.

Roger Boas, supporting this drive, has said that the time has come for this method of electing Supervisors in San Francisco. We are, after all, the only county in California which does not elect its Supervisors by Neighborhood districts. With a little more work by CRG, it looks as if San Francisco's politicans must face the fact that there will be neighborhood district Supervisors elected in November of 1975.

That means at least two of these Supervisors could very easily be known Gay persons of political ability.

But, until that time, let's enjoy the inconsistencies of the strange political bed fellows.



**Mental Health Report** 

The San Francisco Mental Health Advisory Board has adopted the report of its subcommittee on homosexual activity and the law.

The subcommittee chairperson, Mr. Rosenblat, read the report to the MHAB at their April tenth meeting and urged not only its adoption but vigorous disemination to media and legislators.

The board adopted the report and his resolution unanimously.

Some stereotypes were shattered by the evidence gathered into this report over the last years. Of the five hundred and five valid charges of rape in the year of 1972, "Those classified as homosexuals: none", indicating that homosexuals do not engage in rape.

Of the one hundred and seven offenses of child molestation, "classified as homosexual: none".

In addition to these figures, the committee has access to the mental health literature on the subject and cited, "one careful study (Oregon) which showed over ninety five percent (of child molestation offenses) to be Heterosexual contacts, mostly within

the family unit (especially stepfathers, uncles,)," Thus is it made virtually clear that molestation of children is a heteroseuxal problem, not a homosexual one.

They found that of two thirds of the arrests for soliciting a lewd and lascivious act "were by plain clothesmen

(Vice Squad)" "a basic principle of law is that of prohibiting a person from deceitfully or directly using, or enticing another to commit a crime. If done by a police officer, who then arrests the very person he/she has enticed, it is called Entrapment.

"When a police officer declares in court that a person has solicited him/her for prohibited sex and the other denies it, it is the case of 'one person's word against another," If Police officers automatically are believed to be the truth-tellers, the power of unchecked abuse (especially entrapment) could be great."

In addition they noted that there were "no arrests for petting, (or) heterosexual request (solicitation).".

The report concludes with some recommendations.

Since modern scientific findings (anthropology. medicine, Kinsey, Masters, et al) have thoroughly demolished the 1870's definitions of "natural" sex, and since it is patently obvious that millions of "normal" people practice the so-called "unnatural" acts hundreds of millions of times; and since constant violationsof a law on such a massive scale breeds a contempt for it and for law in general; and since the only function of these laws has been a threat and/or an open invitation to blackmail; "they all add nothing to the public safety or welfare" (S.C.J. Robert Conyers).

Pending appeal of laws defining "unnaturalness", we recommend that the law enforcing agencies NOT attempt to vigoriously enforce these "laws," except where the sexual activity is a TRUE public nuisance.

Under section 290 of the statutes, any one convicted of any offense under 267, 268, 285, 286, 288, 288a, 314.1,2 and 647 (a) (d) must THEREAFTER register (in prescribed fashion) as a "sex offender." This is a gross LIFETIME

"Duke Smith moved to adopt in princple the Society's participation in the Gay Day Parade and the fair afterwards. Further that an authorized representative be sent to the preparatory meetings of the parade committee with instructions to report to and await Board action before taking any action. Motion passed unanimously."

Some of the points that were raised in the discussion of the question were that the concensus of the Board would like to participate in the parade, but it was feared that a repetition would occur of the unfortunate incidents that marred the parade's image last year; i.e., the unwarrented abuse hurled at the participants and observers by one of the organizers, and the widely publicized charges of misuse of the parade funds.

The Trustees were hopeful that there would not be a reoccurence of last year's events, but voted to move cuatiously in order to avoid their committing the Society's membership to participating in an event that would prove to be embarrassing and damaging to the Gay community.

It is our hope that this year's parade will prove to be a credit to the community that will show our solidarity.

There are 400 Gay brothers here sending their deepest thanks for your help.





# COMMUNITY NEWS

MA BELL TREMBLES AT GAY OFFENSIVE

Pacific Telephone Company, better known as "Ma Bell" is fairly well trembling at the concentrated 52 week offensive being launched against the employment discriminatory policies of Pacific Telephone, bay various groups, organizations, collectives and individuals within the Gay communities of San Francisco.

Pacific Telephone received notice of the impending 52 week offesnive at the PUC (Public Utilities Commission) hearing that was held at the State Building on Thrusday, April 12th, in which six memebers of various groups testified that Pacifi c Telephone should not be granted a rate increase due to their discriminatory hiring practices which cost PT&T greatly, and that they could save that money if they would end their discrimination in hiring against Gaypeoples.

First to testify at this 10 AM Public Hearing, was George Mendenhall, member of SIR and the PRIDE Foundation, who explained that Gaypeoples who were already working for Ma Bell wer forced to lead double lives, due to Pacific Telephone's concern over their bedroom life. He stated that he as a homosexual who is curretnly unemployed, could not be hired at PT&T due to the fact that he is a homosexual. This was echoed by Dick Gayer, representing the GAY STUDENTS UNION of Hastings Law School. Gayer stressed for the need of PT&T to drop the hiring policies which exclude Gaypeoples as have Bell of New York and General Telpephone of Long Beach-Orange county. Then he was followed by Roland Schembari of the FAGGOTS & FEMINISTS Caucus of the GAY ALLIANCE/SF, who vowed that "a bunch of faggots would be coming down to the Folsom Street phone company offices, doing their thing to upset them and their employees for 52 weeks, an entire year." He stressed that the demonstrations would be quite legal, but irritating.

Then spoke Barbara Harwood of the COUNCIL ON RELIGION AND THE HOMOSEXUAL (CRH) who really laid into the PT&T officials, letting them

know that they will be foreced to end hiring discirmination. She was followed by the Reverend Ray Broshears, GAY ALLIANCE/SF, who told of the atrocities being committed by Pacific Telephone Company today, against the poor, the disabled and the elderly, straight and Gay. He related the horrors of which the old and disabled must suffer, and how they are dependent upon their phones and how one elderly woman who could no longer afford to pay a phone bill and was disabled, had her phone removed, was trapped in her hotel during a fire and burned to death. Broshears said that had she still had a phone she might have been able to phone out for help to let someone know that she was trapped. Reverend Broshears scored Pacific Telephone for asking such a ludicrious rate increase of 32% for residences and 50% for businesses, syaing that Pacific Telephone wants a rate increase while the population of San Francisco has gone down and the service has gone downhill to the point of absurdity.

He warned Pacific Telephone that their hiring discrimination is costing them money and paying former Chief of Police, Thomas Cahill \$50,000 a year to witch-hunt Gays as head of Ma Bell's security system, is just one example of extravagant kspending.

Larry Littlejohn the last of the six speakers told of the various points of discrimination, stating that Pacific Telpephoen could save money, as well as raising the morale of the Gays curretnly working there and being forced to lead double lives, and helping improve the efficiency of Pacific Telephone Company, thus saving money and eliminating the need for a rate increase.

The actions of the six Gaypersons have received national press and gives strength to the 52 week offensive against employment discrimination by PT&T, which is being launched officially on April 20th at 11:30 AM with a massive ZAP at the 666 Folsom Street offices of PT&T. During the ZAP, a young Gayperson, carrying a telephone pole-like cross, will carry that pole on his back from the HELPING HANDS COMMUNITY CENTER

beginning at 10:30 AM and walking a route that passes by the SIR Center and then by the Chronicle and Examiner and down fifth street to Folsom and over to the main offices at 666 Folsom Street and should arrive their by 11:30 AM for the rally and ZAP, at which Larry Littlejohn, Barbara Harwood, and Frank Fitch are the tenative speakers. The Gay-youth caryring the pole-cross will be crucified to the cross in front of the Pacific Telephone offices after the rally. All are urged to come and join in, bring along some bells to ring, tambourines to bang on, and some toy telephones.

### **GAYS & WOUNDED KNEE**

The San Francisco Bay Area Ad-Hoc Committee for Gay Solidarity with the Independent Oglala Nation, has been circulating petitions in support of the struggle of the American Indians in the past week. The Ad-Hoc SF Committee is headed up by Rick Hansen a member of the SAN FRANCISCANS and Aubrey Bailey, a member of S.I.R.

The petition reads as follows; "We, the undersigned members of the Gay Community, an oppressed people, seeiking our liberation, do hereby affirm and declare out solidarity with and support of the American Indian Movement (AIM) and the Independent Oglala Nation (Wounded Knee, South Dakota) at this time of their liberation struggle. The struggle of your people for

freedom and self-determination is also the struggle of our people, and we stand united with you at this time. For the life, power, peace, joy, and freedom of all the people!"

they are on record as opposing any such facility anywhere, stressing that the local jails would have ample room to house the peoples arrested if the police would cease and desist from their drive on non-victim crime arrests, particularly those having to do with Gaypeoples (288a, 286, 647a, 647b, 314, 647d, 647e).

The chairperson of the GAY ALLIANCE, the Reverend Ray Broshears, has announced his resignation from the executive board governing the GAY FREEDOM DAY PARADE COMMITTEE, stating that due to a heavy work load with the ALLIANCE, and other committments, that he can no longer hassle with arch-conservatives on the Committee.

Reverend Broshears stated that the committee's treasurer desires to set policy in areas which he feels that treasurer has no control over. He denounces the reactionary right-wing tactics of both the treasurer, William Edward Beardemphl and H.L. Perry, the parade marshall. Reverend Broshear's resignation followed that of parade chairperson, attorney B.J. Beckwith who resigned due to personal reason. Broshears and the radicals who remain active in support and partcipation of the 1973 Parade wish to emphasize that they will take whatever action they feel is necessary to preserve the rights of the radicals and poor Gays to participate in the Parade unhampered by the conersyative reactionary rules that Beardemphl and H.L. Perry desire to create.

The summer issue of GAY PRIDE QUARTERLY, the official publicaiton of the GAY ALLIANCE will be released

on May 15th so as to not conflict with the GAY PARADE '73 booklet for the GAY FREEDOM DAY activities, which is due for release in June.

The GAY ALLIANCE which is one of the major tenants of the HELPING HANDS GAY COMMUNITY CENTER at 225 Turk Street, have received with considerable regret, the resignation of famed attorney, B.J. Beckwith as legal counsel for the Center. The staff of the Center and the membership of the ALLIANCE whishes Mr. Beckwith the very best, and thanks him for the tremendous service that he has rendere; both the ALLIANCE and the HELPING HANDS GAY COMMUNTIY CENTER.

### HISTORIC MEETING

Attending also was a reporter from the ADVOCATE, and the D.O.B. (DAUGHTERS OF BILITIS).

And what was even more surprising was the fact that the maverick militant Gay minister, Reverend Ray Broshears hosted the meeting and did not blow up once at persons many consider his mortal foes. Broshears told BAR that, "In the matter of Gay rights, I am more than willing to cooperate with anyone to bring about the elimination of discrimination against my Gay sisters and brothers, but I will not compromise my political and philosophical positions to do so, and at this meeting, it was not necessary for we all agreed that the enemy, Pacific Telephone, must be

forced to come into the 20th century. One tense moment did arise when SIR president Frank Fitch made a mention to the recent BAR Article concerning the Bell Tell ZAP, but it quickly passed.

It was agreed that all the groups present would co-ordinate efforts to try and force Pacific Telephone to change their anti-Gay hiring policies. Dates for future meetings were set, and Barbara Hower and Reverend Bill Johnson of CRH were elected by the group to coordinate information, etc.

The meeting was chaired by Larry

Littlejohn, and was attended by Dick Gayer of SIR; Reverend England of MCC; Barbara Hower of CRH; Winston Leyland of GAY SUNSHINE Newspaper Collective; Dennis Krusynski and Mitchell of EMMASU HOUS E; Frank Fitch, president of SIR and Don Sccott, vice-president of SIR; David Snider and Roger Ryan of the Gay Effeminist Caucus of the GAY ALLIANCE; Reverend Ray Broshears, chairperson of the GAY ALLIANCE; George Mendenhall of the ADVOCATE; Millicent Staten of CRH & DOB. This could be the beginning of something really big is the general opinion of all persons who are involved, and all those present were to go back to their respective groups to seek endorsement of the effort against Pacific Telephone. # EMMAUS GAY SWITCHBOARD INAUGURATES HOUSECLEANING SERVICES

In a move to help underwrite the costs of operating their Gay switchboard and community center, EMMAUS HOUSE is now offering domestic housecleaning services. Operating under the name of PEOPLES CLEANING SERVICES, they are providing housecleaning, yard and garden work, and painting to both private homes and small businesses. At people's price.

The coordinator of the domestic services project, F.E. Mitchell, has three years of experience operating a registered commer cial domestic services agency, and has been invovled with EMMAUS HOUSE for over a year. "Although I'm no longer a private entrepeneur in this field," Mitchell reports, "I am actively involved with the

switchboard, and feel I can put my expertise to use in helping the switchboard find a way to survive financially." He further points out that the Gay community's patronage of this new undertaking will serve two purposes: that of providing jobs for Gay people and also that of helping keep a Gay Community service alive.

Bernardo Espi, Personnel Manager of the cleaning service, points out how the service will aid the switchboard. "This service is operated by several switchboard volunteers like myself who also do domestic housecleaning for survivial. Several people in this field have agreed to donate one-third of their receipts to the switchboard. In other words, when you have a person from EMMAUS HOUSE come into your house to do cleaning, 2/3 of the charge goes to the person doing the work and 1/3 will go to support the switchboard."

The EMMAUS HOUSE Gay Switchboard and community center is now in its third year of operation. It has never been funded by any agency nor does it have "financial angels" who underwirte its costs. "We've always survived solely on donations, and most of those donations actually come from people working on the switchboard who somehow manage to dig into their pockets when the bills come due," according to EMMAUS director Dennis Kruszynski. "We know it's an increasingly tight economy, and that it's getting harder and harder for Gay groups to get the donations they require to survive, just as it's getting harder and harder for Gay people to be able to give those donations. So this domestic services project is our attempt to become self-supporting without having to constantly hassle people for donations."

Although the PEOPLES CLEANING SERVICE is housed in the same building as the EMMAUS GAY SWITCHBOARD, it occupies its own office, and has its own telephone and its own staff. People wanting further information on service s or prices should contact:

## Sex Laws Fall

1973 Cameron Scot

In a decision that will have far reaching impact on individual — and specifically Gay — rights, the Superior Court of the District of Columbia has handed down a formidable tool for use in cases involving citizen vs. government. The opinion, issued by J. Halleck; reported in 12 Criminal Law Reporter No. 25 (March 28, 1973) is one of the most amazing, incredible and hopeful decisions yet rendered FOR Gays in a court in this country.

Cited as US v. Doe; D.C. Super. Ct., 2/21/73, Judge Halleck dismissed sodomy charges against two men who were caught in "apparently a public rest room" — and proceeded to reduce District of Columbia Code Section 22-3502 to rubble on so many points that the District of Columbia must still be reeling over the decision. And they're probably bewildered at the extent of Judge Halleck's attack on the statute.

The Court's opening blow stated that the statute was unconstitutional because it was overbroad "...because all persons who engage in acts of sodomy are subject to prosecution... including husband and wife, consenting adults of opposite sex, or consenting adults of the same sex, regardless of whether the act is committed in public or private." In other words, sodomy WAS punishable, period. This line of reasoning is followed through later in the opinion as the Court asserts the individual's right to privace, free from governmental intrusion, EVEN IN SEXUAL MATTERS.

Further, the Court offered the opinion that the "discriminatory application... against homosexuals may present a selective enforcement problem

TRUCKS AND MEN TO SERVE YOUR NEEDS, LARGE OR SMALL of constitutional dimensions..." Someone up there has finally recognized the discriminatory actions of police and prosecutors in enforcing such laws, USING MOST OF THEM, MOST OF THE TIME only against Gays and now suggests that such discrimination is unconstitutional, and in violation of several civil rights acts guaranteeing freedom from discrimination.

The most incredible aspect of this decision is the force and many fronts on which the D.C. statute is attacked. The Court goes on to state that the statute is in violation of "the right to privacy guaranteed and protected by the First, Third, Fourth, Fifth and Ninth Amendments..." And, noting that the right to privacy includes the right of control and function over our own bodies, Judge Halleck quotes from an earlier decision that "If the right to privacy means anything, it is the right of the individual, married or single, to be free from unwarranted governmental intrusion..." Halleluja - we may be freed yet! And the Court points out that government of length and style of hair has been denied and it would be ironic to conclude that the government had the right to interfere with a matter so personal as sex, after being denied the right to govern the length and style

More! Citing the Kinsey report, the Court continued to attack the statute, stating that sodomy cannot be distasteful to the "vast majority" (apparently an argument used by the prosecutor) since such high percentages of men and women have engaged in some sort of Gay experience in their lives. Now, all those closet cases are no longer going to be protected from themselves by such proscriptive laws, since the Court sees no reason why they should be offended by such behavior, since most of them have engaged in it, even to the point of orgasm.

The Honorable Judge Halleck, quoting from yet another case, states that the government may interfere with one's privacy only when there is conduct that harms others — and he doesn't put homosexuality in that category.

The next attack on the legality of that statute is so amazing, and so

obvious, as to be worth quoting almost verbatim:

"In Western civilization, the repressive treatment of sodomy as a crime is a direct legacy of the Judeo-Crhistian view of sodomy as a sin.\*\*\*

"Christianity, of course, began as a Jewish faction, and the sexual asceticism reflected in the Mosaic Code was absorbed by the early Church. As the political power of the Christian Church grew after the Council of Nicea in 325, the Church could proscribe what it had formerly preached against.\*\*\*

"It was this view of sodomy as an offense against God which obtained at the time Christianity passed into England in the sixth century. The religious nature of the offense was clearly recognized in England during the Middle Ages. Sodomy was not a crime according to the early common law, and jurisdiction over the offense was left to the ecclesiastical courts.\*\*\*

"The present D.C. Code Sec. 22-3502 is a direct descendant of this religious heritage. ...The religious character of the offense is clearly revealed by the first reported decision construing the 1793 [Maryland] statute...

"The mere recitation of this history suggests that the govern mental interest served by this statute is not only far from compelling, but may well be violative of the First Amendment to the Constitution. That amendment commands that Congress shall make "no law respecting an establishment of religion". The establishment clause ...means at least this: Neither a state nor the federal government can set up a church. Neither can pass laws which aid one religion, aid all religions, or prefer one religion over another....."

"The teaching of these cases is that when the government enforces a religious injunction by use of the police power, it is passing laws which 'aid one religion' or 'aid all religions' unless some harm to the secular interests of society coincides with the evil the religious prohibition condemns.\*\*\*

"[T] he enforcement of Judeo-Crhistian notions of sexual morality, absent a clear secular justification, is not a 'compelling' governmental interest sufficient to override the fundamental right of individuals to privacy in sexual matters.

"Although the Government has asserted no other state interest in placing statutory restrictions upon the sexual acts proscribed by D.C. Code Sec. 22-3502, other possibilities have appeared in a variety of writings.\*\*\*

"One such rationale is that there is a connection between homosexuality and violent crime. This claim is altogether unsupported by any evidence.\*\*\*

"Another equally erroneous justification for the criminal proscription of homosexuality is the belief that such persons are involved in recruituing, seducing, and molesting children. But the problems of homosexuality, and pedophilia are not necessarily related. The Wolfenden Report at Para. 57, points out that "a man who has homosexual relations with an adult partner seldom turns to boys, and vice versa\*\*\*'. '\*\*\*Moreover, the state's legitimate interest in the protection of minors will not be compromised by a holding that consensual sodomy among adults is beyond the constitutuional reach of the criminal law. Child-molesters will continue to be liable to criminal sanctions.

Are we finally going to get the separation of church and state guaranteed by the Constitution? It looks that way, and the next time that \*\*\* in Sacramento thumps his Bible and screams about a California Sodom and Gomorrah to defeat the consensual sex act bill, maybe we can get him impeached for violation of guarantees afforded by the Constitution that he is sworn to uphold.

As if that weren't enough, in yet another amazing portion of the opinion, the Court notes that sexual conduct between man and wife in public in the "missionary position" is AT MOST a misdemeanor while any other form of sexual activity would be a felony, and raises the question of why one forms of sexual activity should be more "criminal" than another. Holding that the right to privacy extends beyond government prying in our homes, the decision incorporate s the views that (1) sexual acts committed by consenting adults in a public area where they might reasonably expect to be undisturbed by the general public, and might reasonably not expect to disturb the general peace, are also protected by the individual's right to privacy, and that (2) if such acts

should be committed in full public view that they be handled as disorderly conducts rather than sodomy, and that (3) the penalty "for violation of Sec. 22-3502 by consenting adults" (10 years imprisonment) raises severe questions of constitutionality under the 'cruel and unusual punishment' clause of the Eighth Amendment. And there is even mention of violations of the Fourteenth Amendment, too.

The opinion is concluded with a statement that, by whittling away the unconstitutional portions of the statute, the case at bar has no merit because the only thing left to the statute is forcible sodomy (rape, even if you are married) and child molesting (which carries its own penalties, but also carries penalties under this statute).

Case dismissed!!


Thus, Judge Halleck's decision, coupled with other recent decisions on the rights to privacy and freedom from government intrusion, provides attorneys with a formidable weapon for fighting Gay prosecution cases. Several courts are recognizing that the State has no 'compelling' interest in intruding itself into homosexuals' lives in the absence of public harm which the State will be hard pressed to prove and which they undoubtedly aren't going to be able to surmount. WE'VE known all along that we weren't harmful to the State - and now some intelligent courts are beginning to back us up.

It would be all but inconceivable that this decision won't be appealed, with the 'state' - D.C. - claiming the right to govern public morality as a 'compelling interest', but that particular statute, and similar ones in other states. has been so thoroughly attacked by this decision as to render it, and others like them, useless - except in specific HARMFUL instances - as they rightfully should be. In an appeal, the 'state' now has the burden of proving that control of homosexuality between consenting adults is legitimately and constitutionally within its purview, and that it has a compelling interest in such control.

Alternatively, the 'state' will act to pass further laws to circumvent this decision — an equally questionable task since the Superior Court decision seems to anticipate every other law that might be passed and raises the serious questions of constituionality of any law.

at all proscribing consenual sexual conduct. Decisions in cases such as this become doubly important to individual rights in light of Mr. Nixon's stated belief that 'law' is the province of the legislature and not of the judiciary; overlooking, or more correctly, IGNORING the stated functions of Congress (to enact laws) and the judiciary (to interpret those laws AND DETERMINE THEIR LEGALITY IN CONFORMITY WITH THE CONSTITUTION, BILL OF RIGHTS, AND AMENDMENTS). But then, Mr. Nixon ignores just about every other fundamental guarantee of this country. Mr. Nixon, et. al., in cutting off legal aid funds for "class action" and "te st cases" hope to avoid having the judicial branch of our government exercise its proper function in interpreting legislation, preferring to leave our fate in the hands of the rich lobbyists who greatly influence the legislature. Who ever heard of an effective Gay lobby for Gay rights? Or a lobby for those too poor to fight prosecution to get the law changed in their favor? So far, in this country, it has had to be up to the Courts to decide the legality of such issues, and our current administration doesn't like the way it is going.

It is more than ironic that at a time when such decisions are being handed down by Superior Courts that we in San Francisco — long noted for its tolerance of not only Gays but many diverse groups — should be subject to the hassles we are now experiencing. And, unless, you want to be the California test cases, I wouldn't recommend running wild in light of this Court decision. Although it has a number of tremendously important and standing cases behind it, it's final test hasn't yet



been made. But it is one of the most enormous steps forward that we've had and, affirmed or denied, should prove to have great impact in individual rights cases, and prove of great benefit to attorneys in fighting invasion of privacy, consenting sex betwen adults and abridgement of civil rights in general.

We all owe Judge Halleck a "thank you" in support of his opinion. I, for one, intend to see that he gets it! A card addressed to him, c/o Superior Court of the District of Columbia, Washington D.C., surely could not take long to write and post and can only help ALL OF US in our fight to keep government out of our lives.

Especially in view of the recent court determinations that Gay s were not being treated fairly, it makes me literally want to throw up to have to read Thomas Edwards, et. al's screaming at Gavs who are trying to equalize the Gay situation around the world. It makes me sick to know that we have those in our own community who, having somehow never gotten caught, nor been in danger of being caught, do not bleieve that it happens, when obviously several courts of this country DO believe it happens. Cases are reported every day, and Judge Halleck's decision quotes on at least three instances where such laws are used discriminatorily and where the penalties against Gays are far more severe than against straights. Yet we have to listen to the imbecilic ravings of such men, who point to themselves with pride at "having made their own way," and don't realize that fully 50% of it was luck at not being in the wrong place at the right time.

I, too, have made my own way, and have no beefs now — however, I HAVE been hassled for just walking down the

sidewalk, I HAVE been tailed by unmarked police cars to try to catch me cruising the streets, I HAVE been harrassed in Gay bars for nothing more than just coming in the door, and I CAN give dates, times, and details on each one of these hassles. Yet, in spite of that, I have done well enough, but am thankful that it hasn't blinded me to the fact that it DOES happen. And, I repeat that if Mr. Edwards, and Mr. Wing, can't help correct the inequities in our society against Gays, the very least they could do is shut up and not harangue Gays themselves. We have enough shit to deal with without having to deal with their's

### REPRESENTATIVE GOVERNMENT

CRG announced today that it had gathered the signatures of 35,000 San Francisco voters on its petition which calls for the election of Supervisors from 11 neighborhood districts. CRG thus has collected more than enough signatures to qualify its charter amendment for the ballot under the City Charter which requires 25,000 signatures.

Spokespersons for CRG indicated

however, that a recent change in State lawplaces their petition drive under state provisions of the Government code which now requires the signatures of 38,000 voters. This Code has been amended four times since 1970, with the most recent change taking effect on March 7th 1973. No one, including the Registrar of Voters and the City Attorney, knew of this fact until March 15th, 1973. The CRG spokespersons stated that although they had already satisfied the City Charter requirements that were in effect when the petition drive was started, they have been informed by the Registrar of Voters, Emmery Mihaly, would immediately declare an insufficiency of signatures and void the drive. It was anticipated that the new state requirement of 15% would be met by the first of May. They pointed out that CRG had grown from 100 to 700 active workers who gathered 35,000 signatures during the rainiest period in San Francisco's history.

CRG claims that the present "at large" election system, with its exorbitant campaign costs, has turned San Francisco into one large Chicago style ward. Supervisors seem to be responsive only to monied special interest groups, and are not

representative of San Francisco's diverse neighborhoods and are thus not well informed concerning neighborhood issues. CRG maintains that district elections will cut campaign costs drastically, and force representation and responsiveness. They point out that CRG organized by district allowing local citizens to run the campaign in their own districts, using personal contact campaign techniques. Thus, 35,000 signatures were gathered with a total expenditure of only \$800, a little less than 2.3 cents per signature.

CRG claims that the Board of Supervisors themselves are responsible for the strong citizen support for the 11 neighborhood district campaign. The last year has seen the Board further continue the decline of supervisorial responsibility, which critically threatened the historic principle of balance of power between the legislative and executive branches of local government in our city. The present Board has never overriden a mayorial veto, even though many of the measures vetoed originally passed with sufficient votes to override. This distressing trend towards one man rule in our city must and will be reversed by electing supervisors from neighborhood districts where they will have an independent political constituency.

Moreover, while the present Board weakly abrogates its responsibility to the citizens of San Francisco and knuckles under to special interest group pressure, it refuses to allow the citizens of San Francisco to decide the issue of neighborhood districts. Last August the Board of Supervisors Legislative and Peronnel Committee, after hearing testimony from over 200 San Franciscans, recommended that neighborhood district election be placed on the November ballot. After a week of backroom wheeling and dealing the Board voted 9 to 2 to keep the issue off the ballot and not to let San Franciscans decide for themselves how supervisors should be elected. The main reason for this vote was clearly expressed by Supervisor Francois who, during the debate on the matter, stated that CRG was "naive" to even ask such a thing because of the adverse effect district election would have on the personal political careers of those 10 supervisors who would have to run for only three district seats.

PROMENADE,


A VOCAL EXTRAVAGANZA

PROMENADE, currently at Trinity Methodist Church, is a pleasant satirical look at people and events of our time. The original revue played Off-Broadway about four years ago and to my knowledge the Promenade Company's production is the first in this area. It's a show that has something for everyone, especailly vocally.... It's an extravaganza!

The music by Al Carmines and the lyrics of Maria Irene Fornes have the flavor of Fellini's "8½", "Candide", "South Pacific" and Jac Brel all rolled into one splendid score. Unfortunately, the musical numbers (there are many) are not listed in the program and I'll have to be content to stab at titles. "Unrequited Love" (the opening ensemble number), "Isn't That Clear",

"Be Content" and "Ha, Ha", in my opinion, are the composers' best efforts. At this point the musical director, Ron Manuel, should be complimented for his vocal work with the ensemble and also the quality of sound from the eight piece orchestra.

The thin shred of story is centered around the escapades of two convicts, 105 (Wayne Smith) and 106 (Steven Rogino). Their Laurel and Hardy antics and personable performances give the revue it's lighter moments as they travel through fantasy land and experience the decadence of people, the tragedies of life and the horrible reality of war.

Other notable members of the cast include Miss Cake/Rosita Rodriquez (Neysa Null), who has a roller skate bit in the second act that's hilarious and Ms U (Joyce Lovett) who gives a show stopping performance with "I Gave My Heart To You." Also, featured as the mother looking for her lost babies (Elizabeth Lagorio) in a fine characterization, followed by Jim Coon as the Mayor. In lesser, but important roles, are Rick Slavsky as the Waiter and Richard Kelley as the Dishwasher They work well together, especially singing a song about "Hamburgers."

The director, Glenn Du Bose, has created a very intimate show in the limited confines of the combination gym-auditorium. His crisp staging and fast paced production never leaves the audience with a dull moment. He utilizes the functional set of ramps, stairs and platforms well and even managed to incorporate some of the gymanstic equipment into one production number.

Even with this writing I'm not totally sure what "Promenade" is all about and may be a second viewing would help to more fully understand. But, then again, maybe it's intended to be just the way it appears... a satirical hodgepodge and should be accepted as such. Hopefully this production will not go unnoticed by people uptown. I couldn't think of a better vehicle to replace "Godspell" at the Marines' Memorial. At least, if nothing else, it would be an improvement:


SERPENTS CELEBRATE FIFTH ANNIVERSARY



"I am an enigma I have always been an enigma, and I shall always be an enigma, "so states Helmut Berger as "LUDWIG" (The Mad King of Bayaria). The film of the same name is also an enigma - whose pieces never quite make up an entire film. I was terribly disappointed in this film which is the work of Luchino Visconti, who has

brought to the screen such masterpieces as "The Damned" and "Death In Venice."

The entire film is flawed and I really found it hard ot believe that I was seeing the work of Visconti. Yes, in the past his films have tended to get tedious, but always the feeling and mood of the film were captured in the editing and photography, In "Ludwig," the worst things about the film are the editing and photography, with screenplay and score (you are Wagner-ed to death) coming in a close second. When one thinks of the subject matter - a man who ruled and went bananas, building story-book castles for his personal use, having beautiful men at his beck and call, sponsoring Richard Wagner as the composer wrote his great music, etc. etc. - one would think that something a lot more effective and interesting would emerge on screen than the hodgepodge presented in "Ludwig".

Helmut Berger may be a great personal friend of Visconti's (it's been printed that Visconti is leaving Helmut everything in his will) but unfortunately his acting talents cannot and do not carry such a role as Ludwig. His makeup is fine in conveying the spoiled brat king

who eventually loses it - with those plunked evebrows and marcelled bob. he does a good Germanic Joan Crawford sans shoulder pads. "Time" magazine has stated that the film is 3 hours of watching his teeth rot, and they're not too far off. His best acting is done by the decaying teeth.

There are some individual scenes that are interesting but seem to bear no relation to the rest of the film. Ludwig's preference for young men is first disclosed in a very "GP" rated scene and later in a drunk brawl-room that is nothing but "The Damned" in lederhosen. During his "rotting teeth" period, Ludwig becomes enchanted by a young actor (Folker Bohnet) but the young actor disappears from the film as mysteriously as he appeared. Strange things happen in this film all the time and one is constantly asking "what???" as each scene disvolves into another.

Many of the fine actors in "Ludwig" seem embarassed by their roles. particularly Trevor Howard as Richard Wagner. Silvana Mangano portrays Wagner's mistress who is the cause of much distress and the eventual parting of the ways between M.L. (Mad Ludwig) and Wagner. In another of his




King Ludwig (Helmut Berger) welcomes the Empress of Austria (Romy Schneider) in Visconti's new film at the Larkin Theater.

one of M.L.'s aides and except for one brief scene and speech about losing the war, he is totally wasted. After his success as "Max" in "Cabaret", I was looking forward to seeing him in much better roles. Greim seems to be repeating his role from "The Damned" with even less to do in "Ludwig". The only standout in the film is Romy Schneider as the Empress Elisabeth who seduces then abandons the young Ludwig (prior to his discovery of boys). She conveys a spirit and sense of discipline that is sorely missing in others, particularly Berger.

In a season of many films around town after post-Xmas famine, this is one

supporting roles, Helmut Greim plays that should only be caught by die-hard Visconti fans ("Ludwig" makes "The Leopard" look great) and those who go to look at costumes and sets. Although we are allowed some glimpses of the castles built by M.L., not enough is shown to make it worthwhile for set-viewers only. It's just all too sad and disappointing for me as I expected much, much more but would have settled for less, but this is settling for nothing.




