MAYOR ANSWERS GAY CRITICS

MOSCONE ANSWERS QUESTIONS FROM THE GAY COMMUNITY: A TRANSCRIPT

It was a night of miracles. Supervisor Harvey Milk joined the Alice B. Toklas Democratic Club and was embraced by its founder, Jim Foster. Foster, who had worked diligently for Milk's opponent, Rick Stokes, spoke to the Toklas gathering and urged the Gay community to unite behind Supervisor Milk.

The November meeting of Toklas at the California State Building auditorium in the Civic Center ended early and was followed by a Gay Community Forum with an honored guest, Mayor George Moscone. The mayor was aware of some constructive criticism of his policies from Chris Perry of the San Francisco Gay Democratic Club and others. He received a standing ovation as he entered the auditorium.

The Gay Forum was sponsored by several Gay groups, including the following: GALA, Coalition for Human Rights, BPAC, Gay Democratic Club and Toklas.

This is the actual transcript of the mayor's response to questions and statements made during his presentation:

GAY ADVISORY BOARD

I have been reticent to appoint a Mayor's Gay Advisory Board because of something that I am very sensitive to and that you may be sensitive to also: That is, like any other community, when you select 5, 7, 9 or whatever there will be others that should have been appointed. The last thing that I want to do, is to do anything that would encourage any kind of competitive effort among people who need to work together and with this administration.

POLICE CHIEF CHARLES GAIN

I appreciate this resolution (from the Toklas Club) in support of Charles Gain. It is worth a great

deal. There is a reasonably concerted effort to disparage not just Chief Gain or myself but some of the things that I like to think that both of us stand for. It is of no surprise that the Gay community would recognize it rather quickly and take action to give support . . . I am not weakening in my support of Chief Gain; Herb Caen, to the contrary, not withstanding. There has never been a discussion, thought or action by me to weaken the position of the police chief. He needs reinforcement from time to time, that there is a greater community out there that wants to see a decent city and a decent police department.

GAY CENTER ON GROVE STREET

I do not support the Center in its present locale . . . or anything else at that location (330 Grove Street). The Center should continue there until the 11th hour, when that property is needed to be used. I believe that a Performing Arts Center is good for this city. I believe that it has the potential for adding much to this city, whether you come from the so-called "elite" or from any other place. (Note: 330 Grove Street is in a city Master Plan to become part of the Arts Center project and is temporarily loaned to the Pride Foundation rent-free.)

A FUTURE GAY CENTER

I am absolutely, unequivocally, 100% behind decent, sound, comprehensive facilities that can be called a Gay Community Center. I believe that this is clearly a major obligation of this city. I am happy to join in this effort. That city money, I believe, will eventually have to come out of the Community Development Program. We should provide facilities for this important segment of our community. I believe that you are helping the city by pursuing such a plan. I am going to make every effort to support that. The mayor's office is committed to this and we will need your help to get ratification from our legislative body, the Board of Supervisors.

LACK OF COMMUNICATION

If you ever hear a snide remark about Gay people or the Gay lifestyle from people over which I have some control, I want to know about it. I do not want people in my administration who do not provide respect, no matter how much they may disagree with you on principle. You do not serve your community or me if you think that you are doing something wrong by reporting such incidents to me. I want to know about it . . . Many times things go awry because I do not hear about what is happening.

DISTRICT ELECTIONS & HARVEY MILK

One of the reasons I supported District Elections is because the only way a person can be a 24-hour, 7-days-a-week ombudsman is for that person to represent a particular neighborhood and a particular community . . . The city is now privileged to have the representation of Harvey Milk. Such representatives can deliver concerns better than any "Gay Advisory Board" to the mayor.

TV EDITORIALS CRITICAL OF THE MAYOR

Channel 5 and Channel 7 have never elected anyone to public office. Nor have they ever pressured a resignation. I would hope that the day comes when Channel 7 would find the morality in their own operation that it demands of us.

GAYS IN CITY GOVERNMENT

Our staff includes at least three upfront Gay people — at least they are known to me. There may be others who I do not know about, as I don't think it is my business to check on the personal lives of others.

I hope that the Gay community is not saying, "Give us a Gay on the Police Commission, on the Board of Permit Appeals, and on the Planning Commission because they are votes that we can count on." I hope they are saying, "Here is someone who is sensitive to our needs and who shares that with the other commissioners, who will talk publicly and privately about the needs of our community."

I have never sent the Gay people who work for me out into the community to be my "Gay" representatives. They are not hired for that reason. They were hired because they were the most capable people in a special sphere. They only happen to be part of an important segment of this community. I believe that it is my job to be the liaison with the Gay community.

GAY PARADE - CITY FUNDING?

Roger Boas, the Chief Administrative Officer,

accepted his appointment with the knowledge of where my political head is. (Note: Boas determines where the city hotel tax funds go in the funding of special events. He has refused thus far to fund the annual Gay Parade, calling it a "political" activity.) I am able to discuss rationally with Mr. Boas the needs of this city.

The Gay community has found it to be terribly important to have a parade to exhibit the kind of progress that it has made in this very progressive city. It is an honest endeavor that gives publicity to the city. It is an event that has considerable self-enforcement in difficult times. I can talk with Mr. Boas, allowing him to make an independent judgment about giving financial aid to the Gay Parade. I do believe that my reasoning will prevail, but if it does not, he will have another year's experience before that matter comes up again. I believe that support of this event is a proper expenditure, for providing a little happiness in this city for a very well enforced parade.

GAY ON POLICE COMMISSION

It is very proper to have minority people on the Police Commission for the reason that they have particular concerns about the sensitiveness or lack of it by the police department.

I will not appoint a Gay to the present vacancy. I shall appoint another Black person to that appointment to replace the Black who is leaving.

There will be a Gay on the Police Commission before I leave the position of Mayor.

HOUSING

I support a proposed city ordinance which would make it illegal to discriminate against Gay people in housing.

CITY AWARD MONEY USED TO APPREHEND MURDERERS

City award money is not used capriciously. The money is offered when the Police Department determines that a financial incentive is needed to apprehend the wanted person. They let me know when such an award would be appropriate. We follow Chief Gain's advice on such matters.

POLICE HARASSMENT ON POLK STREET?

We met with merchants and other citizens - Gay and straight - from Polk Street. They unanimously commended Northern Police Station for being so considerate, sensitive and responsible in dealing with the problems in that area . . . I need complaints with specific details if you have any in regard to alleged police harassment of citizens. We will follow up.

GAY ON MANPOWER COMMISSION

There is a current vacancy on the 28-person Manpower Commission and it is slotted for a Veteran. I am open to possible appointment of a Gay Veteran. Please give me the names of Gay Veterans who want to serve, and I will make that appointment forthwith.

GAY UNITY

There are probably a lot of broken hearts and broken feelings from the race in District 5 where two Gay people opposed each other. (Note: A reference to Harvey Milk and Rick Stokes.) It is very difficult to mend that. However, there must be great dispatch in putting aside feelings that were evident in the campaign and unite behind the winner.

There should not be squabbling among one another. When the chips are down, you must put aside the petty politics and fight for the city and the life of your community. That is what I ask of every minority community. On certain basic issues you must speak with one voice, without the squabbling. That is the greatest service you can be to yourselves and to this administration.

FUTURE PUBLIC FORUMS

I hope that tonight is only one of many meetings that I hope will take place between me and my office and the community at large so that we can always be upfront about the problems that plague our city and those problems that particularly beset you. You are certainly part of the greater community. I am sure that you agree with that.

Local TV Opens To Gays

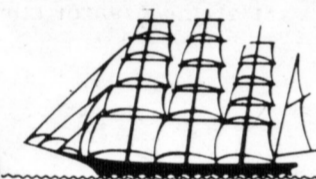
SAN FRANCISCO - Officials of (UHF) TV station Channel 38 (a religious broadcasting outlet here) have decided to give Gay activists a chance to explain their views on the air.

Last June, the San Francisco-based Council on Religion and the Homosexual had complained to the Federal Communications Commission that Channel 38, part of the Glendale-based Faith Broadcasting Network, would not give them equal time to rebut the homophobic views of Anita Bryant. Federal regulations insist that "controversial issues" be fairly handled or the station faces a non-renewal of its license.

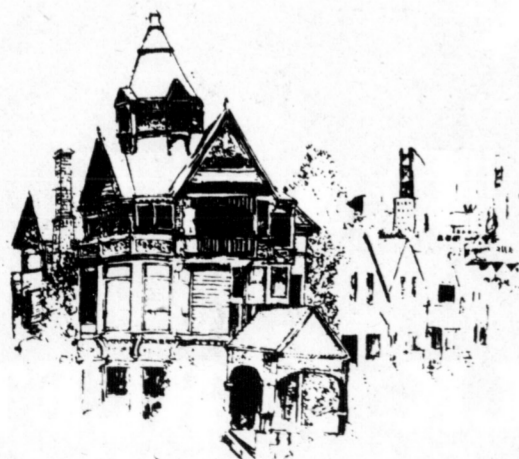
Bryant had appeared on three hours of programming aired by Channel 38 prior to the June 7 repeal of a Dade County, Fla., ordinance that banned discrimination against Gays in housing and employment.

"I believe our broadcasting voice in the San Francisco Bay Area must go on record as recognizing the intrinsic value of the rights and person of the so-called 'Gay' community," the network's president, Dr. Gene Scott, said in a letter released by his attorney.

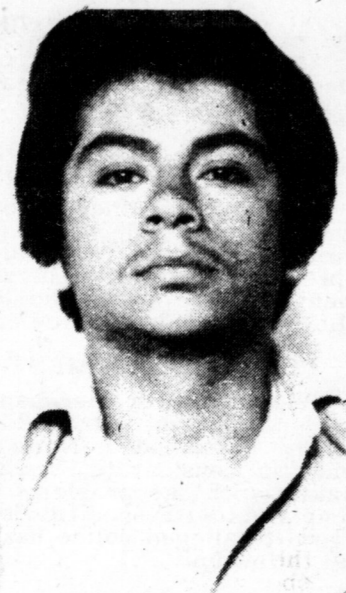


Hillsborough Murder Case Concluding

SAN FRANCISCO - John the California Youth Cordova, 19, of Daly city, Authority after a hearing is to be tried separately in San Mateo County. from his co-defendant B.A.R. has learned that Richard J. Spooner, 20, of San Bruno in the murder case which made a cause celebre of victim Robert Hillsborough. The two were to be tried together, but they now have separate attorneys, and Spooner will face trial after the Cordova case has been concluded. A third adult suspect, Michael Chavez, 20, of Daly City, was granted immunity by the district attorney after he agreed to testify against the defendants. The 16 year old juvenile was placed in the custody of

Cordova will be tried on November 28. There may be a possible postponement until December 5 if his attorney, George Walker, is still involved in a Los Angeles trial. Walker has been attempting to get a change of venue, meaning the case involving Cordova could be heard in another city.

Gays Unite For Anti-Briggs

STATEWIDE ANTI-BRIGGS SESSION IN L.A.

Gay activists from across the state will be meeting at the University of Southern California in Los Angeles, December 9-11. The three-day session will be a broadly-based rally and planning session to unite the Gay community behind the fight against the anti-gay teacher initiative proposed by State Senator John Briggs.

The U.S.C. conference is open to all Gay people. It begins Friday evening with registration and socializing. Saturday will be a day of workshops. Sunday will feature a general business session. A ten-person statewide planning group set up the conference, which follows a preliminary meeting that was recently held in Sacramento with 200 Gay activists participating.

Buses are being leased for the trip with a \$24.00 round-trip charge. They will leave on Friday at noon from the Gay Community Center, 330 Grove, and return late Sunday evening. Free child care and some housing will be provided for those taking the trip. Those who have cars or wish to make automobile arrangements may call Les Morgan at 775-1000. National Women's Meet Backs Lesbian Mothers

"Thank you, sisters!" came a yell from a California cheering section of the gallery as the National Women's Conference meeting in Houston passed a Lesbian Rights plank on Nov. 20. The measure, if it is adopted by Congress or put into effect by government agencies, would allow Lesbian mothers to keep their children and guarantee them equality in housing and employment. In reality, acceptance of the resolution by women at Houston means that the same guarantees would apply to Gay men.

Earlier in the 2,000 delegate fete, San Francisco's Del Martin spoke to the assembled on the need for clinics and other aid for battered women. Martin authored the first important book on the plight of the battered homemaker, "Battered Wives," and serves as Chair of the local Commission on the Status of Women. She was in Houston with her lover, Phyllis Lyon, who heads the National Sex Forum

and serves on the Human Rights Commission. H.R.C. staffer Jo Daly was also one of the 13 upfront Gay women in the 96 delegate group from California.

All 26 of the proposed resolutions -- including the right of women to have abortions and support for the equal rights amendment -- received overwhelming approval. Phyllis Schlafly, who heads the ultra-Right, anti-women's rights movement, held her own unofficial rally which drew 20,000. Schlafly told the media that the "Lesbians who are anti-family" controlled the federally financed official meeting. Former Congresswoman Bella Abzug, who chaired the Houston Coliseum sessions, denied the accusation. Abzug said that the conference delegates were chosen in fifty separate states and six territorial conferences and that they were a representative cross-section.

Who's Expendable, Caen Or Gain?

The persistent infantile stratagems of the Police Officers Association to undermine Police Chief Gain seem to know no limit. The latest, leafleting of the community with photos taken of Gain and Margo St. James at last month's Hookers' Ball -- as if his presence aided and abetted immorality -- is par for their sleazy efforts. Their locker room pranks, while unfortunate, are just that and not much more.

No one knows this better than Herb Caen, local rumor monger and arbiter of fad. It is no secret or scoop that Caen has his private "hit" list and that once on it, the victim can expect himself yipped and yapped at beyond boredom and/or beyond truth. Caen wants Chief Gain removed from office, and Caen will see to it that no mud pie is left unthrown.

In one recent column he has "rumors flying around City Hall" that Gain will be gone by tomorrow's mail.

His latest item is to inflate and keep alive the Hookers' Ball photo -- He puts the question, "Why is Police Chief Gain as moralistic (read 'uptight') about men under his command, and so lacking in restraint in his own behavior -- as witness his rollicking attendance at the Hookers' Ball?"

Now if Chief Gain were talking in the first case about some cop's having his picture taken with Margo St. James at a Ball and then ignoring his own photo session -- Caen has a point.

Obviously there is a world of difference between being upset over shakedown, drinking on duty and citizen harassment and being upset over graffiti which blackens one's reputation.

Caen, the inveterate coward, then puts into the mouth of ex-Mayor Christopher how the latter would "do things in the proper and ethical manner." Christopher would go to his Police Commission and "if they didn't fire the Chief, I would fire the Police Commission." Ho-hum...

PRIDE CONTESTS JUDGE'S RULING ON FLORIDA

Stanley Weigel, federal district judge in San Francisco, has ruled that Anita Bryant, Bob Greene, Mike Thompson and Save Our Children, Inc. in Florida are out of his jurisdiction in a suit filed by Pride. Pride is suing these parties and State Senator John Briggs in a \$5 million court action which alleges that the defendants created a climate which led to the murder of Robert Hillsborough. Weigel contends that there was not ample direct involvement in California by the Bryant forces in Florida.

The court action is being brought by the Pride Foundation on behalf of Mrs. Helen Hillsborough, mother of the victim, under a statute which makes it illegal to deprive persons of their civil rights out of prejudice.

Attorney John Baissey, who recently flew to Florida and obtained a deposition from singer/activist Anita Bryant, says that Pride will contest the judge's ruling. Senator Briggs has also given a deposition in the case.

The judge emphasized that he was not judging the merits of the case by his ruling. There will be a later hearing on the matter in another court.

The death of Robert Hillsborough received national attention as it occurred directly after the wide publicity given the defeat in Miami. It was alleged in some reports that those attacking Hillsborough shouted anti-Gay taunts at the victim, although the clarity of what really happened has not been explained in a court by witnesses. The coming trials of the alleged murderers of Hillsborough may cast more light on what transpired.

Storm Over Noble's Stepping Down



Massachusetts state representative Elaine Noble announced that she will not seek reelection.

The Boston Gay community has been embroiled in an on-going controversy ever since Elaine Noble's announcement that she would not run again for the Massachusetts House of Representatives.

Critics led by David P. Brill, Editorial Consultant for Boston's Gay Community News, have charged that Noble accomplished little for the Gay community and spent most of her time traveling around the country making speeches. The controversy has spilled over to "Community Voice" section of the GCN with charge and counter-charge.

Wrote one critic, "As far as I can tell, Noble's only legislative accomplishment was passing a bill that would put hustlers in prison. That is quite an achievement for a Gay person." Others have accused Brill of stabbing Noble in the back.

A recent redistricting of the Massachusetts legislature reduced the number of representatives, and Noble would have been forced to run against highly popular Barney Frank. It would have been an awkward confrontation.

In the last two years Noble has repeatedly campaigned in California — not always to the delight of the Gay community. In the recent San Francisco supervisory race Noble made appearances for candidate Rick Stokes, who was battling Harvey Milk in District 5 along with three other Gay candidates.

Mass. Court Defines "Privacy" In Sex

The Massachusetts Supreme Court last week ordered a new trial for John Scagliotti who pleaded that he was a Gay victim of police harassment. The defendant had been convicted of soliciting to commit "an unnatural and lascivious act with another person."

The Civil Liberties Union of Massachusetts considered the Scagliotti decision a victory "test case" in halting police harassment of Gay men.

The Supreme Court also ruled that a "consensual unnatural act must be committed in a PUBLIC place in order to be punishable by law. The PUBLIC nature of a consensual act is an essential element to be proved by the prosecution."

State Representative Barney Frank (a long-time friend of the Boston Gay community) said that the court made "a clear-cut statement that private, consensual homosexual sex is not punishable in Massachusetts."

The court defined privacy as meaning "removal from the public view and elimination of the possibility that the defendant's conduct might give offense to persons present in a place frequented by members of the public for reasons of business, entertainment or the like." Frank viewed the Court's definition of privacy to be a "functional" one, rather than a "formal" one.

RC Hierarchy Rejects Liberal Sex Report

WASHINGTON, D.C. — lute "dos" and "don'ts" Roman Catholic bishops last week condemned a report released last spring that urged an easing of Church rules on sex.

The controversial report, a book-length study called "Human Sexuality: New Directions in American Catholic Thought," concluded that activities such as adultery, premarital sex, homosexuality and masturbation can be condoned in some circumstances.

The bishops, speaking through their doctrinal committee, said the study "departs from the teaching of the church," abandons "objective criteria" of evaluating sex acts and weakens "the demands of sexual morality."

The doctrinal committee's position represents the view of the entire National Conference of Catholic Bishops, which is meeting in Washington. However, the conference took no vote on the matter.

"By abandoning norms that make specific demands, the report reaches the conclusion that sexual activity outside of marriage can be permissible or even virtuous," the bishops said in repudiating such conclusions.

The "Human Sexuality" study was issued last spring by a five-member committee of the Catholic Theological Society of America and has stirred widespread interest and varying reaction.

It departs from the church's traditional abso-

Gay Rights Reach Amnesty International

According to a report by Jim Marko in Boston's Gay Community News, Amnesty International, the human rights organization and recent winner of the Nobel Peace Prize, is considering a resolution that the organization define violations against homosexuals as a human rights issue.

At the recent Annual International Council Meeting to determine new policy, the French delegation (with American backing) introduced a resolution that stated: "The International Council of AI, recalling the terms of the Universal Declaration of Human Rights, considering that certain governments imprison people because of their homosexuality and considering that freedom of choice in sexual matters where this does not infringe upon the rights of others is a fundamental human right, it resolves to recognize as prisoners of conscience, those persons drained because of their homosexuality."

An American delegate to the annual meeting said that the resolution was referred to a conference

committee which amended it omitting the word homosexuality. The amended resolution referred to those "arrested because of their sexual orientation or behavior between consenting adults which does not infringe upon the human rights of others."

word is enough to have the group adopt those prisoners incarcerated because of their sexual preference; therefore that change is also in committee.

Worldwide in scope and independent of any government, Amnesty International is an organization that works for the release of people "imprisoned or tortured because they profess the wrong politics, or pray to the wrong God, or were born the wrong color." The group "adopts prisoners of conscience," investigates the circumstances of the case and then, if it deems fit, brings the case to the public forum.

Gaylord Case Is Not The Last Word For Gay Teachers

The recent refusal of the U.S. Supreme Court to review the case of James Gaylord, a former teacher in the Tacoma, Washington, public school system who was fired simply for being Gay and honestly admitting it to school officials when he was asked, has rightfully caused outrage among Gay people throughout the country. The case should be seen in perspective, however, and not taken as the end of the road for the assertion of equal rights by Gay teachers or Gay public employees generally.

The Supreme Court's action has only the effect of letting stand the decision of the Washington State Supreme Court which upheld Gaylord's firing. Further, the firing was by a local school board in a city in Washington State which had no ordinance protecting Gays from employment discrimination, and so the result would doubtless be different even in Washington State had the city involved been Seattle, for example, which has a Gay rights ordinance.

The Gaylord decision has no binding effect on the courts of any state other than Washington, and courts in other states have in previous cases reached different conclusions. The California Supreme Court in 1969 in Morrison v. State Board of Education held that a teacher could not be fired simply because she was a Lesbian, where no adverse effect on her ability to teach was shown.

The federal district court in Maryland has previously found, in Acanfora v. Montgomery County Board of Education, that one's status as a homosexual alone should not be a basis for firing, and that homosexuality per se is a "suspect class," which means that for a discriminatory classification to be constitutional, the state would have to meet a very heavy burden of proof to justify the discrimination. Acanfora's dismissal was ultimately upheld, however, because he intentionally did not disclose membership in a Gay student organization in college to the school authorities when he was hired.

Recently another federal court in Oregon found in favor of a Gay teacher in Burton v. Cascade School District, and damages were recently assessed against the University of Delaware in Aumiller v. University of Delaware by a federal court when Aumiller was fired because he spoke out in favor of Gay rights.

Gay teachers, therefore, should continue to assert their rights to equal employment in public educational institutions. When they are told they may be fired because they are Gay, they should demand an administrative hearing. If that is unsuccessful, they can bring court action.

Where private educational institutions are involved, however, Gay teachers would have much less chance of successfully challenging discrimination unless the locality in which they taught had adopted a law protecting Gays from employment discrimination, because the constitutional provisions under which the cases discussed above were decided apply only when discriminatory action is taken by a governmental body.

Poll Shows U.K. More Tolerant on Gays Than U.S.

The Gallup Poll has reported that British attitudes towards homosexuals are generally more supportive than those of their American counterparts.

When asked if Gay people should have equal rights in employment, 65% of the British respondents answered "yes" while 19% answered "no." Americans favored equal rights by a smaller 56-33% margin. Both national groups held similar views on whether Gay people should be elementary school teachers, clergy, doctors, salespeople, and armed forces personnel, however.

On several general questions, British attitudes were much more pro-Gay than those of Americans. 66% of Americans thought that homosexuality was more "prevalent" today than 25 years ago, compared to only 43% of British who agreed with the statement.

Americans, more than the British, tended to attribute homosexuality to upbringing, rather than

something that a person is born with. 56% of the Americans agreed with the "upbringing" theory, compared to only 28% of the British respondents. 31% of the British saw homosexuality as an innate condition, while only 12% of the Americans subscribed to that theory.

One of the major differences between the attitudes of the two nations came in attitudes on whether or not consenting sexual activity should be legal or not. Britons opinion backed legal consensual sex by a 58%-22% margin, while the Americans were equally divided on the issue, 43%-43%.

Bryant Retains Job

LAKELAND, FLA. - Despite the recent flurry of trial balloons to test the wind of public opinion, the Florida Citrus Commission here has renewed Anita Bryant's contract.

In addition to the \$100,000-a-year contract, the Commission passed a resolution praising her courage in battling Gays.

The move by the 12-member

which extended Bryant's contract through August 1979 ended all speculation that Bryant had become too controversial.

The Commission also adopted a policy that there will be no further discussion of the Bryant situation by anyone connected with the Commission - including its advertising agency, except in open meetings of the Commission.

While the gag rule applies to Citrus Commission and ad agency officials, the public is still free to express their dissatisfaction. Particularly insofar as Bryant continues to appear with groups and promoters who demand that all homosexuals be in prison.

PORTLAND, ORE. - An initiative to recall Portland's Mayor Neil Goldschmidt for his 1977 Gay Pride Day Proclamation failed in late October. 25,110 valid voter signatures were required by October 18. The number was not reached, and no sheets were turned in. News reports stated that only 18,000 names had been secured.

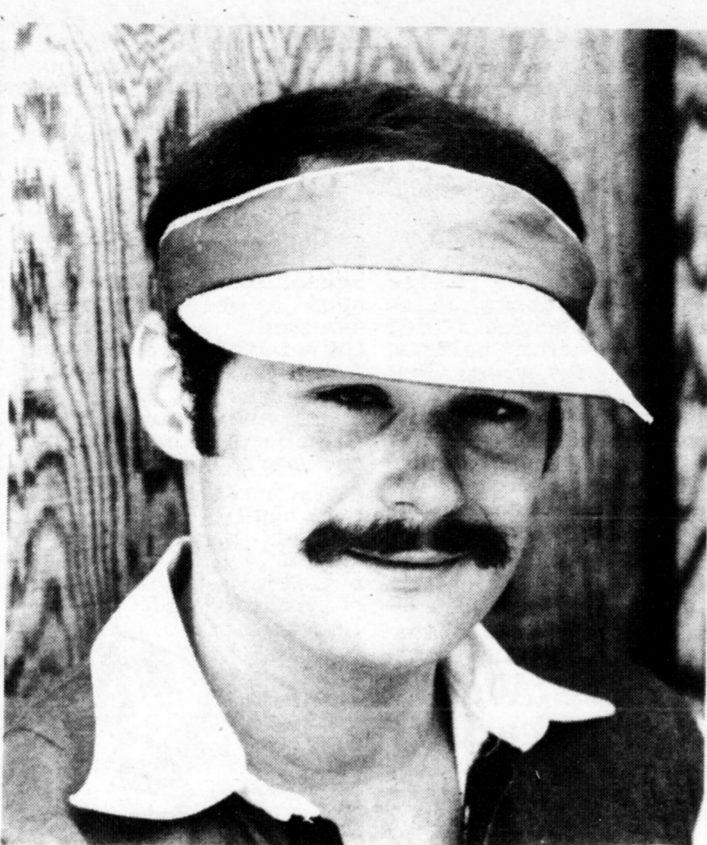
The initiative was sponsored by a group called "Citizens to Protect Our Children Committee."

James Spada launches gay lifestyle survey.

National Gay Lifestyle Survey

James Spada, Los Angeles Gay activist and author, is currently conducting a nation-wide survey of Gay male lifestyles and sexuality, to be published next year by New American Library.

The survey is based on a questionnaire Spada has formulated and is distributing through the mail. "This survey is unique," Spada says, "in that Gay men are being asked to write about their feelings and their emotions. The survey is not statistical, but verbal. The Gay men who respond to the questions will be treated as human beings, not numbers. The answers, whether two words or two pages long, will be printed verbatim in the book - without analysis or interpretation. I'm very excited about the concept because I think it's about time Gay men had a chance to speak for themselves!"

The questionnaire is anonymous and, although it consists of 55 questions, respondents can answer only those questions that interest them most. "The questionnaire isn't easy," Spada admits, "so I'm urging those people who don't have the time or inclination to complete it to send in whatever they do have the time to write every answer is important."

Says Spada, "This book is a great way to let Gay men explain themselves - and by so doing, I think that a lot of stereotypes are going to disappear."

Spada's previously published works include "Barbra: The First Decade - The Films and Career of Barbra Streisand" and "The Films of Robert Redford." He is active in Los Angeles Gay life, a member of the ACLU Gay Rights Chapter in Southern California

and the National Gay Task Force. Recently the Los Angeles Times reprinted a letter Spada wrote to his father, informing him that he was Gay. Spada explains this public coming out: "I think it's very important that Gay people reveal themselves because so many of us do not fit into 'Gay mold.' I wanted the Times to reprint the letter so that other Gay people might be inspired to do the same thing. It worked, because I got many letters telling me just that."

THE POWER OF THE BALLOT

More and more, the Gay community in San Francisco has proven its power at the ballot box. The secondary part of that power is the working on the campaigns for candidates. The experience and learning of those Gay people who have worked must now be put to positive use.

Unfortunately, we might have to pull all that energy and talent together in a fight against the Briggs initiative if his new one gets the signatures to get on the ballot next year. The planning stages and strategies are already taking place for that struggle.

In order to develop even stronger knowledge, Gay people must get involved not only in Gay political clubs but into the campaigns for local and state office. In San Francisco we already have a small army of people with experience who have built the bridges with other people. This must be done in all the other cities and counties of the state - Fresno, San Diego, Santa Cruz, San Jose.

I will give as much help to any group anywhere in the state in passing on my experiences. What worked and what did not work in my case.

BRIGGS

The battle against Briggs will be hard and dirty on his part. We must reach out to every possible group of people everywhere in the state. I urge every Gay person to get involved in their local races - primary, etc. We will need as much help in our fight as we can get, and there is no better way of getting that help than to start to help others now.

ORANGE JUICE

The Florida Citrus Commission has told the Gay people of the nation just what it thinks of us. It gave Anita Bryant a new contract. It made a value judgment on her

anti-Gay stands and congratulated her. The new contract was a sign of approval of what she stands for.

The Gay community in the nation can and must respond. It is too easy to continue to drink our OJ in the privacy of our kitchen. But what must be made clear is that the convenience of drinking Florida orange juice will make life inconvenient to Gay people elsewhere. Every time you drink Florida OJ you are saying that Anita Bryant should continue to speak out against Gay people - that it is okay to take away our rights. The price that you pay when you "must" have your one glass of OJ in the morning is that some young Gay person somewhere in the nation will have their rights taken away. I cannot urge every Gay person and every "friend" too strongly to stop drinking ALL orange juice that comes from Florida.

Every Gay person must be made aware of the power of their vote AND the power of their dollar. Every Gay person must become aware of issues. And every Gay person should become fully aware of what power their individual dollar has. If the estimated 2 million Gay people just in this state alone did or did not drink one glass of OJ each day, that adds up to a total of some 730 MILLION glasses per year! The conclusion... don't drink orange juice from Florida and spread the word throughout the nation.

(EDITOR'S NOTE: According to TIME Magazine, Florida orange juice sales are down 10% from a year ago. Citrus industry flacks attribute the drop to higher prices caused by a poor growing season last winter. Perhaps a 20% drop in sales will prompt them to look elsewhere for the causes...)

Shall We Laugh?

For several years I've been clipping articles that have to do with homosexuality from the daily newspapers, and I've now filled a couple of scrapbooks. When I page through these scrapbooks, I invariably end up laughing. In most instances, of course, the articles are

turn common sense upside down. Recently, Anita Bryant shouting that she's being "persecuted" while her own record offers stark evidence that she is the persecutor. Why does she choose this very word? Is something nagging at her conscience? She has also claimed that she is being "crucified" and her choice of that word tells us quite a lot about her grandiose self-delusion.

And then there's Senator Hayakawa, who ought to know something about the use of language, but apparently forgets. "I do not believe homosexuals should be teaching family life classes," he says, "because they don't know about family life." Surely the senator must know that the term "family life" is a euphemism employed solely to avoid the dread word "sex." Is Hayakawa trying to pull someone's leg, or is he simply willing to admit to the world that he loses his ability to think when he is confronted with homosexuality?

Farther back in my scrapbooks, I find some truly hilarious examples of how antihomosexuals are willing to stand on their heads. A couple of years ago television viewers who were interested in art and/or culture heroes were able to watch a program about Leonardo da Vinci. But something funny happened to Leonardo on his way to the television studio - he lost his sexual orientation. This, of course, made problems for the script writers, particularly in a scene where Leonardo and his male friends were being quizzed by the authorities of the time. Since the people who made this

program couldn't believe for that a man of genius could be homosexual, they resorted to an outright lie: the charge was changed to heresy. Obviously it isn't fascists and communists who think they can rewrite history and get away with it.

As far as homosexuality is concerned, the re-writing of history has been going on for a long time - and still goes on. One of the funniest clippings in my scrapbooks is a Reuters dispatch from London that appeared in the fall of 1974. It's a brilliant example of doublethink: "William Shakespeare, you may or may not be pleased to know, was not a homosexual. But, according to Martin Seymour-Smith, writing in the British Journal of Sexual Medicine, he was a heterosexual who 'suddenly and to his own shock and surprise, found himself the victim of a homosexual passion.' Not only was the Bard prey to a homosexual passion but, says Seymour-Smith, judging from references in his sonnets 34 to 36, he actually succumbed to it. It is not possible to explain these sonnets except in the hypothesis that Shakespeare did on at least one (and probably

only one) occasion, have some kind of physical relationship with his friend," he says."

How many homosexual acts make a man a homosexual? Let's imagine that Shakespeare lived in the United States in a recent year and that he made his living as an accountant or a store clerk. We may rest assured that nobody would later write "William Shakespeare, you may or may not be pleased to know, was not a homosexual." But there's something even funnier going on here. According to this account, Shakespeare was a VICTIM. He was PREY to homosexual passion. And it all happened SUDDENLY AND TO HIS OWN SHOCK AND SURPRISE. Would anybody like to place any bets?

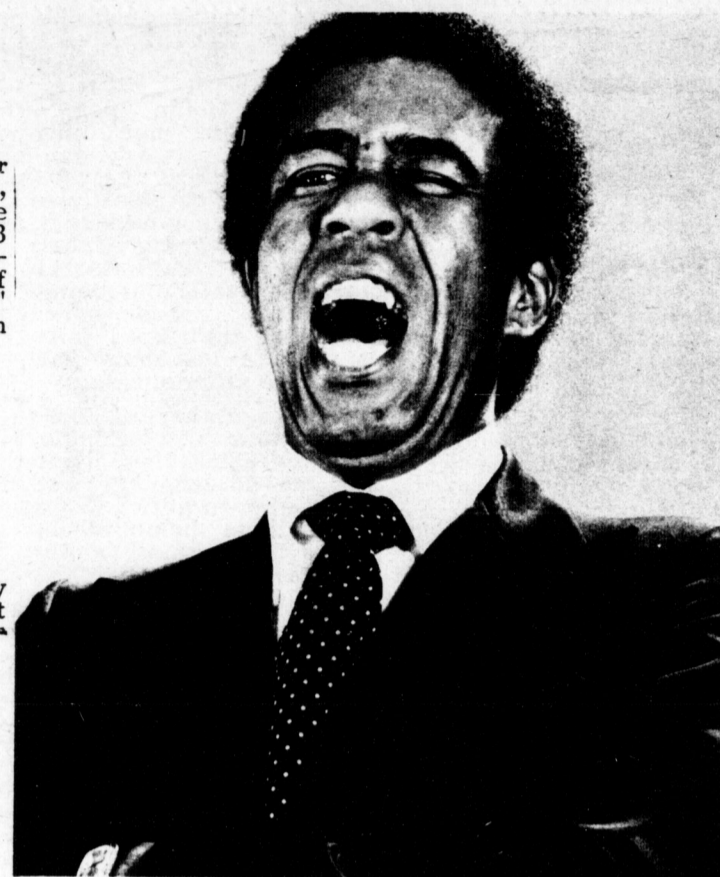

retail handling of poultry in local markets. However, mistakes within the home may let a few germs multiply rapidly, and cancel the benefits of all the precautions taken on the long route from farm to kitchen.

Holiday birds are sold fresh, frozen, whole, in parts, or in rolls, with or without dressing inside, and "oven-ready." Each must be handled differently, and each must be handled with proper care, to remain fresh and wholesome - but a single theme runs through all the different ways of preparing the bird for the table: "Keep it very cold or very hot. After thawing, don't let it stand at room temperature, neither raw nor after it is cooked."

KITCHEN INSTRUCTIONS FOR A SAFE HOLIDAY DINNER

1. DO NOT THAW commercially frozen STUFFED birds before cooking. Thaw other frozen poultry in the original wrappings, under cold running water for 2 to 6 hours, depending on size; or thaw in refrigerator for 1 to 3 days; then cook as soon as possible.

2. Roast bird unstuffed, and bake stuffing separately in a shallow pan. However, if you INSIST on stuffing your bird, do this at the last minute before roasting, and then roast at 325 degrees F. for 20 to 25 minutes per pound. The roast is done when a meat thermometer in the bird reads 180-185 degrees F.; stuffing should read 165 degrees.

3. Serve within 30 minutes. Don't let the leftovers stand too long. To store, wrap well to prevent drying, and put immediately into the refrigerator at 35-45 degrees F.

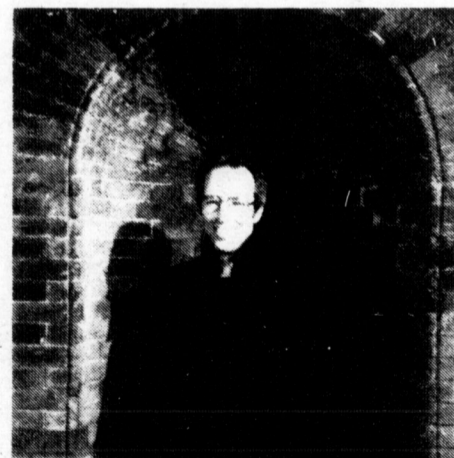

For a Food-Safe Thanksgiving

Traditional American holiday foods such as the turkey are a symbol of joy and plenty, yet these same foods occasionally may be a source of physical misery. Unless they are carefully handled in all the preparatory processes, Thanksgiving poultry (turkey, duck, chicken, goose, etc.) may reach the table tainted with certain germs (salmonella) which may cause cramps, diarrhea, and other classic symptoms of food-borne infection. The Federal and State health protection agencies maintain strict regulations over the wholesale processing of table poultry and other food products; the San Francisco Health Department oversees the safe

Coors: Thousands For Sales But Gaycott Continues

The Adolph Coors Company of Golden, Colorado, has publicly admitted that a Gay boycott of its beer has affected its sales. Coors has spent countless thousands to lure back the Gay consumer, but it has failed miserably. Even the heads of the brewery, the notoriously ultra-conservative Joseph and Bill Coors, have been forced to hit the road to push their product as sales decline. Gay Power has been recognized as being effective in reducing sales of a major corporation.

Adolph Coors' non-voting stock was offered to the public for the first time in its 105 year history in 1975 at \$31. It has since declined to \$14. Coors, which manufactures a variety of products, had restricted its sales to only a few Western states, but is now expanding to other states to halt its sales decline.

The beer, which is unpasteurized so must remain refrigerated most of the time, is shipped to Coors-owned distributors directly from Golden. It is manufactured in a brewery built by the Coors construction company. The product is advertised by the Coors advertising company. Every aspect of its operation is owned and controlled by the descendants of Adolph Coors.

Coors also has attempted to control what kind of employees it has and reserves the right to dismiss an employee on a whim. It has strung out negotiations with its few unions so long that the unions have been weakened or dissolved. Coors management has consistently hired non-union employees ("scabs") to take the place of union strikers in order to deny workers any kind of organized bargaining unit.

Gays became involved in the striking Brewery Workers dispute which began in April, 1977. Rumors spread that Coors had sent considerable money to support Anita Bryant in Miami. This reporter personally checked the Save Our Children records in Miami and could find no truth to the rumors. However, the rumors persisted that Coors, somehow, discriminated against Gay people

is interested in whether prospective employees have ever taken drugs, participated in a demonstration or done anything that might "embarrass the company."

2. Employee Rights: Coors reserves the right to fire any Brewery Workers employees for ANY reason. The reason could be sexual orientation or any other "cause." The reason does not have to be job-related.

3. Union Busting: Management has consistently used every technique to destroy employee bargaining - believing in bargaining done between an individual and management, where the employee is in no real bargaining position.

4. Joseph Coors: The purchase of Coors beer continues to make the President of Adolph Coors Company a millionaire. With his vast wealth, this man has financially assisted the most ultra-conservative organizations in the nation - The Heritage Foundation, the John Birch Society, the Committee for a Survival of a Free Congress, and the National Federation of Independent Businesses. These groups support representatives and senators in Congress who have voted successfully to eliminate Gay people from federal housing and legal assistance programs.

The recent interviews with Joseph and Bill Coors in The Advocate were very revealing. They revealed that both men had nothing to say that was new and re-emphasized what this reporter had revealed in the earlier B.A.R. series.

The Gay boycott of Coors has put Joe and Bill Coors on the road, pushing their beer and doing personal public relations that would normally be done by their advertising department. The Coors have even discovered two

Lesbians in the factory

and put them on an all-expenses paid vacation, telling how "wonderful" it is to work in Golden. Coors executives held several meetings - in San Jose, San Francisco, Orange County and Los Angeles. They have spent thousands in advertising and promoting themselves - but not one cent for Gay liberation. Coors has even used the support of Ray Broshears in advertisements to promote its beer in the Gay community.

The strike continues at Golden with half of the 1,472 hungry strikers returning to work. The

others walk the picket lines and receive some aid from the national AFL-CIO. The brewery continues to operate partly with "scab" workers who evidently do not care about human rights. Meanwhile, the meetings with Gay leaders and bar owners have not been successful. At one recent session in San Jose, Coors representatives spoke and then the group voted to continue the boycott. The Coors "public relations" advertising has brought more public attention to the fact that there is "trouble" at the factory in Golden.

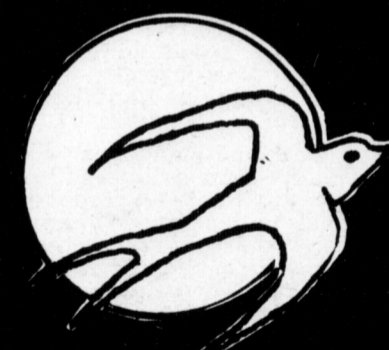

The Men in My Life

George Sand - Part III "There Is Only One Sex"

by Paul-Francis Hartmann

LOVE AND SAND

On finishing an early novel of Madame Sand (his mother's copy), Walt Whitman experienced a conversion. From Sand's lines Whitman drew his All-encompassing Lover - "flinging his arms, drawing men and women with undeniable love to his close embrace."

BEFORE THE SEXUAL REVOLUTION

From 16 to 65, George Sand thrived and suffered in a vortex of love and lovers. In 1865, George (who lived her stories before she wrote them) published her novel LE DERNIER AMOUR (The Last Love). George was 61, her latest, painter Charles Marchal - who could love "lightly, healthily and well" was a much younger man. She called Marchal her "great springtime." But she dedicated her book to her newest friend, Gustave Flaubert - much to Flaubert's embarrassment. The deep attachment of Sand and Flaubert (to many, France's greatest novelist) lasted until her death in 1876 at the age of 72. Gustave was 17 years her junior. Their affinity remarks one biographer "remains a marvel."

In George's 20's her lovers were her contemporaries and seniors; in her later years, her juniors by as much as 30 years.

The roster of George Sand's lovers reads like the Who's Who of artistic and political France from 1830 to 1860: poets, novelists, journalists, playwrights, actors, composers, musicians, doctors, politicians, government officials. From playboys to students... almost everyone save Prince Napoleon and Louis Pasteur...

George Sand was not the greatest beauty of her day. Poet Alfred de Musset described her as "black-haired, olive-hued skin with highlights of bronze, and enormous eyes like an Indian's." Yet George was perhaps the most magnetic woman imaginable. And as in the song, "Men clustered to

her as moths about a flame." As she saw herself - to each lover she was true and loyal - in her fashion! She plumbed a relationship to its depths and stretched it to its limits. Once exhausted, she moved on. There seemed an endless supply of admirers waiting in the wings.

She would respond to her suitor - or her prey - delicately but forthrightly. "She was a 19th century lady with the directness of a man," writes a biographer. "A disconcerting combination for her male contemporaries who thought the one category excluded the other."

It was not unlike George at 30 to run off to Venice with the 22-year-old Alfred de Musset. Of this celebrated poet she wrote, "He is a person I love more than anybody else in the world." The lovers set off for Italy on the twelfth of December, 1833, full of hope and high spirits. George wore "pearl-gray trousers, Russian leather boots and a visored velvet cap."

Two months later the affair had soured, and Sand returned to Paris with a new lover in tow, Pietro Pazello - a handsome, healthy, well-built 26 year old Italian doctor who had nursed Sand through the "turistas" and later Musset through typhoid and the DT's in Venice's Hotel Danieli.

"When I love... Love is all. True complete love is when two hearts, two minds, two bodies meet in understanding and embrace. That meeting, that many-sided embrace, a 'sympathie,' occurs once in a thousand years. So long as but two elements concord - mind and body without heart or body and heart without mind - one believes the third somehow exists until the absence becomes so strongly felt it kills the 'sympathie' of the other two."

George Sand was both lucky and unlucky in love. One thing remained; she never ceased experimenting. At 46, she wrote of her latest adventure, "I have been able to abandon myself to it selfishly... I am 46. I have gray hairs. I have learned that old women are more loved than young women."

BEFORE KATE MILLETT

One of the more successful of her amours and the least discussed was her intimacy with Marie Dorval, the beautiful and famous actress. Marie was the Sarah Bernhardt of the Paris stage in the 1830's and 1840's.

Born illegitimately to a pair of touring performers in 1798, Marie had babbling her first words on stage. She learned to please before she knew even a child's pleasure. Married at 15 to the balletmaster of the troupe, Marie was more than pretty, she was a "charmer."

The winter season of 1833 saw her at the height of her theatrical career playing in Hugo's "Marion Delorme" and Dumas' "Antony." George was a great theater-goer and was overwhelmed by the splendid actress. She wrote Marie Dorval, asking to see her. With similar directness Marie responded. The day she received George's note, she was at the door of George's Paris apartment. Marie threw it open without knocking, went straight to George and embraced her. "Here I am," she cried breathlessly, "I!" (At time both women had husbands, children and live-in male lovers.) To say the least, "It was a time of tangled lives."

George would meet Marie at the theater, in her loge after the spectacle, or "at the corner of the fire" in George's apartment - "living" a great deal in a few hours. They became known as "the inseparables." "At this time," recounts a contemporary wag, "Sappho was reborn in Paris."

George packed her male lover off to Italy, and all Paris buzzed with the scandal. In 1840 the same lover wrote in appreciation - rather than denigration - of George. "Madame Dorval placed her friendship in Madame Sand. An instinctive feeling of sympathy drew the one woman to the other... Both women incomparable in talent and unhappiness; the one an eagle, the other a dove, both swept away by the storm, sides being the outstanding man of our time."

As one of her early lovers, Jules Sandeau (her first collaborator and from whom she borrowed the "Sand" of her nom de plume - Sandeau, who was the rival of George's affections along with Marie Dorval and a dozen others) reminisced in 1840, "As the man, or woman, who lived on the borderline of the two sexes, Madame Sand was sort of a female Christ, carrying the cross of womanhood in her arms, shielding the adulterers from the world's stoning."

tions and subtle rationalizations with which societies feed themselves in that matter. I have observed the childhood and development of my son and daughter. My son was myself and consequently more feminine than my daughter, who was a failed man."

Writing in 1914, Henry James aptly noted, "The moral of George Sand's tale, the beauty of what she does for us is not the extension she gives to the feminine nature but the richness she adds to the masculine," - the lesson of the Wholeness of George Sand.

After her funeral Flaubert wrote, "One had to know her as I knew her to realize how much of the feminine there was in that great man, the immensity of tenderness there was in that genius. She will remain one of the radiant splendors of France, unequalled in her glory."

We are a group of homosexual women and men with a strong love of our Jewish heritage and a desire to perpetuate it.

We range in age from the 20's through the 70's and we come from every kind of Jewish background, from Orthodox to totally secular. We represent a cross-section of the San Francisco Jewish community.

Some of our group have attended yeshivot or Yiddish schools, been or still are members of other synagogues and/or Jewish organizations. 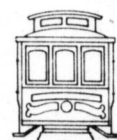

Jewish identity within this special framework.

Our forebears formed new communities based on earlier places or origin and common cultural patterns. "Olin" have formed "kibbutzim" and "moshavim" in Israel based on common social beliefs. We have formed our synagogue and community or "kehillah" because in it we can best experience our Jewishness among friends who understand our feelings and our way of life.

WHAT RELIGIOUS SERVICES AND OTHER ACTIVITIES WILL WE OFFER?

Our Friday night service is the highlight of our week. We will welcome the Sabbath with great joy, singing and dancing. Then we will have a coffee hour followed by an Oneg Shabbat which is usually a cultural or entertainment program of Jewish or Gay interest. We finish the evening with Israeli and Yiddish folk-dancing.

We will celebrate all the holidays of the Jewish calendar with appropriate services, traditional meals and songs. Traditionally on the first day of Rosh Hashannah we have a community dinner after services and end the day with tashlich. We break the fast after Ne'ilah with a kiddush. We have full Simchat Torah celebration. We have a Chanukah service, Chanukah and Purim social dances, a Purimspiel, read the Megillah, and conduct a community seder on the second night of Passover. We celebrate Shevout, Yom Hashoah, Yom Atmout, and Tisha B'Av.

HOW DO WE RELATE TO THE LARGER JEWISH COMMUNITY?

Congregation Sha'ar Zahav does not fit into any of the traditional categories of synagogues in America. We have not sought affiliation with any of the existing Jewish denominations - Orthodox, Conservative, Reform or Reconstructionist. Our ritual conforms to none of these, yet borrows from all of them. We enjoy cultural pluralism in the American tradition. We find it possible to integrate and enjoy our Gay lifestyle and Jewish background at the same time. We wish to remain free to develop the style of worship that best suits our needs. Sha'ar Zahav is a Gay Jewish community, having an experimental synagogue as its focus, with a feeling of love and spirituality all its own.

We consider ourselves rightful members of the Jewish community. We are dedicated to supporting Jewish institutions. We are profoundly concerned about Israel and Jews all over the world, and are interested in promoting Jewish religious education and culture among ourselves. We aim, on the one hand, to promote an understanding of homosexuality in Jewish community, and on the other, an understanding of Judaism among homosexuals.

IN WHAT WAYS DO WE ACT ON OUR VALUES?

We hope to participate under the banner of Congregation Sha'ar Zahav in demonstrations for Israel and oppressed Jewry. We hope to raise funds for the United Jewish Appeal, the Israel Emergency Fund, Keren Kayemet (Jewish National Fund), several local Jewish charities, and Gay organizations.

We hope to have classes in Hebrew, Yiddish language and literature, Bible, Talmud, Jewish Concepts, and Kabbalah. Many of our Friday night Onegs will be directed toward education in all aspects of Jewish life and thought.

We want civil liberties for all homosexuals, Jewish and Gentile, and support Gay liberation activities.

WHAT ARE OUR FORMS OF ORGANIZATION AND SOURCES OF SUPPORT?

The Synagogue will be administered by a Board of Trustees, elected annually. Our varied activities will be conducted through committees responsible to the Board.

Our financial support will come from ourselves. In keeping with the true spirit of Judaism, our spiritual teachers and leaders will serve without pay. Others in our community also contribute according to their skills; all serve on a volunteer basis. Our membership dues are supplemented by contributions to cover expenses.

WHO MAY ATTEND OUR SYNAGOGUE BESIDES GAY JEWS?

We are a synagogue and our doors are open to all. Parents, other family members and non-Jewish friends are welcome to our services and activities. Everyone is welcome to stay for the coffee hour after the services and then the Oneg Shabbat. Holiday services and cultural activities are also open to visitors.

Friday night services are at 8:00 sharp; get together at 7:30, casual dress. Services are currently held at Glide, Ellis and Taylor (Ellis Street entrance).

We look forward to seeing you at services.


**Better Business Bureau
Shopping Tips**

We are convinced from past experience that if
you are smart, your Christmas shopping can be
happy, satisfying and profitable. If not, you might
experience the disappointments, heartaches and
after Christmas complaints so often reported to the
Better Business Bureau.

- REMEMBER:**
1. Trade only with concerns known to be reliable or with those whose reputation can be established by intelligent inquiry.
 2. Unless there is a written or provable agreement otherwise, all sales are final - and the matter of a refund or exchange is dependent on the policy of the seller.
 3. Decide definitely what you want before you buy so as to avoid difficulty or delay in take-back, exchange or refund.
 4. Buy with care - Read labels - Be sure of the correct size, color and other requirements. Keep your sales slips or receipts.
 5. It would be best to examine Christmas purchases before Christmas so that any claim for defect or damages may be made immediately rather than after Christmas.
 6. Don't expect that you can bring back to a store after Christmas an article bought before Christmas and get full refund or credit for it if that article has already been marked down - unless the store wants to do so.
 7. Don't try to get cash refunds on Christmas gifts given to you. The fact that you don't like the gift or that you received two or more alike is no reason why any merchant should give you a refund.
 8. Don't contract to purchase anything beyond your capacity to pay.
 9. If you pay an advance deposit on the "lay away plan" or otherwise, be sure that you can and will go through with the deal - otherwise, you may sacrifice your deposit.
 10. Never let yourself be rushed into buying anything by high pressure sales talk; or claim that it is your last chance - take your time and make up your own mind carefully.
 11. Read all papers you are asked to sign and keep a copy.
 12. If you want delivery by Christmas, be sure you deal with concerns that have the facilities to fulfill their promises.
 13. If you find the article you receive is not as ordered - do not use it. Notify the seller

immediately and give him an opportunity to adjust it.

14. Don't buy from advertisers who attempt to discourage you from buying attractively advertised goods but who instead try to high pressure you into something else. That's "bait" advertising.
 15. If you do business by mail order - First make sure you are dealing with a reliable company; allow plenty of time for delivery and write very plainly - printing or typing is best.
 16. No one can continually sell retail at whole-sale prices, so an appeal "Buy Wholesale" is general-ly wholesale bunk.
 17. Transient vendors, sidewalk hawkers and peddlers are not around after Christmas to listen to complaints.
 18. A guarantee should be specific and in writing.
 19. When you know about cases of false or misleading advertising or unfair schemes, report them to the Better Business Bureau. Your name will be held in confidence and your report will serve in the protection of others.
- Christmas is just around the corner, and so are the Christmas peddlers.
