NATIONAL POLICE FORCE GOING INTO EFFECT

Money from LEAA (Law Enforcement Assistance Administration) administered by William Saxbe, the U.S. Attorney General, will become harder for local police departments and cities to get unless they agree to place control of local police units under the control of the U.S. Attorney's office. A giant national computer bank, which was printed in the CRUSADER back in April told you of the coming national police force, and with the latest edict by Saxbe that 'only cooperative or affiliated police departments will be given priority for federal LEAA monies, the article in the February issue of the CRUSADER on CODAP (Client Oriented Data Acquisition Process) has now become full reality.

CODAP "data banks" have been in operation for six months and are located in Maryland and Florida. Agencies receiving federal funds were the first to learn about CODAP and now others have learned about it the hard way.

If you have been arrested, or have had treatment for drugs, etc., your name has gone into this national data bank, and you are listed as a possible criminal. Same goes for those who have been to meetings of organizations considered "subversive", etc. And you can't have your name removed by merely stopping your associations and contacts. So keep on going to those meetings, etc., for you have already been branded baby.





NOVEMBER 5TH ELECTION **GAY VOTE HOLDS KEY TO** BART BOARD ELECTIONS IN 9TH DISTRICT OTSEA, SPOTSWOOD, KIRKWOOD RACE A SQUEAKER

With the November 5th election day deadline so close the BART (Bay Area Rapid Transit Board of Directors race in the 9th District has become the talk of the Bay Area with huge Republican money, tens of thousands of dollars being put into the Kirkwood campaign as the downtown silk-stocking Republicans are determined to elect Kirkwood to the BART Board. On the other side of the coin is Spotswood, whom the Democrats have given token support to, and who has some labor support. But in between these two husky men is a tiny woman, the former administrative assistant to former Congressman William Maillard. Ms. Marion Otsea. Ms. Otsea, the only one SAN FRANCISCO CRUSADER an interview, was quite open about her chances for election, and she said that she needed the votes of the Chinese community and the Gay community if she is to win. She has the backing of the larger groups in Chinatown including former Supervisor George Chinn, and she recently picked up the endorsement of the politically potent GAA (Gay Activists endorsement of several senior citizen

groups and several young voters groups Kirkwood is supported in his race by several noted leaders in the homosexual rights field, one being an official of the Pride Foundation, others with SIR. It is quite amusing that these groups have 'joined hands' with the big oil Republicans to elect Kirkwood, for the big oil interest and silk-stocking Republicans would never even admit to the fact that homosexuals

Spotswood is supported by the vehemently anti-homosexual labor groups whom several GAAers battled with at the Truck Stop some time back concerning the union's harassment of that place. So, it appears that Ms. Marion Otsea, longtime advocate of equal rights for homosexuals will quite possibly win when the votes are tallied on November 5th. The Beardemphl "messiah" trip is bought by many, and we respect the right of anyone to play any role they want, but, as editor of the CRUSADER, I do not have to remain silent about such actions. The people should know that the stage is being 'set" for a "takeover" of S.I.R. next year. And it is obvius who is doing the manipula-

I am deeply sorry that this editorial was necessary. I had nothing to do with the articles in the Sentinel, I had nothing to do with the Castro incident, and I most certainly did not blow it all out of proportion as the Sentinel. I did not create Bill Beardemphl or Thomas M. Edwards.



Wednesday evening, September 25th at the Fellowship of All People's Church, nearly a hundred gaypeople turned out to see and hear the representatives of nearly all of San Francisco's homosexual organizations speak about the activities of their groups. I should say Bay Area, for several

NEARLY ONE HUNDRED

East Bay groups made an appearance also. Greg Schiller, writer and member of the Gay Student's Coalition was the master of ceremonies for the evening and did an admirable job. Leading off the speaking was a representative from DIGNITY, a homosexual Catholic group, followed by Prometheus of Palo Alto, Achvah of Oakland, Alice B. Toklas Memorial Democratic Club which did not have a mailing address or phone now according to their representative, who spoke also for two other groupsthe Golden Gate Business Association and the Community of Concern which is centered in Palo Alto also.

Then came speakers from BROTHER, a newspaper collective from Berkeley; Brothers Behind Bars, one of the three splinter groups formerly known as one Join Hands which did not have a representative; community Guild was represented by Harvey Milk who later spoke as the representative for the CASTRO VILLAGE ASSOCIATION, another merchant's group which Milk states has several non-homosexual members; and then a representative of EAST BAY GAY spoke, followed by a person from the two year birthing newspaper, the GAYLY PLANET. which states they still hope to get out the first issue; he was followed by someone from East Bay Gay Rap; and then a person from the GAY MEDITATION GROUP, which teaches from the group Inner Light Foundation, which is one of the finer spiritual groups; and Jim Stoll of the Family Service Agency/Operation Concern spoke: and the hombshell of the evening. Steve Ginsberg, better known to intimates as the EMPRESS ESMERELDA OF THE FARALONES, who denounced the Empress trip and told of plans to disrupt the Grand Duchess Perry ball at the Bellevue Hotel Ginsberg spoke for a group of which he and a couple of others are members, the Gay Liberation Alliance, NOT TO BE CON-FUSED WITH the Gay Activists Alliance not the Gay Liberation Front, both groups which claim no part of the Empress Esmerelda's group. Finally, HELPING HANDS COMMUNITY CENTER was rep resented by Rev. Ray Broshears who spok of the plight of the disabled, the elderly, and was not in the least the firey Reverence

another side of Ray that none of us had bothered to look at. He was followed by Richard Boyle from GAY RAP, the longest running institution of its kind which meets each Tuesday night at 8 PM at 121 Leavenworth Street; and next came Lavender U. represented by Don Jacobs (Mr. Nice Guy) who spoke of the ever-growing group in detail; then Rev. Jim Sandmire spoke, representing the Metropolitan Community Church (MCC), expressing dismay that he had to wait so long to speak, suggesting that just maybe MCC should change their name to All Saints, then they wouldn't have to wait so long to speak, which drew a few chuckles. A new group called Oakland Gay Men's Political Action Group spoke; followed by Dave Kesti representing Lambda Gay Community Center. Then a representative named Michael spoke on behalf of SF Sex Information Line; followed by Richard Box speaking for a commercial publication. Last but not least was Rev. Robert Humphries, the extremely controversial fund-raising minister of the UNITED STATES MISSIONS who spoke about that group and surprisingly enough (eat your heart out Beardemphly) the youths liked Rev. Humph

All in all, it was an enjoyable evening with most all staying to the end of the event, and sharing together the nice refreshments provided by the Gay Students Coalition afterwards. The Gay Student's Coalition e commended on this event, for it brought together for the first time in the same room without a rumble, some of the most controversial homosexual rights activists in the Bay Area. I note with a sense of discouragement that the Times (9/22/74) continues to give publicity to the "homosexual" who wor ordination as an United Church of Christ clergyman. The Rev. Wm. R. Johnson's decison to permit those responsible for his ordination to pass judgment on the moral character of his private sex acts as respects his fitness for the ministry was misguided. The incident was a set-back in the long and continuing fight to expand the right of sexual privacy. If a man's private sexual conduct is made an issue in determining his fitness for responsibilities unrelated to sexual matters the correct response is: "None of your business." Many successful lawsuits have been argued on this principle -particularly in regard to protecting the rights of teachers and civil servants. Similarly, the important issue of William Johnson's fitness to perform clerical functions should not turn on an assumed relationship between those functions and consensual

Discrimination in housing and employment, etc. based on the notion of a collective homosexual identity is ridiculous. There is no definitely, definable and distinct group of human beings as "homosexuals" to discriminate against. The work "homosexual" describes sexual behavior and choices rather than people. Thus, it has always been tacitly understood and generally accepted that a certain percentage of the men who serve God are "homosexual"-just as they are in other walks of life.

The Rev. Wm. Johnson is to be criticized for submitting his sexual behavior to ecclesiastical scrutiny and approval, if it was his intention to strike a blow for sexual freedom. It was, in fact, an act of personal weakness. Sex is a matter of private conscience that needs no official endorsement of any sort. We don't have to qualify for the right to decide what kind of sexual practices we will or will not engage in. or what techniques we will use.

LACK OF DISCIPLINE IN YOUTH LEADS TO DRUG ADDICTION?

An article in the National Observer by Jack Cook stated that the home links to addiction are elusive, and that there is a most definite link between non-drug addict

ion and good strong up-bringing. This came as a result of a survey by Forest S. Tennant, Jr., a physician who is working for a doctorate at UCLA. Tennant took his survey from a study of 5,044 soldiers, averae age 21, in West Germany while he was in charge of the Army's drug-abuse program in Europe. He asked the soldiers about their use of drugs and alcohol, and correlated their answers with responses about their participation in more han 100 kinds of "antecedent" behavior. He asked all about their childhoods, and the resulting answers were more than interesting to the SAN FRANCISCO CRUSADER. For the CRUSADER, serving a City with a sad reputation in the area of drug abuse and alcoholism, can relate to the findings as a result of the work in the area of combatting drug abuse by the Helping Hands Community Center located in the Tenderloin.

One of the findings was pretty well forgone as far as this writer is concerned. that being that such activities as participa tion in 4-H Clubs, Boy Scouts, Hi-Y, etc., was common amongst all the service personnel, but...the big finding came here, that being that amongst those who went to church regularly as a youth, and who worked around the house, doing regular chores, and had an occasional swat across the ass for acting up... this particular group had only 5% who were ever users of drugs, or who used alcohol to an excess.

Now, this long confirms the findings of this writer, for this has almost always been the case in each individual that I have counselled. And now, some of the "biggies" are arriving at the same findings.

Belief in God, attendance at church, and doing chores around the house as a youth, in plain words, a good old-fashioned Godloving upbringing, makes for a very good person when they grow older.



HELPING HANDS CENTER



Elliot Blackstone, action sergeant with the Police Community Relations Unit of the San Francisco Police Department is forever in a series of crises during his last few months as a police officer. Blackstone is due to retire April 10, 1975 and his foes within the Department, namely one Captain William O'Brien, are trying to oust Blackstone from his soft-desk job in Community Relations. O'Brien wants Blacksone out in a district station, walking the beat. And with the size of Elliot's tummy, the walking would do him good, but, he is still somewhat effective in his role as the cop to the homosexual, transsexual communities of San Francisco. He is only partially effective due to his 'outside' interests, namely trying to hold onto the acting sergeant's post which Elliot says will give him an additional \$70 a month retirement pay, and his concern over his 'no-tell' motel operation. He has failed to give his undivided attention to the problems confronting the community for well over two years, and thusly, relations between the police and the community have fallen into disrepair, witness the sad incidents that have taken place in the Castro, the Tenderloin, and the ever-increasing problems of Polk Street, which has become the "new" jaded meat-rack of San Francisco, replacing the Tenderloin in that market, also in the sale of hard drugs as well. Blackstone's obsession with his own comfort after retirement can be understood in one light, but in another, it cannot. For time and time again, various community have tried to get Blackstone to begin training a replacement. One that was found acceptable was Chris Weld, an officer who worked in the Chief of Police's office, but Blackstone soon found him "unacceptable" for Blackstone, always being the center of attention at Tavern Guild meetings, etc., did not like the attention paid to the much much younger. slimmer and handsome Chris, and so Blackstone then made a "ruling", unofficial of course, that a nice looking cop would not make a good cop to the homosexual community for he might be "tempted" by

people due to his good looks. This decision by Blackstone was outrageous! It was an insult to the homosexuals of San Francisco and furthermore, an insult to Chris and to any decent looking, slender cop on the

Then in the late spring Blacksone found a chubby cop, who was not very nice looking, and who had been detailed out into the "bushes", and had a most undistinguished record as a police officer. This person, a person who has worked in the Intelligence unit, gathering data on different people

Blackstone wants to force upon the homosexuals of San Francisco, one Ray Carlson. Ray Carlson appeared at a community meeting in the Tenderloin, and most every question directed at him was handled by Blackstone, if it proved embarassing. Carlson would by his very attitude cause considerable trouble between the police and the community. This we do not

Many many officers have come forth to seek Blackstone's job, but he has rejected them all. And now, after a long search, an independent caucus of activists have come up with a cop that is a very busy cop, a hard working cop, one who would not be dearly loved by the public-sex homosexuals, for he has arrested more of them than any other cop in San Francisco, but, never once has be abused any person, either physically or verbally. Never once has he "entrapped" anyone, and never once has he taken a bribe. That is why the caucus has selected him to be presented on a trial basis to the Community Relations Unit, to see if he would work out as a replacement for Blackstone. His name? Officer James Hennessey, of the Mounted Park Patrol. Officer Hennessey has made all his arrests while uniform, and has never been accused of "entrapment". And he is not one bit different than Blackstone in the area of "white-lies", but he is a lot different in that he understands the various homosexua communities far better than does Blackstone or Carlson. Carlson had never ventured into the Tenderloin until a week or two ago, and only because he was detailed to go to a meeting by his commanding officer,

Rodney Williams. And, Officer Hennessey has excellent rapport with various District Attorneys, with all of the district stations, has great respect from all police officials, something which Blackstone cannot lay claim to

Hennessey wants to serve the citizens of San Francisco, and wants to create bridges of understanding and communication be tween all police officers and the various homosexual communities as well as the other sexual minority groups. He unlike Blackstone would not become tied to the 'apron strings' of the Tavern Guild, but

would work with all groups and individuals. But, Officer Hennessey is opposed by Blackstone, even tho Blackstone says he

It is time that the San Francisco Police Department put a cop into the post, possibly two cops, of working with the communities involved, and it is important that the cop not selected by Sgt. Elliot Blackstone, for Blackstone is of another era, an era of gayola-payola, and shake-downs, and we need new forward thinking, and anyone Blackstone chooses cannot be anything but another "cave era" person. And we need a cop that does not play hanky-panky with the intelligence unit. The cop for the community is obviously Officer James Hennessey and possibly Officer Chris Weld also. Two cops are needed now! Think it over, write to the department, and your "elected" officials,

I QUESTION

A letter dated January 15, 1974 from the Family Service Agency states that they have a "new staff position...homosexual counsellor". That sounds fine, and if you listen now in October 1974 to that counsellor, Jim Stoll, you would think that the Family Service Agency is doing something wonderful for San Francisco's homosexual community. IT IS NOT! The fact of the matter is, that homosexuals are paying Jim Stoll's salary and not through UBAC (United Bay Area Crusade) which funds the Family Service Agency, but through Operation Concern. In plain words, homosexuals are having to pay Family Service Agency to ALLOW a homosexual counsellor on the staff. Why does not the Family Service Agency pay for such a counsellor through UBAC funds? Because they have found a "sugar daddy", that's why. Stoll claims that an agency such as this needs a "professional" counsellor, maybe, but Stoll would be better off, paid by Operation Concern, to be stationed in either S.I.R., Golden Gate Gay Liberation House, or Helping Hands Community Center.

Is Operation Concern all that "concerned that they will pay money to a straight Agency, which is funded by UBAC which means money from homosexuals anyway through various fund drives? Operation Concern is an unusual operation, and before the past year, many wondered where the money went, no one knows for sure. But, Operation Concern could do no beter than to support their own agencies which are struggling to get along. Recently, 'emperor' Marcus said he was raising funds for Golden Gate Gay Liberation House, Gay Rap and Acceptance House for Alcoholics, all three worthy gay projects of tremendous assistance, then Marcus, a major member of Operation Concern, one of the main-men who put together Circus-Circus, suddenly changed his mind, or had it changed for him, and decided to give the money to Bob Ross's project called Tavern Guild FOUNDATION Community Center. Shame on Marcus! First he backs a loser for emperor and now he stabs Golden Gate Gay Liberation House, Acceptance House and Gay Rap in the back. Where is all the "unity" Operation Concern officials preach now?

Based upon the performance of Operation Concern to date in giving financial support to non-gay projects, ignoring the plight of their homosexual sisters and brothers, the Crusader must ask this question, "Is Operation Concern concerned with the homosexual or with tolerance of their being homosexual?' LEGAL **SUPPORTING**

This is a bill to repeal sections 286 and 288a of the penal code

Section 286 provides that "Every person who is guilty of the infamous crime against nature (sodomy)...is punishable by imprisonment in the state prison not less than

Section 288a provides that any person participating in an act of oral copulation is punishable by imprisonment in the state prison for not exceeding 15 years, or, by imprisonment in county jail not to exceed one year; provided that if defendant is more than 10 years older than a coparticipant who is under the age of 14, or that if force, violence, duress, menace, or threat of great budily harm was used, imprisonment shall be not less than three years.

The statutes apply to all acts of oral or anal copulation, irrespective of the sex or situs of the participants. Thus the statutes punitive reach embraces not only foreplay in public (People v. Hansel (1965) 233 CA2d 834) and private homosexual contact between consenting adults (People v. Earl (1958) 216 CA2d 607 [hotel room]), but also prohibits oral copulation between married couples. (People v. Doggett (1948) 83 CA2d 405 [obscene pictures].)

The time has come to repeal these statutes, for a number of reasons: 1. Repeal of sections 286 and 288a will

remove the State from the bedroom, where it has no business to be.

The statutes appear to be a clear invasion of the federal right of privacy guaranteed by the Fourteenth Amendment of the Constitution, insofar as they prohibit such sexual activity between married couples (Griswold v. Connecticut (1965) 381 U.S. 479 [prophylactics]) and between unmarried men and women. (Eisenstadt v. Baird (1972) 405 U.S. 438 [prophylactics]; Roe v. Wade (1973) 410 U.S. 113 [abortion of unmarried womanl)

The rule of privacy announced in these cases would also extend to homosexuals. (see 2 Pacific Law Journal 206, 221-223

3. On November 7, 1972, the electorate of the State of California approved a referen-dum to add "privacy" to the list of inalienable rights guaranteed by section 1 of Article I of the California Constitution Private consensual acts denounced by sections 286 and 288a, whether by married or single heterosexuals or by homosexuals, would now seem to be protected by the express provisions of the California Constitution relating to privacy for the same reasons that they are protected by the implicit 'right of privacy' under the federal Con-

4. The above interpretation of the California right of privacy enactment is indicated by Supreme Court decisions that have given "repeated acknowledgment of a right of privacy' or 'liberty' in matters related to marriage, family, and sex (People v. Belous (1969) 71 Cal.2d 954, 964 [abortion]); and by the Court's specific recognition that the State must not arbitrarily impair the right of a homosexual "to live his private life, apart from his job, as he deems fit" (Morrison v. State Board of Education (1969) 1 Cal.3d 214, 239).

5. Despite the apparent unconstitutional ity of sections 286 and 288a respecting private sex acts, it is improbable that a successful challenge can be made in the absence of an actual arrest in the privacy of the home followed by conviction-an unlikely event in view of the search and seizure exclusionary rule. (See SIR v. Nelder et.al. (D.C.N.D. Cal. 1971) No. C-70 ACW [admitted homosexual lovers who fear arrest for private acts have no standing to suel.) Legislative action, therefore, is the only practical means of removing teh unconstitutional taint of these statutes.

6. These statutes, even though unenforced against private consensual acts, have serious consequences for the homosexua These include the following:

a. The statutes substantially inhibit the ree choice of occupation of many homosex uals by denying them eligibility for federal civil service employment and service in the armed forces. The provisions of sections 286 and 288a have been exclusively relied upon by the Department of Defense to justify denial of security clearances to employee of civilian contractors, on the ground that violation of these state laws evidence an insouciant attitude toward all laws! (See In Re Allan Lewis Rock, OSD Docket No. 72-109, Industrial Security Clearance Review Office, Western Field Office, Office of Assistant Secretary of Defense.)

b. The possibility of arrest and prose-cution is a constant threat that hangs over the heads of all homosexuals. Although the search-and-seizure exclusionary rules make conviction unlikely, the very fact of arrest would leave an indelible blot upon the individual's record, and have severe social and economic consequences.

Examples of the growing recognition that homosexuals are entitled to the same civility of treatment and equal rights under the law as any other minority group include the following:

a. Homosexual organizations are entit led to incorporate under State laws, ever though their private sexual activities ar contrary to State law. (See Owles Lomenzo (1972) 38 App.Div.2d 981, 329 N.Y. Supp.2 181.) Among the many incorporated homosexual organizations in this State are the Society for Individual Rights, The Pride Foundation, the Whitman-Rad clift Foundation, and Daughters of Bilitis b. Many universities throughout th

State have now granted recognition to gay organizations. Recently, the Gay Law Stu dents Association was registered on the Campus of Hastings Law School.

c. The Pacific Telephone Company ha officially acknowledged that homosexual organizations are entitled to advertise in the Yellow Pages of the telephone directory (See Society for Individual Rights, Inc. v. P.U.C., (1971) Cal. Supreme Court No. S.F. 22803; see also September, 1974 San Francisco Telephone Directory, p. 74)

d. On April 17, 1972, the San Francisco Board of Supervisors amended City Ordinance No. 261-66 to provide that all contracts negotiated by the City shall contain a provision obligating the contractor "not to dis criminate on the ground or because of race, color, creed, national origin, ancestry, sex or sexual orientation, against any employee of...such contractor..

e. Homosexuality is not a bar to the practice of law in California. Thus the Committee of Bar Examiners has expressly declared that:

'Publicly affirmed homosexuality does not in itself preclude a person otherwise qualified from being admitted to the California Bar." (See letter dated November 14, 1972, by Ruth Hawksley, Assistant Secretary, in response to in-

13. Repeal will not remove the criminal sanctions against public sex acts. Sexual conduct in public and other anti-social conduct such as loitering in public toilets for lewd solicitation will continue to be punishable as misdemeanors, and child molestation will remain punishable as a misde-meanor or felony (See Penal Code sections 647(a), 647(d) 647a, and 288.)

14. As a practical matter, "Public displays of adult consentual homosexuality are currently treated by the courts in all but exceptional cases, as a nuisance meriting only misdemeanor sanctions. This judicial practice is a response to the inappropriateness of the present statutory system." (The Consenting Adult Homosexual and the Law 13 U.C.L.A. L.Rev. 644, 793-794 (1966).) Removal of the felony penalties will allign the statutory law with the reality of judicial practice, and prevent occasional abuses of the statute that inevitably will occur so long as the option for draconian punishment remains available. (See Peopel v. Drolet (1973) [prison sentence for oral copulation by woman in stage skit, vis-a-vis jail term if instead she had engaged in vaginal inter-

course on stagel.) 15. The statutory penalties constitute a denial of equal protection under the law with respect to public sexual activity. Presently, homosexuals arrested for public acts are subject to ferocious prison sentences under section 288a [maximum 15 years] and section 286 [maximum life], while heterosexuals at most face a sixmonth county jail term. Repeal will elimin-

ate this unjust and irrational disparity. 16. The statutes also deny equal protection of the laws with respect to private sexual activity, in that intercourse between

N.C.L.C. [NATIONAL CAUCUS OF LABOR COMM ALIAS THE U.S. LABOR PARTY ATTACKS **P&F CANDIDATES**

The U.S. Labor Party here in San Francisco, headed by one time gaymilitant Nick Benton, has made threats against the Peace and Freedom Party in general, and towards local congressional candidates in particular.

Benton denies any responsibility for such action by others in the U.S. Labor Party, but the attacks threatened have not as vet materialized. In return various P&Fers have vowed a physical battle to the end with the U.S. Labor Party (NCLC) whom they claim are actually working members of the CIA, in aan attempt to destroy other political groups so that Rockefeller's Republicans can run

A P&F spokesman said that the U.S. Labor Party attacks Rockefeller as a disguise to give him publicity, sympathy, and to give the general impression that the radical left is out to "get Rockefeller", thus creating a backlash against the REAL radical left. Several P&Fers have charged that the fake-socialist group which is trying to destroy P&F from within is a part of the U.S. Labor Party (NCLC). This view is gaining in support with various movement

A P&Fer said that if NCLC wants violence they will get it in a very heavy way, a way that they never had before. NCLC wantonly attacked unarmed members of the Commu nist Party USA in their offices, innocent women beaten nearly dead by the sick CIAers of the NCLC this past winter in New York City. NCLCers have since made physical attacks upon others in Detroit, Seattle and Boston. Here in San Francisco. minor skirmishes have been reported, and such tacky tactics as opening vending boxes of CHALLENGE, COMMON SENSE, and other such publications, and placing their publication "Solidarity" in front of the regular newspapers. NCLC of course denies this nazi tactic as well, but this is typical of CIA agents,

heterosexuals, whether married or unmarried, is not a crime, but homosexuals who experience private sexual relations are guilty of a felony. The California statutory scheme, by permitting only heterosexuals to engage in lawful acts of copulation, violates the principle that homosexuals may not properly be held to higher degree of moral conduct than are heterosexuals." (Vallerga v. Dept. Alcoholic Bev. Control (1959) 53 Cal.2d 313, 319.)

17. Under sections 286 and 288a, every mosexual is effectively branded a felonat-large; we wears a "badge of infamy" that fixes upon him "the stigma of an official defamation of character." (Norton v. Macy (D.C. Cir. 1969) 417 F.2d 1161,1164; Morrison v. State Board of Education (1969) 1 Cal.3d 214,239.) Thus these laws, by their very existence, exact a terrible psychological toll, no less so than the "jew badges" of the Middle Ages, the pernicious "separate but equal" doctrine applied to Negro school children, and the long history of intolerance and oppression experienced by Catholics in this Sate and nation in the 18th and 19th centuries. Obviously, no individual can relate optimally in a society that denies or condemns relational sexual expression. But the homosexual, to achieve sexual fulfillment, must commit a "crime", while his heterosexual counterpart, no matter how licentious he may be, commits no crime by his fornication. In effect, sections 288a and 286 relegate those homosexuals who would live within the law to the Spartan alternatives of asexuality or masturbation. Consequently. homosexuals, in order to satisfy what to many is a natural sexual function, must engage in furtive, felonious copulation, with all its negative psychological consequences. including, in many instances, feelings of self-hatred, guilt and inferiority. (See Barnett, op.cit., pp. 7-8, 20 [note 40], 22-222; Geis, "Not the Law's Business?" pp. 48,

Repeal will help to remove the opprobrious cloud, and permit each individual to be solely judged on his intrinsic merits and ability, not on the basis of private, harmless sexual conduct.

SAN FRANCISCO MINISTER **REFUSES TO TESTIFY AT** TRIAL OF ATTACKER **DISTRICT ATTORNEY** OUTRAGED-

In early June, the Rev. Raymond Broshears was viciously attacked by a drug-crazed balck youth by the name of Marshall Hopkins in the Center operated by the minister. The minister had told the youth he could no longer come into the Center due to his "holding" of dangerous drugs. As the minister turned his back to go into the office, he was jumped from behind by the youth, also known as "Jo Jo", and "Peanut Butter", who proceded to batter Broshears badly as nearly a dozen queens sat by; Broshears was beaten into near unconscious-ness until Harlan Shrader (Rebel) picked up a club and knocked the hell out of the youth The injury to Broshears resulted in agravation of a serious bone disease which Broshears has, and in early September he entered the hospital for surgery to try to correct the matter. As a result of the beating, Broshears had to have all of his teeth removed surgically as well. And a few days after his release from the hospital while still in a very weak condition, Hopkins tried to jump Broshears from ambush near the Mind Shaft, but the effort was stopped by part-owner Pat McAdams who saw Hopkins slink into the darkened doorway to wait in ambush.

Broshears had already refused to testify against Hopkins and he does not believe in legal maneuvers of that nature; and as was pointed out by a "friend" of Broshears, most of the witnesses to the incident had already moved by the time the police and district attorney bothered to do anything towards prosecution of Hopkins. Friends of Broshears who viewed the attempted ambush by Hopkins have vowed to "talk" to Hopkins about life insurance, etc., but Broshears asked them to leave him alone, saying that Hopkins was not quite responsible for certain of his actions.

As a result of Broshears refusal of the

subpoena to testify against Hopkins, he has a reprieve on life, but the District Attorney told the judge, "he'll be back". Broshears when told of some foul language attributed to him by the DA said that the DA like his boss Ferndon is a lying ass, and said he would send a letter of explanation to Hanlon the judge.

The police expressed dismay that Hopkins got away again, but the inspector present told the reporter that Hopkins will 'inside'', "it's only a matter of when

Broshears said that he feels sorry for people like Hopkins who do not have the ability to understand, but only have a "dog-eat-dog" jungle-survival attitude. Broshears pointed out that Hopkins is a friend of the owner of the Sanctuary, who has a very big bad-on for him.

GAY RIGHTS

On Thursday night—Friday morning of November 7-8, the Tomorrow Show, hosted by bigot Tom Snyder, presented an hour long look at "Chickens and Chicken Hawks" as presented by host Snyder and a guest of ill-fame in Los Angeles, Paul Mace.

Mace was accompanied by a 16 year old confessed? male prostitute who said he had been doing "it" for two years. Also on the program was a Roman Catholic priest along with an illiterate 14 year old runaway from Texas, and the Priest, Father McGuiness told how Christ Jesus could save the youths from homosexuality, but, the poor priest must have been shocked when the boys both said that they enjoyed doing "it", and didn't really want to change. Both of the boys were "male Lolitas" according to one Los Angeles observer.

Mace is a "sugar-daddy" and a chickenhawk himself according to numerous Los Angeles people with whom the Crusader spoke after the program, and that Paul Mace ran an operation called Buelahland, a "drop in center for runaway boys" (what about the girls?) until it went broke last year. Mace now claims that he heads us a new operation called Genesis House which is also for runaway boys "chickens", and has a "foundation" called the Hans Christian Andersen Foundation.

Mace, well known along the Hollywood and Selma circuit by the youths in Hollywood, has a young man who is 18 as his "lover" as well, "other lovers." The age of 18 is still most certainly "chicken" in case Paul Mace, formerly of U.S. Missions, was not aware of it. (U.S. Missions director Robert Humphries disavows any connection with Paul Mace, stating that they had once

The cause for the program according to host Tom Snyder is the upcoming book, an expose of the homosexual community, which will deal with this subject of "chickens and chicken hawks.'

The book, written by an associate of Tom Snyder, a huge man by the name of Robin Mansell Lloyd, has been purchased by an east coast publishing house. It is generally feared that the book will cause much greater trouble than did the expose-minded book, Boys From Boise which caused much numerous people to kill themselves, and others still to this day, are in mental hospitals, and others lost homes, businesses and families, all due to this thoughtless book. The Robin Lloyd book would have a far more devastating effect, and could destroy the lives of many well-known Hollywood figures as well as several government employees, not to mention certain closet-type gay leaders-figures. The book should not be published as it most certainly has no good redeeming values to it except to the queer-

But, back to the Tomorrow show, for all through it, not once was the fact that Paul Mace is a practicing homosexual ever mentioned. And also the fact that Buelahland was staffed by homosexuals, this too never came up. Mace seemed bent on exposing one of the sorest points in the homosexus world. And never once was the fact that only a very minute portion of the homosexual world is involved with young boys, ever brought up, for the show gave the appearance that all homosexuals are boy seducers.

And it has been pointed out by various who viewed that this show can and most possibly will be used against any arguments for passage of sexual law reform. The show was vile, chock full of lies and distortions, and the young 16 year old punk who sung like a bird on his former benefactors who obviously paid the little bastard too well, is discredit to the human race in general. Rat-finks are never very well liked and this 16 year old rat-fink shall be exposed, picture, story and all, in the next issue of the Crusader, so all will know to treat him like the leper he truly is.

And as far as Paul Mace, this show, his participation in it, is unexcusable, and Paul Mace too must be treated like the stoolie that he is, and for the tremendous setback he and his 16 year old "friend" have given the gayrights movement. There are some things which should be left unsaid.

BLACKSTONE OUT!

COP TO HOMOSEXUAL COMMUNITY REMOVED FROM POST...SGT. ELLIOT BLACKSTONE TRANSFERED TO MISSION STATION BEAT...UPROAR BEGAN BY GAY ACTIVISTS ALLIANCE [GAA] ON HIS BEHALF..RACISM CHARGED WITHIN POLICE DEPARTMENT

At an emotion charged press conference held Friday November 15, at Helping Hands Community Center, the Rev. Raymond Broshears charged the San Francisco Police Department with using racist tactics to try and gain public sentiment in the Department's running battle with Third World police officers, represented by the Officers for Justice.

The Department had transferred Blackstone from the Police Community Relations Unit to Mission station stating that there was a shortage of police officers due to the law suit by the Officers for Justice, which came about to bring an increase in the amount of Third World members of the Department, which now number 127 in a force of over 2000 officers.

Broshears, joined in the conference by Officer Jessie Byrd, president of the Officers for Justice, and Rev. Bob Humphries of the U.S. Missions and Carol Lynn, noted entertainer in the gay community of San Francisco, all charged the Department with racist hiring policies. Humphries told of the tremendous amount of help Blackstone has been to the Gay community, and that his transfer at this time before his replacement had been trained deals a serious blow to the communication between the Gay Community and the SFPD.

Rev. Humphries' charge was denied by the wealthy bar owners, and other elitist Gaypeople who boycotted the conference, as most of them supported the ouster of Blackstone. S.I.R., Tavern Guild, Pride, Golden Gate Gay Liberation House, Daughters of Bilitis, Lesbian Mothers, Join Hands, and Gay Students Coalition all failed to send representatives or to participate in the conference.

Officer Byrd told the newsmembers present (K.G.O.-T.V., K.G.O. Radio, K.C.B.S., K.S.A.N., and others), that the Officers for Justice lawsuit has not created a manpower shortage in the Department as the administration charges, that the Department could hire men to fill the vacancies now on a limited tenure basis, but that they did not want to do so, as they are trying to build public pressure against the Officers for Justice to call off their lawsuit.

The coalition which Broshears headed then announced their full support for the Officers for Justice lawsuit against the hiring policies of the San Francisco Police Department and reaffirmed their solidarity with Third World liberationist groups.

FOR JANUARY 6TH The Redwood City trial of the two San Franciscans arrested for the kidnap and castration of a 16 year old hitchiker has been

set for the first of 1975. Rudy Brink, 18 years old, and William E. Johns, 35, have told reporters they would appeal Judge Gerald A. Ragan's decision to forbid the moving of the trial from San Mateo County, as the attorney for the two felt that the jury would be prejudiced. Judge Ragan said that the crime would "shock people wherever they are." The media has referred to the two defendants as the "mutilation bandits.

Brink and Johns both maintain innocence of the alleged beastly act, but the youth has made positive identification of the two. The 16 year old is undergoing treatment which will allow him to live a nearly normal life, according to the doctor attending the case.

Information from a confidential source has let the Crusader know that Johns has been hositalized in the state of Oregon many years back for an act somewhat similar to the sick act committed on the 16 year

Meanwhile, as investigations continue in San Francisco and San Mateo into the background of the two accused mutilation bandits, more and more reports come into the office of the Crusader concerning the two, and we are checking them out.

An elderly apartment building manager in the 300 block of the Tenderloin, who is a bit strange, has told a group of youths staying at the Y.M.C.A. a story which has led to a libel slander suit being brought against him.

A thorough check by the police at the request of the slandered person, has revealed that the person slandered has been working closely with San Mateo County sheriffs authorities to bring about a conviction in the
