

The recent city strike was a most revolutionary act in many ways. It certainly has shown the elected officials of this city that no longer do Joe Belardi, president of the Labor Council, and John Crowley, secretary of the Labor Council, have the great influence they would like them to believe they have over the rank-and-file workers. John Squires, the super-minority (18 per cent of the vote) elected president of the Muni Railway workers, will never be reelected after the Alioto-like tactics he used during the strike. Mr. Squires and Ms. Supervisor Feinstein have good rapport, so Squires as you can see is a fast man, covering all the bases of the bosses, but Squires, like Crowley and Belardi, has forgotten to keep in touch with the rankand-file workers, and thus has little influence with them. This strike was settled without them; it was settled by a 20-person rank-and-file labor committee, and for the first time in years the rank and file came out with some fairly substantial gains. But alas, the janitors, the hospital workers, etc., are still at the bottom of the ladder. They are the real workers, they do the hardest work, yet they are still at the bottom. If the rank and file had not seized this strike away from the likes of Crowley, Belardi and Squires, the hospital workers would have received very small gains. Now that the strike is over, the time has

just begun for the rank and file to organize into worker caucuses and to overthrow the likes of Belardi, Crowley and Squires and let the big businesses as well as the big politicians know that it is the rankand-file labor caucuses that they will have to deal with in the future, and not John Crowley and Company.

The rank-and-file worker is being heard from all over America for the first time; union bosses are being tossed into the ashcan where they belong, for it is the workers to whom the world belongs, and they are beginning to awaken, yes, the great slumbering giant, the rank-and-file worker, has awoke and is beginning to move, the earth trembles. The time for one big union, a rank-and-file controlled union, is

RACISM AND SEXISM CHARGED AT LUXOR CAB By Gaylen O'Brien

Luxor Cab, a company of independent cab owners, has been charged with racism and sexism by various minorities and a complaint has been filed with the Human Rights commission.

The Gay Activists Alliance has filed a complaint with the HRC concerning the lack of black and women drivers at Luxor

Luxor Cab president Bill Lazar has stated that the company is merely a coordinating body, that they own no cabs, that each cab is owned by an individual and that they cannot make any of the individual owners hire a black driver nor a woman driver. Luxor, he stated, would go out of business if they tried to make the independent owners hire blacks or women. Yet the facts remains to many that this is merely another way of avoiding integration. A GAA (Gay Activists Alliance) spokesperson stated that "What Bill Lazar and Luxor are doing is merely another way of avoiding integration, much like the various school systems which dissolved and sold the individual schools to individuals and operated them as private schools in order to avoid integration.'

The GAA called upon all Gaybusinesses in San Francisco to withdraw their accounts from Luxor Cab in solidarity with those who have been discriminated against in employment by the independent cab owners at Luxor.

One GAA spokesperson said that "Due to the high amount of racism within the Gay business scene in San Francisco, it is doubtful that the Tavern Guild will request any members to withdraw from Luxor Cab.

The GAA is now investigating De Soto and Veterans Cab for failure to abide by the Equal Opportunity Employment code. Meanwhile, the GAA asks all humanbeings to not use Luxor Cab, to use other cabs, if they believe truly in justice, freedom and equality.

RAPE . . . DOESN'T ANYONE CARE?

Rape... a word that sends chills of horror into the hearts of most women.

Rape...a word that sends laughter through police station locker rooms. Rape . . . a word that most do not truly understand the meaning of.

If a woman is raped, calls the police, the police treat the woman-the victim-far worse than the savage rapist. Most police have little understanding of the situation, nor do they want to understand. All they can do in their best sexist-sadistic way is question the victim, in ways that no human should be questioned. Rape is a most traumatic tragedy. When you mention that a person has been raped, the usual words you hear are, well, she was asking for it," or "hell, just look at those buns, she really enjoyed it," or "the guy sure had good tastes," or "wish I could get a piece of that action," or "hell, you can't rape the willing, and all women want it," or "there's no such thing as rape." All of these are typical male macho statements, true sexist pig attitudes that are shared by the overwhelming majority of men-insecure men, who for the most part can't cope with their own frustrations and take a sick delight in hearing or reading stories of rape.

The medical profession is only a couple of steps above the police in their heartless treatment of the rape victim. Very little good can be said for the medical profession. What can be done about rape, you ask? Well, education is a very important step. Getting men to deal with their sexist role-playing, and educating them to cope with the doubts and fears that haunt most men concerning their masculinity. The macho-male image that has been created by the Bible, the church, and by Hollywood fast-buck artists who continue to promote sexism via the films.

San Francisco has a higher percentage of rape cases reported each year than any other major city in Amerika, and God only knows how many women did not report their tragic plight to the blue-sexists. Why is this so, many ask me, and the only answer that I can come up with is that due to the extremely high Gaypeoples population here, the heterosexual males are insecure, the majority of them; so, even with all the seemingly easy-to-come-by sex here, they in their doubt, their fear, their frustration, seek out the woman, to beat her, to rape her in order to reassert their masculinity. The haunted heterosexual must do it violently, in order to prove that "he has what it takes." This is like the opposite of "queer bashing," which is the haunted heterosexual who will attack for no seeming reason, a homosexual, and beat him senseless, as this, to the mind of the haunted hetero, reasserts his mythical masculinity.

But, thus far, I have spoken only of rape in relation to women. But did you know that rape of men by men, in our own city of San Francisco, and not inside the jails, but right in the alleys, baths, beaches, parks, bedrooms, is becoming too commonplace? Yes, it is for a fact. And what of the male who is raped by another male, what can he do, who can he turn to, who can he ask for help? The police? . . . hell no, for the cop will say, as they say with the women, written above, and also will add, "Well, this is another typical hustler situation, and the guy simply beat the shit out of him, rape hell!" Oh yes, the plight of the male rape victim is just as tragic as the plight of the female rape victim, but in many ways it is more horrible, as you will find few homosexuals who will admit that there is such a thing as male raping male. The only Gay group to deal with this in detail thus far has been the GAA, through the Helping Hands Community Center. And we find the so-called friendly police community relations cop just as evil as the others, for he too snickers and disbelieves. Even when we have them come into the Center bloody and beaten, the police write it off as a "mugging" and do not examine for rectal lesions and other internal damage. And too, we have another type of rape that is not done with the penis, that being "fist-fucking." Yes, you heard right, this is some kind of new faddishfetish that has killed. I cannot comprehend someone sticking their hand-fist and arm-up someone's ass! That is a sickie for sure! And then what of the psyche of the person on the receiving end? Who knows! But, this fetish of "fist-fucking" has led to several cases of "raped-fist-fucking," and it has ended in death in some cases. It is much too much to cope with in this article now, but we shall go into it in depth at another time.

But what is the problem right now, why can't rape victims be treated with compassion and understanding? Well, we have explained that already, so now we need a solution. There is none in sight, except that a committee of concerned persons involved in Human Care Services may get it together and work to create a city-wide rape-control/education and assistance to the victim program. At least we can hope this will come about and soon.



But the dam is about to break, Ma Bell is giving every indication that they will capitulate to the demands of the Gaypeoples who have worked so many years on this, spending thousands of hours and much money to end this discrimination against

It was one year ago on Good Friday that the Gay Activists Alliance (GAA) began their 52-week offensive against Pacific Telephone without the support of any other Gay groups in San Francisco, so now, a year later, the same sad situation of discrimination exists, so the GAA shall launch the second 52-Week Offensive against Pacific Telephone, and again, without the support of any of the other Gay groups in town. We have filed employment discrimination complaints against PT&T, yet not one word of it in the Gaypress, but when the Pride Foundation (we're in the money!) group does one angle paper trip, the Bar and Advocate both go wild. Yet GAA zaps have received little or no coverage, and that is why the GAA calls once more upon those independent Gaypeoples who will not be mesmerized by Pride, Tavern Guild and MCC, to join with us on Friday, April 12th, at 12 noon, at 666 Folsom Street, the PT&T employment offices, to hold a mock crucifixion of a Gayperson upon a telephonepole cross. There will be speakers, music, and much to show Pacific Telephone what we think of their employment discrimination policies.

COPS SHUT DOWN AFTERHOUR LEGAL OPERATION ON POLK ST **GAYOLA PAYOLA** SHAKEDOWN TRY?

Officers from the Northern Station of the San Francisco Police Department came into the Havoc House, which has been remaining open after 2 a.m. until 6 a.m. on Fridays and Saturdays, and shut them down, even though they have all the required permits.

Captain Joseph Flynn, aspiring Chief of Police, had ordered shut down earlier, in violation of state law, the Sack Dance Academy, Flynn and Lockwood and Dumas, the three "bustkateers" who seem bent on outdoing the high-priest of moralty. Captain Shaughnessy, have ignored state laws at the very bad advice of David Roache, legal-eagle of the SFPD, and shut down the Sack Dance Academy of Ray

Now, the Havor House, which has every permit necessary, dance, entertainment, afterhours, cabaret, and what have you, has been shut down by the "three bustkateers of morality." The Shed out on Market Street also has every legal permit going and were busted also, some time back, yet finally won the right to remain

The mayor of San Francisco and the hief of police defied the courts in the recent strike, showing no respect for the law, and now the "corruptors" have gone even further.

TO ASSEMBLY COMMITTEE: CLASHES WITH GAY MILITANT **OVER BESTIALITY**

Professor Walter Barnett of Hastings Law School in San Francisco was one fifteen San Franciscans who journeyed t Sacramento to testify concerning Senate Bill 39, a penal code revision bill that has passed the Senate and is now before the Assembly Criminal Justice committee.

While the main issue was opposition t the bill in general, and in particular the section 9310, which deals with homosexuality and keeps it a felony, but using the word "homosexual" and dropping the former words which were used, "oral i copulation" and "sodomy." While most all who testified were against this change which would legalize "deviant sex acts' between members of the opposite sex, but not of the same sex, the fireworks began after the Hastings Law School professor testified that "there are no victims in bestiality, it is a non-victim crime, and thus should be removed from the books."

A Gay activist militant from San Francisco spoke next on SB 39, and against all aspects, and then attacked Professor Barnett for his statement, stating, "Members of the Assembly, I have never heard of any animals consenting to sexual acts. And instead of dropping the laws against bestiality, they should be increased to a felony. I mean, have any of you ever heard of a dog or sheep saying 'yes' to sodomy? Gentlemen, if we cannot have respect for animals, how can we ever have respect for humans?" There was no comment from the professor after this, but angry glances were exchanged.

There will be another hearing about the first of April on SB 39.

HANDS COMMUNITY CENTER

The secretary of the SF Tavern Guild and financial blizzard of businesses, Mister Henry Leleu, has blocked any financial assistance to the Helping Hands Gay Community once more. The last request, made to TG president Ross, was presented to the Board, and Henry Leleu filibustered against it, stating that "That Broshears has picketed Tavern Guild functions, why should we help him?"

The last time Broshears and the Gay Activists Alliance picketed a Tavern Guild function, was almost a year before the Helping Hands Community Center was even opened. And it was pointed out to Henry Leleu that the Center serves hundreds of people weekly, and free, and that Helping Hands is not political, issues no political statements, holds no pickets, etc. etc., etc., but Rev. Broshears, who is the director, is also the chairperson of the Gay Activists Alliance, which does do such things, but that is not Helping Hands.

"Henry Leleu is a charming person. when he wants to be," said Rev. Broshears, "but that isn't very often where ! am concerned.

"But what I want to do, is confron Henry and ask him some questions concerning his obsession about sex in other people's bars," said Broshears. (Leleu reportedly gave financial assistance to the old Rainbow Grocery or O'Farrell Street, as well as to Mr. B's. The ones I know no more which used to be on Second Street, and to other after hours place called the Covered Wagon). Broshears stated some thing about Henry Leleu attacking Bro shears' past, to which he added that, would like to ask Henry why he left that 14th Street address in San Diego back in 1956 so quickly and went to Europe, and also why the Red Chinese government is interested in some art objects which reportedly are in a museum in Texas somewhere," and went on, "These are just questions about rumors that I want to ask Henry, and maybe I could understand his vicious attitude towards poor people and particularly those involved in civil rights

Mister Leleu refused to make any comments to the Gay Crisader concerning these questions that were asked, but the Gay Crusader will give a trip on China-America Airlines if someone can. We need cooperation and understanding, not fighting such as this.

"OPERATION ZEBRA?" San Francisco is averaging one murder every 21/2 days now, and what are the police doing about it? Nothing! Nothing except to look the other way and give de facto encouragement to them. Back in January, a dark-colored car, Cadillac or Lincoln, roamed the streets of the city with occupants who leaped out and shot down seven persons for no apparent reason. Since that date, the slaughter has increased. The SFPD has expressed relief over the kidnapping of Patricia Hearst, for as one cop put it. "it sure as hell took the heat off of us by the media." That is typical of the Chief Donald Scott adminis tration. Yet, all during the Patty Hearst kidnapping, the public has been kept in the dark concerning the slaughter on our streets, for the total of people murdered thus far this year, via shootings and stabbings, is well over 40, which brings it to an average of one murder every 21/2 days.

The SFPD has used the slaughter as an excuse to harass poor peoples; they have not gotten down to the nitty gritty of the slaughtering going on, but instead are concentrating on the poor and low-income peoples, the street people who are not the killers, and letting the killers go on killing.

The infamous white-wash code, "Operation Zebra," which stated that all cops are working overtime and cops are out in every part of the city and on Muni buses in an attempt to halt the killings, is pure bullshit.

The slaughter goes on, and the police go on playing politics down at City Hall, getting free booze and meals at local inns. What the hell, a fat cop is a contented cop, right fatso Scott and Blackstone.

through the phenomenal success of "Ziggy Stardust." But he's been around for quite a bit longer than that. Raised in a tough slum in London's South Side, David Jones had a rough childhood before dropping out of school for a job as a commercial artist. Finding the work boring, he left his job to form a rock and roll band called "Davy Jones and the Lower Third" and released his first record. It was not a success and when David Jones of the Monkees became famous, our David Jones changed his name to Bowie (after the knife), the band broke up, and Bowie left to study with the Lindsay Kempe Mime Troupe. A year later, having picked up new skills from Marcel Marceau in Paris, Bowie formed his own mime troupe called "Feathers," whose performances with T. Rex in England are legendary. During all this, David had found time to learn guitar and in 1966, he struck out on a solo singing career. Examples of this "folk" period may be found on the London double album entitled Images 1966-1967. It was during this period that Bowie,

openly and proudly gay, decided to marry Angie and have a family. He also returned to rock and roll, forming the "Spiders from Mars" with Tony Visconti, Mick Ronson, Mick Woodmansey, and Ralph Mace. His first rock album, The Man Who Sold the World, was released on Mercury and Ziggy Stardust was born! No sales though, so a few months later Bowie and his manager, Tony DeFries, formed Main Man Ltd. and in conjunction with RCA began plans for stardom. Main Man offices were opened in London, New York, and Tokyo (with a fourth planned for Los Angeles) solely to promote David Bowie, though the London offices handled Lou Reed for a while and Iggy Pop (The Stooges) was soon signed to Main Man. With the release of "Hunky Dory" Bowie's career began to move. "Hunky Dory" shot to the top of the English charts and plans were laid for the American invasion. It took a while, but finally the album began to climb the U.S. charts and as a result of brilliant publicity techniques, the fabulous show, and Bowie's new album, Ziggy Stardust and the Spiders from Mars, our hero became a STAR. Trevor Bolder replaced Tony Visconti on bass and Mace left the band, but the Spiders sound is, if anything, even tighter. Live, some of the songs are even stronger than on record! After the incredibly successful American tour came the release of Aladdin Sane, a very controversial new album of songs written while on tour; except for "Let's Spend the Night Together" by Jagger and Richard, a preview of things to come as it turned out a few weeks later when RCA released Pinups, a pleasant rock album full of fluff and fun. Not Bowie's best, but it grows or ya! Three cheers for David Bowie, the first 100% up front Gay Superstar!

WHO ARE THE PEOPLE'S **REAL FRIENDS**— SOME COMMON SENSE

By Sasha Gregory-Lewis

We in the gay and feminist movements are acquiring a pantheon of leaders of our own-as have other movements before ours. Each leader gathers a following of supporters and finally collections of ideas and tactics which are argued as philosophies of the movement.

These leaders and their groups of supporters are rapidly becoming an "establishment" in the full sense of the word. The movement establishment could become as oppressive as, and nearly identical to, the straight establishment which oppresses us today if we are not vigilant.

It is important for us-the people, the non-leaders, those whom the leaders claim to represent-to be able to tell who our real friends are. We must begin to distinguish among so-called leaders to find those who are deserving of our help, support, energies and time.

We must also be able to determine who our enemies are so that we don't devote our time and support to those who will end up oppressing us.

How shall we evaluate these groups and individuals who claim to be our spokespeople and leaders? What criteria should we use?

These are difficult and important ques-

There are many degrees of "friendship," and those who are our friends today may become our enemies tomorrow. The qualities which make a person a true friend of oppressed people are rare and elusive.

ENEMIES-FRIENDS-POTENTIAL ALLIES

People who act as our enemies are those who oppose the movement to end the oppression of all peoples. The more power our enemies have, the more dangerous they are. Enemies need to be removed from places of power so they can't continue to hurt us.

Our true friends are those who act in such a way as to support the struggle to end the oppression of all human beings. Our true leaders should be those whom we can trust to act consistently in the best interests of oppressed people. These are our true friends, these should be our leaders.

A third group of people may be called our potential allies-those who in some ways contribute to the movement toward freedom and oppression. Potential allies differ from friends in that allies are not dependable and act primarily in their own selfish interests or even in the interests of our oppressors.

We can sometimes make temporary alliances with these people to achieve specific goals. Some of their actions may be destructive, however, and this is why these people and groups cannot be called our true friends.

Groups and so-called movement leaders who at first glance seem like our friends may not really be our true friends at all. They may, in fact, act as our enemies at times

DOING AS REAGAN DOES

Ronald Reagan often acts as an enemy of poor and oppressed people. His pleas to starving and hungry Californians asking them to refuse free food from People In Need (PIN) are clearly acts which hurt the people-they contribute to the oppression of hundreds of thousands of Californians who do not have enough to eat each day.

. But what about the gay and feminist leaders who refused to have anything to do with the distribution of PIN food? Aren't these people advocating that hungry people be prevented from getting free food just as Reagan advocates?

Aren't these groups acting just as oppressively as Reagan?

Perhaps we can't call these groups our absolute enemies since some of their actions may after all benefit us, but certainly they are not our real friends, as they have shown.

At best they are only potential allies.

We should beware of our potential allies. When they attain positions of power they can do our movements great harm. This harm is even more insidious when it comes from those who claim to be our friends. We must be constantly vigilant when potential allies who are not our true friends enter positions of power.

vidual which claims leadership of our movements? Do they propose to reform the system so that their own group can get a bigger share of the goodies offered by our capitalist system? These reformists are not our true friends.

As long as there is capitalism there will be exploitation. The reformist just wants his or her own group to be one of the exploiters rather than the exploited.

Our true friends will recognize that if all oppressed peoples are to be liberated then the system as we know it today willo have to be completely changed and another, different, system instituted. The true friend of the people is a revolutionary, although she may, at times, use the system

as it now stands for one reason or another. done, what they have accomplished and Reformists, however, may be potential allies in some situations, but we should not rely on them as friends-because in the end their goal is to join the exploiting class, not to end exploitation.

EXAMINE ALLEGIANCES

If a potential leader or movement group seems to pass our tests of revolutionary action and philosophy then we must make one further test before admitting them as our true friends worthy of our support.

We must ask-to whom do they owe their allegiance? One indication of this is the source of funds for the group of individual. Another

indication of this may be the person's stan-

dard of living. A government employee, for example, may perform many acts which benefit the people-yet, because the government pays his wages which buy his food, he is not necessarily truly reliable. He may be a potential ally of our movement but it would be risky to claim him as a friend unless he had passed very stringent tests. When a conflict arises which threatens his position in the government, will he sell us out in order to keep his job and standard of living, or will he be willing to risk his job and position in order to stand by us?

People who are closely tied to the system in any way are in positions similar to the government employee. Organizations dependent on government funding are also potential traitors to the people.

This is not to say that these groups and people do not have a plce in our movement toward liberation. The gay liberationist who owns two luxurious homes and spends her hours giving talks on gay rights is not necessarily our enemy. But

neither is she necessarily a reliable friend. We should treat such people and groups as potential allies and always remain wary and cautious lest they profit from our op-

Our true friends will be open about their finances and sources of support and be willing to publish the facts of their survival and all of their interests and associations. In this way we can protect ourselves against those who would profit from our oppression in secret.

OTHER CRITERIA

There are probably many other criteria for determining who our real friends are. We should discuss all criteria among ourselves so that we can give our support to only the most deserving of leaders-those who are truly working for our interests. Our true friends will try to teach people

how to lead others and how to work together to create social change. They will advocate self-defense and

teach survival techniques. Our true friends will have to be dedi-

cated and courageous. They will have to be strong enough so that they will not cop out at the last minute when the going gets

Our true friends will not hide the truth

Our true friends will devote most of their energies to helping the movement and struggling against those people and systems which oppress us. They will not waste all of their energies fighting and slandering their potential allies. Only when our potential allies act in ways which are harmful to us should we struggle against them-and then only with the time and energy which is propor tional to the size of their offense.

'DICTATORSHIP' VS. 'DEMOCRACY' IN THE MOVEMENT

Successful revolutions in the last two centuries were led by a handful of people who gave orders. We should not spurn potential leaders if they appear to be order-givers are long as they meet the other criteria for our friendship and support. It is they who will be getting the job done while we are still sitting back talking and arguing.

It is important, however, for our leaders to be responsive to our needs. It is our REFORM OR REVOLUTION What are the goals of the group or indi-

It is the responsibility of our leaders to establish methods of training more and more revolutionary leaders. There is need today for many, many activist leaders. Many, many revolutionaries and many, many friends of oppressed people.

responsibility to ensure this.

Very few individuals today can truly be called our friends.

The question of democracy in the leadership of the movement isn't a meaningful one today-a democracy today would be a democracy controlled by enemies of the real needs of the movement.

Meanwhile, the need for revolutionary action is so urgent, that a temporary "dictatorship" of our true friends should be acceptable because it will accomplish more to end our oppression than so-called democracy.

But we must never lose our vigilance and should strive to educate new and more leaders who can truly be called our friends so that the leadership of the movement may eventually draw from a broad base—so that eventually all people will be making the decisions of leadership

If those who are leading and dictating the movement are judged to be false leaders and people who are now really our true friends then we should denounce them and replace them.

We have no time to waste in delaying our revolution until we achieve "democ racy" in our movement. There is room for all true friends of the people today as we learn how to take power and leadership into our own collective hands.

This is our responsibility—to see to it that a handful of our leaders who dictate by necessity today don't become the totalitarians of the future.

SHIFTS INTO MOTION

With the opening round of the candidates' night on March 13th at the Towne House Hotel, sponsored by the San Francisco Labor Council, AFL-CIO, COPE, the 1974 Congressional race began in earnest in San Francisco-Marin-Sonoma.

Mayor Joseph Alioto did not appear but sent a telegram signed "Governor" Alioto, which caused considerable dismay from the others running for governor, for it showed the obvious favoritism of Joe Belardi and John Crowley of the Labor Council for Joe Joe. The favoritism did not end there, for the biased Belardi, who is president of the Labor Council, continued on raving about the various old-time establishment candidates of the Labor Council, with one possible exception-that being incumbent Assemblyman John Foran, whom the Labor Council seems bent on dumping, at least de facto, and switching support to Reverend Eugene Boyle, a new lackey of the Brown-Burton machine, who is opposing Foran, whose labor record rating is an astounding 100 per cent. Tis strange that the labor bosses would "dump" a man who has served them so well, as well as all of the people, as has Foran, for the likes of Eugene Boyle.

The Labor Council bosses then went on to praise John Burton, who is seeking the 5th Congressional district seat and is opposed by Alan French and Alan Reeves, for the Democratic nomination. French is certainly the best-qualified to have the Democratic nomination in the 5th district, as he almost upset the highly favored used car dealer Roger Boas last time around. "Alan French would be the real candidate to beat in the 5th if he were nominated," was the statement of the Peace and Freedom Party flag-bearer for that Congressional post, the Reverend Raymond Broshears. French is much much younger and much more in touch than either Burton or Reeves, according to the general consensus of opinion, even though it is obvious that Burton has the blessing of big Joe Belardi and John Crowley.

So, with the speechmaking and fundraising under way now, it appears that for the first time in history, a Gayperson has a very good chance of winning a Congressional seat, as the most recent poll showed the Democrats with 36 per cent of the vote. Peace and Freedom candidate Broshears with 28 per cent, the Republicans with 11 per cent, and the remainder undecided. Marinites view Burton as a "machine man" and "carpetbagger," and he does not have the strength in that bedroom-county area to carry through to victory. The 5th Congressional district race is being viewed by politico experts as the testing site of "new politics."

It is apparent that lasting peace and true freedom have a doubtful future under our governmental establishment. The Peace and Freedom Party has sponsored candidates, and through them has brought the party platform to national attention. This in itself will not change national policy, even if more candidates get elected. If the Peace and Freedom Party is to accomplish its objectives, it must find a way to make the government more responsive to the desires of the people.

Direct Vote

Initiative and referendum provide a means familiar to Californians whereby the electorate participates directly in the legislative process by voting on propositions placed on the ballot. In the 1972 election the people of California passed a coastline initiative by a strong majority. This legislation was in the interest of the people, but could not be enacted by the state legislature because it was under the influence of special interest groups in opposition. A great deal of America's frustration with the Viet Nam War could have been resolved one way or the other by permitting the people to vote on a proposition to end

A national initiative and referendum is in effect a partial adaptation of direct democracy. The concept is made possible by modern communication using television and the press to keep the public informed on important issues. An informed people can determine where their own best interests lie on important issues, provided the issues are fairly stated on the ballot. Furthermore, they can do this for themselves better than their elected representatives, who are under constant pressure from lobbyists and special interest groups with funds to influence legislation.

A national initiative and referendum process would require an amendment to the United States Constitution. The campaing to gain public support for an amendment should begin in California where the initiative and referendum are already in the state constitution. The first step would be to place the following resolution on the California ballot:

Shall the citizens of California resolve to support an amendment to the Constitution of the United States extending the legislative powers of Congress to the people by public initiative and referendum?

LARRY SLOPAK REMAINS IN PRISON, WITH A LITTLE HELP FROM HIS "FRIENDS"

The case of Larry Slopak, imprisoned in Oregon State Prison in Salem, Oregon, remains there this very day, through no fault of Sasha Gregory-Lewis, famed women's liberationist writer, and her assistants.

Ms. Gregory-Lewis wrote several articles for publications which published the plight of Larry Slopak, much of which was in the February-March issue of the Gay Crusader. At that time, Slopak had written to the GAA in San Francisco for immediate assistance, giving written authorization for demonstrations, and what have you. Slopak has been in Oregon Prison for several years on a charge akin to childmolesting, but which was not, due to the "frame-up" and the consensual matters in-

Just as the Gregory-Lewis and GAA-San Francisco "Free Slopak" machine was rolling toward victory, certain Gayleaders in San Francisco contacted establishment Gayleaders in Oregon and warned them to stay clear of any association with GAA-San Francisco or Ms. Gregory-Lewis, who is a person who cannot be "con-

which had done nothing except token paper actions towards freeing Larry Slopak, and this is in Slopak's own handwriting in numerous communications at the GAA offices and with Ms. Gregory-Lewis. The Oregon Gayleaders with the exception of one person, Roger Troen of the Gay Liberation Front of Portland, capitulated to the "let-us-be-respectable" people, Ron Powell, Professor Titus-OSU, George Nicola, and Glenn LaPine. Well, these proper-type Gays still have their respectability and Larry Slopak is still in prison. Titus, a professor of law at Oregon State University, is receiving his salary from the same person as the warden who keeps Slopak under lock and key, and takes his orders from the same people that the Oregon Parole Board take their orders from. Governor Tom McCall. Titus is allegedly the attorney for Slopak, but with an attorney like Titus, who does not want publicity called to such a case of injustice as this, you don't need a prosecutor.

The issue is much larger than Larry Slopak, for there are thousands of Slopaks, and we must work with those who will work with us, and not "cop-out" under pressure as did Larry Slopak. All work on behalf of Slopak (with the exception of Titus's) has ceased as requested by Larry. We all can only hope that Larry Slopak, despite the ill-advice he has received, will

The actual processing of an O.R. con- Project is open from 6:30 A.M. until 10:00 P.M. seven days a week. Judges are available basically between 8 A.M. and 6 P.M. Monday through Friday. Each weekend a judge is available to consider O.R. matters.

A case can be processed quicker if a few points are remembered: A person arrested need not wait to be interviewed by O.R. staff. He should phone the O.R. Project from the precinct station or City Prison, at which time an interview can be conducted over the phone. The phone number (552-2202) should be posted at these locations. If not, ask the officer on duty or check the white pages of the phone book. The more names and phone numbers of references a person gives, the easier it is to contact two or three immedjately. References given should know the defendant's address, employment and family ties.

The problem area in pre-trial release is the defendant who is visiting the area or has only resided here a short period of time. O.R. is unlikely in most of these cases, and if bail money is unavailable the defendant must remain in jail pending trial, which period may run from a few days to several months. A person in this situation is more likely to "cop" a plea just to secure release.

One important thing to remember is that if a person secures an O.R. release and willfully fails to make his court appearances, he may be charged with another crime, in the case of a felony charge, another felony, and in the case of a misdemeanor, charge another misdemeanor.

Courts may grant releases in these cases into the custody of a person or organization, or by placing restrictions on the defendant, i.e. travel, association, or place of abode. An organization willing to assume custody of a defendant should be prepared to assure a judge that it is able to exercise some degree of supervision over the defendant. The organization should be able to keep track of where the defendant resides, notify him of all court appearances and offer assistance in helping him meet these commitments (carfare, transportation, etc.). If a person does not have a local address, the organ ization should be able to provide housing until the defendant is able to secure his own. Ideally, organization members could provide housing during this intermittent period. It would be helpful if the organization could further assist the defendant in securing legal counsel. The defendant's consent is of course necessary in this type



Medical Definition - A contagious skin disease due to the itch mite (Sarcoptes scabiei) which bores beneath the skin, forming burrows. The disease is accompanied by intense itching, together with the skin irritation caused by scratching.

Basic Symptoms - (1) Itching, especially at night. (2) Itching small blister-like eruptions that may contain clear fluid or pus. These appear typically in "runs" or "galleries"—in other words, the itching area appears as a short line (1/4" approximately) instead of looking like a pimple. These most usually appear first on the sides of the fingers and the heels of the palms, but may appear anywhere on the body (rarely in the hair). (3) Microscopically visible mites, eggs, and black clots of feces-these are not visible to the naked eye.

GENERAL CONSIDERATIONS:

Scabies is a common skin irritation caused by infestations with Sarcoptes scabiei. An entire family or communal group may be affected. The infestation is generalized but usually is not on the head or neck (although in infants even these areas may be involved). The mite is not visible to the naked eye. Scabies is usually acquired by sleep-

CLINICAL FINDINGS

Symptoms and Signs-Itching occurs almost exclusively at night. The lesions consist of more or less generalized irritations from scratching with small itching vesicles—pustules in "runs" or "galleries." The run or gallery appears as a short irregular mark (perhaps 2-3 mm long) as if made by a sharp pencil. Characteristic lesions may occur on the nipple and as itching "pimples" on the scrotum in males. Itching raised areas may also be seen over the buttocks. Areas infected by intense scratching may often be the

There is some current research and thought that scabies is a self-limiting invasion-

Many individuals believe that even after adequate treatment they remain infected because of continued itching. Often this is not the case—the dead mite often continues to remain under the skin and although dead and inactive, the organism continues to irritate the skin and cause itching. It is obvious thus that a person may have to endure mild



nological American Party (TAP) has again scooped the establishment press by announcing the 1974 Telephone Credit Card Code. Pointing out that calls are best made in a rushed, business-like voice, and should be limited to 15 minutes, so that the caller cannot be traced and caught, TAP also mentions that users of the code should call only from pay phone booths.

According to TAP officials, the letter code is: 1-N, 2-X, 3-Z, 4-A, 5-G, 6-S, 7-Q, 8-F, 9-U, and 0-J.

To use the code, add the city code (for instance, Los Angeles is 184) to the phone number of a corporation. The letter is determined by the fifth digit of the phone number. Example: Litton Industries in Los Angeles' phone number is 273-7860. The code for L.A. is 184 (not the area code), and the fifth digit is 8. So, the credit card number is 273-7860-184-F.

Other city codes provided by TAP are: Spokane, Washington, 128; New York City, 012; Chicago, 097; and Washington, D.C., 032.

Hypothetically speaking, to use the code to make a long-distance call, you would dial direct 0 (zero), then the number you are calling. When the operator comes on, you would say (using an actual number): "Credit card number xxx-xxxx-yyyx." Try and know the company name, area code, and city.

If the operator asks anything besides the number of the phone booth you are calling from, she or he is suspicious, probably. You should hand up, and try again from another booth. Be careful about what you say during a credit card call. The operators sometimes listen in, especially for the first few seconds. If the phone company asks about credit card calls made to your phone, say you don't know anything about it, that it must have been for someone else, but don't talk further. "Be friendly, but stupid," says TAP.

When making a TAP call, remember, give the phone number of a huge multimilliondollar business in your area.

The most important thing to remember is that you have an absolute right to defend yourself from any attacker. And, if you worry about the well-being of your attacker, you're lost. Fight to win, your attacker is not worried about your health or safety, so fight to win. In a defensive situation, there is no such thing as "fair fighting," you must fight to win, for you are fighting for your life.

Your attitude must be that of victory. You must be prepared to inflict serious injury, or even death, upon your attacker. For your attacker has these things in mind for you. Only a person with a vast amount of superiority over the attacker should consider

You must remain calm, don't freak out, don't forget everything. Getting excited wastes energy and shows your weaknesses to the attacker. If you must work off nervous energy, make loud aggressive noises, yell, shout, gesture, try and psych the

You must make every move count. Don't waste energy by flailing or throwing blows that do not damage. For example, slaps, blows to the shoulders or chest do little good at all. One blow with focused energy is better than 20 ineffective blows. Learn one punch, strike, or kick, and practice it. Make it hard and if you can land it, it's all you need. Better, learn it well and then learn something else. Learning means practice many times until it becomes instinctual.

One of the most effective techniques to learn first is the eye-poke. If done correctly i will immediately disable the attacker and enable you to get away, which is the ultimate defense. Keep the fist tight, and have a solid stance before throwing the punch. Practice in front of a mirror, it will be helpful. Coordination, focus, and strength, the big 3.

Remember: You have a right to defend yourself! Remain calm, and make every move ment count. Get yourself in condition and practice at least one technique so that you can defend yourself. No matter what your size, your build, if you can learn the basics, you can knock the hell out of your attacker, no matter how big or strong.

A special note from the coordinator of the Lavender Panthers:

- I wish to clarify some points about the Panthers. 1. They are not a part of the Helping Hands Center.
- 2. They are a separate and distinct political body from that of the GAA/SF.
- 3. They are an organization devoted to teaching self-defense, not just physically, but politically as well.

- 5. We advocate the use of weapons in self-defense, and urge that each home have a rifle or shotgun for that purpose.

REVERSAL? Yes! HOMOSEXUALITY GAINS **NEW ACCEPTANCE?**

In December of 1973, the American Psychiatric Association's board of trustees passed a ruling that homosexuality was not a sickness. But there could be a setback to that, as a strong right-wing lobbying effort is under way for the national convention of the American Psychiatric

In Los Angeles, researchers say that they can correctly identify homosexuality via the measuring of the male hormone testosterone in urine samples, stating also that feminine behavior is more evident in the sons of diabetic mothers given estrogen during pregnancy than in the sons of diabetic mothers not given estrogen. Big

Come June, an American Medical Association committee, the Council on Mental Health, is presenting to the membership a esolution which endorses the American Law Institute's Model Penal Code, which calls for removing legal restrictions on sexual behavior between consenting dults. It would also put the AMA on record as being opposed to employment and ousing discrimination against Gaypeople. But what I ask is, why does the law have to be "between consenting adults," which is ageist! Why not just between consenting persons of consensual age, which could mean from the age of twelve on up. Let us be realistic-does it not happen that the 13-, 14- and 15-year-olds make sexual overtures toward an older person, and if they desire it, why should it not be? Let us make the laws proper, let's not give the police one ounce more power than they already have.

The gains that some of the homophile leaders feel that we have made are not really improvements at all, but merely putting homosexuals into more highly categorized slots of society. I support the rowing movement for sexual law abolition; how about you?


