

The Office of the District Attorney denies that their men threw prospective jurors out merely because they were gay. VICE ENTRAPMENT IS **WORKING!?** Gay lawyer beats D.A. Freitas again

In his unending persecution of the gay victimless crimes in our city, the District Attorney Joseph Freitas was soundly beaten once again by famed gay trial law yer B.J. Beckwith at the Hall of (in) Justice, 850 Bryant in Dept. 17 with the Honorable Jud ge Louis Garcia



presiding and a full jury of 12 women and men. The case was another misdemeanor, 647a solicitation for a lewd act; 647b prostitution and 315 Penal Code "keeper of a house of prostitution"; and 318 PC the use of such a place as in 315 The D.A., in an almost vendetta-like attitude, continues to prosecute any and all cases which the famed trial lawyer is the defense attorney

But in the case of John Deming, who was busted March 17th at Market and Taylor for the above charges, the handsome young vice cop (see left here) was defeated in his first trial effort to convict a gay. The assistant D.A., Bernard Walter appeared to be undergoing OJT (On The Job Training) as in the old War On Poverty programs.

The handsome young vice cop was wear ing a leather jacket, levis, boots, etc., when he told young Deming that "I'm available!". Attorney Beckwith charged "entrapment" which the jury obviously agreed with. The trial took almost seven days of taxpayers money on another victimless crime, and apparent Fretias crackdown on gays.

D.A.'s Office is "Throwing the Book" at GAYS!

April 26, outside of Department 10, at the Hall of Justice, in which Judge Lucy McCabe was presiding, was a time of great excitment, as the above woman, representing D.A. Joe Freitas, who considers himself the arch-foe of the editor of this paper, had the Judge allegedly, order two deputies, G. Gonzales and R. Bralin, to take into custody the editor of this paper and seize his camera which had just take the abaove picture of her in the hallway on her way into prosecute the Richard Elmon Male Model Agency case. Umrein said that the Press Pass issued by the SFPD Chief of Police Gain was not enough I.D. The Judge, by ordering such an attempt which was halted by the help of Elmer Wilhelm of the Stonewall Democratic Club who was with the editor, and Officer Henry Friedlander who came down from the Chief's Office to halt the shoving around of the editor. Bralin bragged in front of our editor and Wilhelm, that "I enjoy beating up gays"!

He also said that he had "been a deputy too long" which we obviously agree. The District Attorney, has used THREE Assistant D.A.'s in an effort to defeat the attorney in the Elmon case at just the preliminary hearing.

The editor believes that Jack Campbell people are behind the Freitas efforts in the Richard Elmon case, indirectly.



LARRY HENDRICKS, KILLER OF FOUR, and POSSIBLY MORE, APPREHENDED AND KILLED BY HIS INTENDED VICTIM IN DEATH STRUGGLE EAST OF TACOMA!

It has been estimated that only 500 true gays exist in San Francisco, the others are but various varieties of homosexuals who give a damn for only themselves or their next "trick"! The world "GAY" means some super-special, and so few homosexuals fit into that category. "Gay" means to be completely free, liberated, that means mom, pop, borther, sister, cousin, job boss and neighbors all know that you are a fag or a dyke, and you are NOT ashamed of it to where you have to hide behind a bottle or inside pills (drugs) etc. That being "GAY" means you do care about the other people who are homosexuals and are being oppressed. In our city, obviously.... there could not be more than 500 at the outside most GAYS here. Going to a bar does NOT make you gay. Sucking a cock does NOT make you gay. Going to a bath house does NOT make you gay. Are you begining to comprende???

As has been written, our city has become a "refuges camp" for homosexuals from all over America. They flock here like so many "refugees". And instead of learning who and what they are, and how they should fit into society....they fall into the bath scene almost immediately. To them, the bars, the baths, the orgies are the only things that are important. But they are NOT LIBERATED....they are still caught up inside their own mind's closet, which is worse than the one they think they escaped from by coming here from "Podunk, USA". The "closet they are in now is far worse, far more deadly. They have allowed themselves to become part of the gay-sick ghetto scene. Some say it was formed out of "self-protection", once that was needed but obviously it is not needed now-a-days. Ghettos breed exploitation...by landlords... by bars...by baths...by so-called leaders.... so-called gay politicians (who tell you that YOU HAVE TO vote gay, which is bullshit). The Ghetto is profitable for people like those who control the Tavern Guild. They want to make sure you stay good noozed up. They don't want any alternatives to the bars to succeed....ever! And a "corona May 1st was a day in the life of PFC Tolvo Redditt, a soldier stationed at Fort Lewis, near Tacoma Washington that the 21 year old youth will never forget. Redditt was hitching back to the base when the black van of Larry Hendricks, 34 year old sex counsellor at Western Washington State Hospital and a one-time convicted sex offender, pulled up next to him with a pistol and pointed to Redditt and told him to get in, where upon he proceeded to handcuff and manacle PFC Redditt at gunpoint. Hendricks was only 5'5" and had a "thing" about his size, and was upset about it when people made fun of him, the CRUSADER learned from hospital officials

Hendricks was also an antique dealer in Tacoma, owning an antique shop, The Merchant Prince, 111Tacoma Rd. North. Hendricks made frequent "buying" trips to California, and San Francisco, where he obviously met the two slain Californians, Thomas Walls Gloster, 31 of San Francisco, whose nude gun-riddled body was found in Teha-

ma County near Red Bluff, and the completely nude body, also shot up, of Richard Harland Niemeier of Los Angeles, whose body was found in Napa County. Niemeier was visting San Francisco when he was kidnapped and slain.

The ballistics tests from the guns of Hendricks have roven beyond any doubt that the killer of Niemeier and Gloster were the same guns belonging to Hendricks, according to both Napa County Sheriff's officials and Pierce County, Washington officials.

But, back to the antique dealer's pick-up-kidnapping of the PFC.....after manacling But, back to the antique dealer's pick-up-kidnapping of the FFC......after manacing the 21 year old soldier he drove him into a remote area east of Roy, Washington, down a remote logging road, and turned off into the woods at a point where a tree had fallen across the road. After stopping the truck, Henricks got out, forced Redditt out and knocked him around with a billyclub 24 inches long. He pushed him over to a grave belonging to another body, whose face had been shot in and the genitals had been shot off. Hendricks threatened Redditt that this was what he was fo happen to Redditt if he did not so constrain with him (Hendricks). This was all happening after 4 AM on the he did not co-operate with him (Hendricks). This was all happening after 4 AM on the morning of the 1st of May. Hendricks proceeded to torture Redditt, with a whip, hittmorning of the 1st of May. Hendricks proceeded to torture Kedditt, with a whip, nitting him more with a club, and burning him with cigarettes. Hendricks all this time had Redditt tied to a tree. He released Redditt and told him to lie next to the dead body, which later turned out to be 22 year old Bertram Zahnie. After releasing Redditt to lay down next to the Zahnie body, Redditt, knowing that he was going to be killed anyway, kicked out with his foot, hitting Hendricks in the face, knocking him off balance, and proceeded to struggle for the gun. It went off, and there were powder burns on both of their hands proving there had been a struggle for the gun. Redditt won the on both of their hands proving there had been a struggle for the gun. Redditt won the gun away from his would-be-murderer, and shot him, three times, killing Hendricks... but Hendricks body was still moving so Redditt took another of Hendricks' guns and shot him with this shotgun and then beat him until he was sure the insane killer was dead. Pierce County Sheriffs told the CRUSADER as did the TACOMA NEWS TRI-BUNE that Hendricks had seven guns in the van, in addition to the various torture e-

quipment and the leather masks/hoods.

Redditt told the TACOMA NEWS TRIBUNE that Hendricks had sexually molested his body but later changed that story according to U.S. Army officials. Redditt had made his escape from the area in the van of Hendricks, dazed, bleeding badly, and he crashed into a fence of a farm where upon the Sheriff's office was called. When the deputies arrived at the death scene, they found Hendricks clad in an all-black leather suit. There was items letting them know that he had purchased the leather from a

shop here in San Francisco.

Deputies are still looking for more bodies in the area, having confirmed the two gay California slayings were the work of Larry Hendricks. There are now efforts to try to tie together the several gay slayings in northern San Mateo County which were attributed to someone who is now dead, but evidence now believed by many will trace Larry Hendricks to these killings. San Francisco Homicide officers refuse to become involve and the San Mateo officers say they will when they have "the time".

Redditt told reporters at the TACOMA NEWS TRIBUNE that the sadist Hendricks

only screamed out once after he shot him, "You're killing me! You're killing me!"
Then Hendricks finally stopped moving. Many gays here in San Francisco feel that the
PFC Redditt is a hero to which Redditt replied, "I don't feel I am a hero. I don't feal-

The TACOMA NEWS TRIBUNE did a fantastic job of indepth coverage of the trial, in particular, reporters Bob Lane, Vern Shomshak, Joseph Turner, and Kerry Webster. Friends and neighbors of the slain S&M killer Hendricks all reported shock and dismay upon learning their neighbor was a killer and an S&M homosexual killer at that. How Hendricks ever became a sex counselor at Washington State Hospital, is a surprise to all the reporters including us here, after he had such a serious felony conviction before for an abduction and S&M beating sexual arrest.

The slain killer had amassed \$40,000 in a savings account, owned the antique store, the van, the guns of course.

Authorities are checking with police in various parts of California, Oregon and Washington in an effort to help solve other unsolved slayings which are similar to the ones which Hendricks has committed in the past.

PFC Redditt is being kept away from the press at Fort Lewis army base right now. His right arm is broken, he has cuts, bruises and cigarette burns all over his body.

The San Francisco Tavern Guild president Wayne Friday has said that his group will not give any of the reward that group offerred for the killer of Neimeier and Gloster based upon the technicality that Hendricks was notarrested and convicted. Grief!!!

Gays reward GI T.G. Prexy in a sex killing

The San Francisco Gay Tavern Association and a group of motorcycle clubs are sending a \$2,500 reward to Pfc. Toivo Redditt, a Fort Lewis, Wash., soldier who police said killed a sex murderer in self-defense.

Posting of the reward was confirmed by the Rev. Ray Broshears, editor of the San Francisco Crusader, a gay newspaper: "We are deeply grateful to the

private, who is a hero really." The association, representing about half of San Francisco's gay bars, and the bikers collected the money over the last few months as a reward for information leading to the arrest and conviction of the killer of Tom Gloster, 31, a local gay. His body was

found in Tehama County last February. Authorities determined that Larry Hendricks, 23, a known rapist, was responsible for Gloster's killing. Hendricks had been working as a sex therapist in a Washington state mental hospital in Tacoma.

Authorities said Hendricks was shot and killed May by Redditt, 21, after Hendricks abducted the soldier at gunpoint near Fort Lewis, drove him to a remote spot and beat and tortured him. Redditt managed to get free and killed Hendricks after a struggle, uthorities said.

"DOWNTOWN LOCAL", first on the program, is the deeper but less well written of the two (fifteen to twenty minutes of ideas expanded to fortyfive, mostly through repetition) uses symbolism (a cold, lonely subway platform as life, waiting for the train that never seems to come as constantly looking for love, even tho one night) effectively, but relies too heavily on insanity (two of the four characters) to make a really strong statement

.. Michael Hayden is impressive as "orlando", a young, not-so-innocent but still hopeful street kid (and would be even more effective if one had not seen him in "WEST STREET GANG" constantly using the same acting tricks and mannerisms, although, admittedly the two characters are much alike, both young, underpriviliged Puerto Ricans. Martin Xero is also most impressive as 'Vesper', a semi-drag queen recently out of Belview Mental Hospital, but he comes on so strong at his first entrance and continualy plays at so high a level that the performance looses through lack of contrast.Duane E. Cropper is more than adequate as 'Dennis', another borderline insanity case, but needs to show more inner fire.Blaine Sousa is fine in the rather shadow

waiting tho more effective However, it is...... "RICHMOND JIM" that is going to both draw the crowds and, at the same time, raise eyebrows and probably hell in general. If one finds male nudity or exceptionally frank discussions of sex acts, usual and unusual, and role playing offensive, they should give it a wide miss. This is just about the most open and basic play I've ever seen and while there are no explicit sex acts performed on stage, (nor does anyone get an ecrection) that's about all that's left to imagination. The play opens with handsome, young and innocent 'Jim' (.......Randy Bennett, and what an appropo name his is for the part) on his first night in New York on vacation from Richamond, Virginia and beared, hairy and macho 'Mike' (....Joe Capetta) in bed together.....in the all to-gether. THAT is only the begining......as Mike first talks about how great it was, then about the various less usual acts, toys and role playing and finally iniates the more than willing Jim, said initiation hilariously interrupted by the arrival of a marvelous character (.... Charlie Hufford) whose sustained comic relief (and believe me, this is one time when "many a truth is spoken in jest") is a great counterpoint to the realism of the rest of the play. All three actors are superb, each giving a gem of believability in projecting a simple

role of 'Georgie-Porgie', 'Vesper's' newly re-married husband.

Perhaps the single most interesting aspect of this production is that although intensely realistic and basic......no euphanisms here; at one point Mike puts a ring on Jim, only not on his finger, in full view of the audience.......I, who completely avoid porno shows because I find them extremely boring, found this play enormously exciting without being the least bit vulgar or pornographic. With a less talented cast and a less astute director than Guy Bishop....


"RICHMOND JIM" could easily degenerate into nothing but a sex show. Instead it is a powerful slice-of-life drama, perhaps not everyone's cup of tea, but clearly pointing out everyone's undeniable right to

FINE PRODUCTION, SAD PLAY "The Ballad of the Sad Cafe" (at the SF Rep. Theatre, 18th & Collingwood, Thurs.-Sun., 863-4859 for info) offers fine actingone of the great state fights that I've ever seen (special kudos to Ellen Ernest for her staging of it as well as to Linda Powell and Michael Ernest for her only making it seem realistic but for achieving the almost impossible: that a powerful woman could believably win an all out fight against a strong man.) Yet the warmth and, at the same time, impartiality of her performance nearly pull it off.

A MUSICAL WITH POSSIBILITIES

The biggest drawback to "The Starting 5" (at the Hippodrome, 412 Broadway, Tues-Sun., 982-2343 for info) was the pre-opening publicity stating it was on its way to Broadway (NY). Not surprisingly, this led people to expect a polished, tight, and highly finished show, which it isn't!

On the other hand it is a pleasant, amusing and upbeat musical which should appeal to those huge numbers who are into the disco beat. While the characters are not drawn deeply, such isn't necessary in a light musical and on the whole, they are easily believab-lealthough I personally stick at being asked to believe that any high school basketball star who is five foot six would be offered a million dollar contract to turn pro (on which most of the plot hinges).

For the most part, the cast perform well with outstanding jobs turned in by Kevin Hall as 'Dunk' whose winning personality projects beautifully as well as Robert Jones and Harvey Lacy as 'Large' and 'Small', two of the most engaging con-men seen since Runyon

This story of personal triumphs and tragedies of a high school basketball team, their girls, coach and his family, has charm, and is exceedingly visually attractive and, in a time, when most high school students delight in putting down their parents, one superb line: "Mother may not always be right, but she's always Mother." (And thank you Admiral Decatur.) RECO RECCOMMENDED!!!!!

SOME FINE ACTING.

A few weeks ago I stated in this column that although I didn't consider that a play being an author's first was sufficient reason to attend it, I did admire companies that are willing to take a chance on unpublished playwrites and/or unproduced plays. Cinsequently, I'm happy to say that Martin Epstein's "AUTOBIOGRAPHY OF A PEARL DIVER" (at the Magic Theatre, Ft. Mason, Thurs-Sun., 885-9928 for info) is an interesting, attention holding play with some very fine acting.....and, unfortunately, some that is not so fine.

The balance, however, is heavily on the plus side with Peter Coyete as a mechanic who tries to repair lives as well as cars and ends up getting his own life straightened out. Linda Hoy, as a flighty, not terribly intellilousewife of too many years is very fine as she brings pathos as well as comedy to the best written role in the show. The other two roles, her husband (Abe Kalish) and a policeman friend (Rick Prindle) were intended, I would guess, to be satirical but the fine edge of satire is missing from the actors performances, both are too heavy-handed, and are easily forgetable. Michael Kroschel's set is interesting but because of its depth and the theatre's three quarter round seating, has some very bad sight lines in the side sections nearest the walls. Seats are not reserved so get there early......and put a coat or program on the excellent ones in the cen-

INTERESTING "STRAIGHT" BUT..... "A SOCIAL & POLITICAL COMMENTARY"

Recently, at the much heraled meeting of gay people invited to City Hall to meet with Mayor Dianne "Ayatollah" Feinstein......Steven Walters, president of the Alice B. Wonderclub, aired a too commonly held view that only gays in some position of power can effectively represent gay people. He illustrated it by comparing a possible gay person's future performance as a Police Commissioner to Commissioner Jane McKaskle Murphy's past performance. The comparison was idiocy in it's self! Commissioner Jane Murphy is the first woman ever appointed to the San Francisco Police Commission in this city, and she rates an "A+" citywide for performance, so if Steve Walters wants to knock off points for her hetrosexuality, she'd still deserve an "A-" from the gay community. Gays like heterosexuals just don't come with gurantees on performance.

Taking Steve's though one step beyond......notice, I didn't say one step forward, because it isn't....! Going this step beyond like many have: Gays express thoughts such as..... "Castro belongs to the gays".....and "We're going to take over this city". Mob rule is what these people are supporting, and that is what happened at 18th & Castro Streets last Saturday, May 12th. Remember, that without any laws, we, as individuals, will be defenseless and there can be no safety for any society and especially a gay one! I'm convinced the great majority of people in this town don't want to see this city become any "gay"er! This is not to say that more gay people can't SETTLE DOWN.HERE! That feeling reflects itself in many places, for instance both daily papers whether by deliberate intent or subconsciously, present a pattern that has disturbed me for some time. So much good news is either not reported or played down. I'm not speaking of gay events. I'm referring to events happening throughout this country and right here in our own city and bay area; events that would be informative to the non-gay readership about significant support ascerted in the development of respect for our aspirations toout significant support ascerted in the development of respect for our aspirations to-ward the equal protection of the law, that every individual citizen is entitled to under

It wasn't until recent times that our sexual rights as a member of the human family were legalized. It was changed for the most part by those who did not want us to live outside the law, so our sexuality was made legal. In the gay community, many other activities outside the law....were condoned...or were tolerated! Much of it involved gays EXPLOITING gays. We did not afford one another the benefits offered by law. If now, we don't begin to emphasize our respect for law.....and act responsibly as individuals, WE WILL ALL SUFFER!

Today, there appears to be no leaders in the SF gay comunities. At best, there are a few activists and a significant number of political opportunists. Gay people are in serious difficulties and we have much that must be done!

For one, we must REMOVE D.A. Joseph Freitas as District Attorney this fall. These last two weeks I've spent observing trials involving gays at the Hall of Justice. A common injustice in this country has been the black man unable to get a fair trial when he is accused of accosting a white woman. He always received either the death penalty or a long jail sentence. Likewise, WHITE JOCKS, were freed after murdering another man simply because his testimony that a sexual advance had been made towards him. These last two weeks we've witnessed the trial of a "young jock" by the name of DAN man simply because his testimony that a sexual advance had been made towards him. These last two weeks we've witnessed the trial of a "young jock" by the name of DAN "lily" WHITE; a confessed murderer of Harvey Milk, an avowed homosexual, who smirked at Dan along with George Moscone, heterosexual. Who has made no secret of his friendship with gay people. The District Attorney, first of all, excluded ANY GAY person or any one who had supported gay rights from jury duty. Did he exclude from the jury those who might harbor ill-will towards gays? Hell no!!!! This all-American JOCK, former Policeman, and Fireman, and "law 'n order man's " sweetness and wholesomeness flooded the courtroom and remained unchecked. The over abundance of sweetness became a key role in his defense. In fact "sugar" itself becomes the culprit. How did a BOX OF TWINKIES CREATE A DING DON? This became the major question left unanswered!

Charles McCabe recently came under strong attack by some gays for an article that expressed his observations concerning Dan White and his crime. McCabe said that Dan is a hero to some. This trial reinforces what Charles McCabe found when he took this city's pulse. No murder trial in this city's history has afforded a self-confessed double murderer MORE CONSIDERATION!.....than his victims and their loved ones. Meanwhile on the second floor of the Hall of Justice, two other trials were taking place Meanwhile on the second floor of the Hall of Justice, two other trials were taking place with much different results. One case, the D.A. was prosecuting a gay arrested by a new young hunky member of the Vice "entrapment" Squad, intent on removing Mayor Dianne "Ayatollah" Feinstein's unwanted inhabitant from this city's Tenderloin area. This victim was arrested for standing on the street while harboring unclean thoughts. They literally threw the book at him! Again gay people were kept off the jury by a young recent graduate pf law who works dirt cheap, he is doing it for experience, and they charge the defendant with prostitution. He has had two court victories (the attorney) and he was ready to string up a third with this easy one, had it not been for B.J. (continued on page 19...

ATTORNEY JOSEPH FRIETAS & AND FRANCISCO POLICE.

At the May 6th meeting of the Stonewall Democratic Club, the membership of that group voted a resolution fo censure on District Attorney Joseph Freitas, steming from an April26th incident in the hallway of the Hall of Justice at 850 Bryant Street, when one of the District Attorneys assistants, tried to halt the 1st Amendment of the Constitution, 'freedom of the press' by having a gay reporter's camera seized u successfullyand refusing to honor the press pass of the SFPD. As a result of the same incident a member of the SFPD Vice Unit became involved and the Club voted a letter of censure be sent to both the Chief of Police and the Mayor as the Vice cop infront of a Stonewall Club member, referred to the reporter as a "fruit"!

The Stonewall Democrats also voted to change the time of the meetings to the first Monday of each month at 7 PM. Club president Robert Schmidt, an attorney in the District Attorney's office, supported the

change, stating that such a change will reflect even better in the growing att-endance of the Club which is the fastest growing gay Democratic Club in north-ern California as of now.

Attorney Arlo Smith, Sr., a member of the Attorney General's office of California, was voted the Club's Parlamentarian without any dissent.

Alton McLean, Jr. was voted the new treasurer of the Club also.

The Club joined other gay groups in endorsing the 7 points of the San Franciscans For Affordable Housing. The Gay Voters league, and the Gay Liberation Alliance of San Francisco already have endorsed the measure.

The Club voted to look into the lack of reportage of donations into the fund to pay off the bills of the late Supervisor Harvey Milk.

Ray said, "When one of the bitch ole queens sez he is not going to give any money to it at our auctions, it doesn't hurt me in the least, but it sure hurts the old people.....I hope they can sleep well with their bitchy conscience!" But, fortunately these people are in the minority. Bless you all!







The map below left is an exact replica which the District Attorney Joseph Freitas requires all persons arrested on 647 (b) of the Penal Code to sign. If they violate that signed petition, they will be arrested and have to serve out their terms if they were convicted under 647(b) which is "solicitation for prostitution). Many gays who have been arrested and "forced" to make a deal, even tho they were innocent, have had to

"cop a plea" falsely, in order to avoid going to jail on a prostitution charge. D.A. Freitas who is supposed to be the friend of gays but surely is not, also has one aimed at the blacks, it is a map, but has boundries for out in the Hayes Valley area in which mostly blacks reside. That is racist..... just as his other map the one below is "sexist" (anti-gay).

Yet no one in the other supposed gay papers have said a word about them, all they have done is defend Freitas, print all his press releases, do his bidding, or as one gay politician said......



CONDITION OF PROBATION ON PENAL CODE SECTION 647(b)

As a condition to the grant of probation, Defendant is not to loiter about in the area known as the Tenderloin between the hours of 10:00 P.M. and 4:00 A.M. the following morning. The boundries of the Tenderloin are formed by Polk Street on the west side, Bush Street on the north side. Stockton on the east side, and Market-Turk Streets on the south side.

If you are found loitering in that area during those hours, it may constitute a violation of your probation, and you will be arrested.



As you grow older, the homosexual is free from alot of the problems the heterosexuals have, disruptions of the family, or being forgotten



Beckwith. I've known B.J. for a number of years and was well aware he's recognized as a brilliant defense attorney.

A lawyer who has many times in courts testified to his own homosexuality, begining

A lawyer who has many times in courts testified to his own homosexuality, beginning back when "gay" was not used in a queer sense. Money was never the deciding factor when it came to an important case involving gays. What was important to BJ many times, was that poor victimized gays, sometimes without any friends, receive his expert services to battle all the powers of the People of California (the prosecution), represented by the District Attorney's office and the Vice "entrapment" Squad of this

It was never easy, I have never witnessed BJ ina court room action although I had ollowed many of his cases in the gay newspapers. The straight press never fol him much after he entered the cases. The acquittal of gays was never the straight press's cup of tea, it might attract more gays and people might believe we are some times not guilty of wrong doing as charged. This was a long trial, the one I attended. For it's kind, especially since the "dirt cheap" prosecuting attorney was doing it for the courtroom experience and not working by the hour or pressures of a heavy duty case load or even an employer's concern for time and money spent. It proceeded. When the day came for BJ to present his case for the defendant to the jury, Mrs. Taylor, long recognized as San Francisco's foremost court room spectator, left the DAN WHITE trial to witness B.J. Beckwith in action. In a dramatic conclusion, the case want to the jury for a verdict. After long deliberation the jury returned a "not guilty to three of the four charges. The fourth charge they were unable to reach a verdict with eleven to one for acquittal.

The other trial begins the sixteenth of this month again, with BJ as the attorney for the defense. It was during a week long preliminary hearing for this case that I witnessed the D.A.'s office, the Sheriff's office and the Police Department's Vice Squad WITH OPEN DISGUST!

The STONEWALL DEMOCRATIC CLUB of San Francisco has fully discussed these problems and will be taking some actions. On the 14th, the Alice B. Wonderclub met t the new Women's Center in the Mission, when they removed all of the urinals from the men's rooms. After all, they are one of the many things that men do stand for! We sure have to lift our seats now to the ladies for this one

The Stonewall Democrait Club was the first Club to support the Patio Cafe in it's struggle against unionization. The list of supporters has now grown, with the CRIR (Concerned Republicans for Individual Rights), the Gay Voters League, the Eureka Valley Merchants Association also. Wonder which way Alice B. Wonderclub will go? Just remember, that the right to organize is not in dispute......it is the right to remain free that is in danger!


