### **GINGER SUPPORTS** GAYCOTT of NEVADA

In a break from tradition and in a tremendous show of courage and support for ERA (Equal Rights Amen-dment) and for Gay Rights in Nevada, the Empress de San Francisco, XIV Ginger voted to boycott the June 30th Coronation in Reno Nevada.

Ginger told the CRUSA-DER that this is in no way a "slap" at Nevada gays but a show of support for them and hopes they will understand and will be stirred to

behalf of passage of the ERA and for a Consenting Sex Between Adults bill in that state. Nevada, which almost totally dependent upon California money for existence, will suffer greatly if groups, small and large, as well as individuals, send letters to the State Legislature as well as to the Reno and Las Vegas Mayors telling them they will stay out of Nevada until such time they grant equal rights to wmen and to gays, something which the Nevada State Legislature refuses to even consider. Radical right wingers control the State consider. Radical right wingers control the State Legislature as of now.

Reno gays have greeted news of the gaycott with mixed reaction, but most have stated they feel it will hurt them for a while but in the long run it will bring to them the same rights we have in Cali-

fornia. Many gays who have been alone in hotel rooms have been arrested for having sex in Nevada and California gays visiting the state have been some

of the victims of Nevada bigotry. It is hoped that the gaycott will grow, as will the N.O.W. (National Organization of Women) boycott, which has already cost Las Vegas some very big convention. Congradulations to Ginger!


### Anti-Freitas Picket a Hit



At a special board meeting of the third gay Republican Club in America, the gay Republican Club in America, the CRIR (Concerned Republicans for Individual Rights), the president Don James, a long supporter of Harry Britt the socialist gay Supervisor from the 5th District, let loose an attack upon Britt that shocked man, "In November of '78, after the tragic events at City Hall, there was fear that, with the loss of two good friends, the gay community would find itself bereft of support. and in January, upon the appointment of Harry Britt as Supervisor, I personally expressed my support of him, as I felt he needed broad based support in order to be a fully effective Supervisor. low, however, I must withdraw my support due to my belief that, in agree-ment with Chief Gain, Supervisor Britt

has become a "demagogue". He has effectively alienated our community from the police department by his repeated attacks upon them. 

A Los Angeles based firm called "King Theatres Inc." is attempting to open a theater on Larkin Street across from what is now a parking lot but what will be in the near future a Mini-Park for children and seniors.

King Theatres Inc. is allegedly owned by Monroe Beehler who allegedly owns the Century Theatre

Beehler who allegedly owns the Century Theatre in Los Angeles a gay porno house and also they allegedly own the heterosexual porno house called the Pantages Theatre in Hollywood. The Vice-president of the group is Woodrow Daniel who allegedly owns a porno bookstore in Los Angeles called, "Woodys". The treasurer is John Winslow allegedly who also allegedly serves as the secretary of King Theaters Inc. King Theaters Inc.

King Theaters Inc., reportedly is trying to open a porno house (gay) in Washington and in Houston, which means that alot of money must be coming in from somewhere, at least according to experienced porno house operators, it takes alot ff money to open a porno house let alone buy

It is obvious to any who have looked into the "century" that it is very well organized porno. Which is why the Polk Valley Improvement Association has opposed the opening of the "century"

The "century" is also within 1,000 feet of another porno palace which is a violation of the law which was passed earlier this year. The owners claim they have shown porno there before, but none of the neighbors can remember it and the SFPD Northern Station which is but three blocks away knows nothing of it, nor does the Vice Squaders. The Polk Valley Improvement Association says that it was NEVER a porno house and has requested that the City Attorney look into the matter as the District Attorney is not qualified to do so. Also the Office of the Attorney General of California has been brought into the matter and is investigating "King Theaters Inc.". Similar complaints have been made to the Federal Organized Crime Strike Task Force.

"Bells Are Ringing" (at the CLO's Orpheum, thru July 7, call 552-0500 for info) is a Fifties musical that was written for the unique and kooky talents of Judy Holiday and as such, was a medium success. However, as Poe said: "Ring out the old, ring in the new....." which is exactly what this production does, wisely not trying to emulate the original but giving Florence Henderson full scope and there-by utilizating her own particular talents.

Charming, gracious and honestly concerned rather than wild, wacky and scatter-brainedly helpful, as was Miss Holiday, she brings sincerity and warmth to the show as well as an added dimension of believability.

Co-star Dean Jones, the perverbial aging "preppie" whose eternal boyish "Mr. Clean" good looks and personality is certainly more than adequate but is more likely to appeal to the mother instinct of blue rinsed grey haired matrons rather than the readers of this paper.

While this is not a "South Pacific" or "Fair Lady", "Bells' is a thoroughly enjoyable BIG musical with interesting sets (Robert Randolph) vivacious dances (David Black), colorful costumes by Charles Berliner, and three big hit songs, "Just In Time", "The Party's Over" and "I'm Goin' Back", surprisingly all in the second act.

### "YOU'RE O.K. OKLAHOMA!"

(The Best of Broadway series at The Curran, thru July 8th, call 673-4400 for info) is a rip snorting revival of the fine grand-daddy of modern musicals, brim full of superb songs, DeMille's trend setting dances and plain, old fashion

Despite characters that are either all good or all bad, a plot so thing that one seeing it for the first time will see through it in the first five minutes, and jokes one sees coming before they got started, it captures better than any other theatrical pieces the brashness and optimism of the Turn-of -the-Century America, at least as seen through today's nostalgia filled eyes.

Laurence Guittard as "Curley" and Christine Andreas as "Laurey" are a bit too "very, very good", Martin Vidnovic as "Jud" a bit too "horrid" while Mary Wickes "Aunt Ella" is too all wise and all understanding and Jamie Farr as "Ali Hakim" (and after having see n so many well known TV personalities who can't act their way out of a wet paper and the state of the state bag on stage, what a welcome surprise he was' a pleasant singing voice, a beautifully sustained characterization and truly superb comedy timing) a shade too much the buffon......but that's the way they were written and the over all impact is, if not immensely believable, immensely charming Harry Hroener as "Will Parker" is excellent but I found Christine Ebersole as "Ado Annie" too trashy, coming closer to projecting nymphomania than the innocent fun-with -anyone the role calls for.

### TALENT ALONE IS NOT ENOUGH

Regardless of an actor's demeanor off stage, while Regardless of an actor's demeanor off stage, while on he must project a certain humility, to the extent that the role is bigger than he is. This is as true for a never-off-stage lead as for a one line walk on and if the actor doesn't feel thus, he shouldn't be in the role. This lack of humility is a drawback to "DEATHTRAP" (at the Geary thru July 15th, calll 673-6440 for ino) for although Brian Bedford is close to superb in the lead, his constant projection of the idea that the whole thing is really beneath a man of his talents detracts.......as does Kathleen Freeman's too heavy Dutch accent, so heavy as to be unintelligable much of the time.

Against these two not very major flaws is a superbly crafted show that is just about GURANTEED to keep you on the edge of your seat with surprise after surprise coming after moments of almost unbearable tension time after time. An added plus is William Ritman's magnificent set, a room to die for.

This is FUN theatre at its best; intell sure to get the adrenalin pumping faster and if, in retrospect, holes can be picked in characterizations, so what. Forget your problems for a few hours; go and enjoy! WELL RECOMENDED

COWBOYS AND .

.....not Indians but Shakespeare prove to be a fine marriage in the TAMING OF THE SHREW (at the Cannery ...open end run, call 441-6800 for info). Keeping the Bard's lines but using sets, costumes and actions of the OLD WEST. this production is a laugh filled riot that is packed with non-sensical fun without damaging the inherent structure of the second seco ture of the play.

Mark Rasmussen is a winning Petruchio; commanding, bawdy and vivacious who astutely manages the fine line between self-confidence and conceit, a line very necessary and yet extremely difficult to achieve in this role. On the whole the cast is excellent, particularly Paul West as Lucentio, bringing to that basically stick role both depth and comedy rarely seen in it. Unfortunately Alice Rovick as Kate projects more the idea of a man hating Women's Libber than a smouldering, passionate wench who not only needs but actually aches to be tamed (dominated) with the result that her conversion to docile wife is hardly believable.

Special kudoos to Ronald Krempetz for his intriguing, multileveled set and especially to James Dunn both for conceiving the idea and adapting the play as well as for his fast paced direction.

"The Last Of The Marx Brothers' Writers" (at the Berkeley Rep's Theatre, thru July 22, call 845-4700 for info) is helter-skelter slapstick comedy that is a sure fire hit for those who worshiped the Marx Brothers, but is probably a bit too zany for most. Slapstick is so specialized a form that unless superlatively done it tends to miss badly; thankfully in this case it is very well done indeed, due primarity to Michael Libert's astute direction, lead Charles Dean and Dale Elliot who, at different times, plays Groucho, Harpo and Chico with amazingly close physical and stylistic likenesses. The plot, almost non-existant, is subordinate to how things happen.....entrances to closets, from under the

A most worthy commerative production it is. One of the rarest produced of all the G&S repetoire, for Savoyards it is not to be missed, an apportunity, but, equally, for those not so fond of their works it is well woth seeing. woth seeing.

Nick Eldredge as the prisoner is excellent, beautifully sustaining a characterization that glows with subtleties and variations while Tom Lynch is less effective as his attorney,

DOMINICANS IN SAN FRANCISCO ...

When people think of Dominicans in San Francisco, they think of St. Dominic's Priory on Bush Street. Little do people know that the two other so-called Dominican groups have nothing to do with the Archdiocese of SF, the the Dominican Province or the Roman Catholic Chu

rch.
Several years ago, Brother Donald J. LeRoy, O.P. of the Roman Catholic Dominican province was EXPELLED by the Provincial. So he set up a rival Dominican House in San Francisco, declaring himself a third-order brother-hood with the apostolate of curing alcoholic priests. Among his early candidates were Eugene Kopp and Michael Rice. Donald LeRoy was ordained a priest by Bishop Hough of Los Angeles, an Old Roman Catholic Bishop, consecrated by Dr. Richard Marchenna of New York. Until shortly, he resided at the House of St. Joseph (now the House of St. Jude) 1020 Pierce Street, San Francisco. Other Dominicans were Father Angelo Richard Rovai Other Dominicans were Father Angelo Richard Rovai (now a Franciscan) and Gilbert Hamilton. At the time of this article Father LeRoy is going through another split ...,he is moving from the House of St. Jude. This group under the direction of LeRoy lives in a fantasy world that

The second group I would like to mention is called St. Thomas Aquinas Priory, headed by the so-called Father Eugene Kopp. Until recently Eugene Kopp occupied the Chapel at the San Francisco Ecumenical Center. He has now relocated to Fulton at Fillmore Streets in the Wortern Addition area of San Francisco. He was ordaine Western Addition area of San Francisco. He was ordained by Wallace-David deOrtega Maxey and claims that Bishop Michael Ramm of Los Angles is his Bishop.

they are Roman Catholics associated with the Church of Rome. They have NOTHING TO DO with the Church

I first met Dr. Maxey (as he likes to be called) in January of 1976. I was on my way back from Los Angeles and I stopped to visit him in Fresno. The meeting was short, he invited me in and showed me his documents. I invited him to visit San Francisco, so my driver and I returned to San Francisco. The next month Dr. Maxey visited Our Lady of the Rosary Church. In hi suitcase were several documents which he left with me. They covered a fifty

documents which he left with me. They covered a fifty year span of his ministry.

Dr. Maxey was ordained a Deacon in the Protestant Episcopal Church, the Diocese of California, and served in San Lorenzo for a short time. After resignation before the Bishop of Los Angeles, he was ordained by Bishop Hunter in Mobile, Alabama for the Old Roman Catholic Church. He served this Church until 1953 when he resigned and was made a titular Arabhishop without any animal catholic church. Church. He served this Church until 1953 when he resigned and was made a titular Archbishop without any episcopal jurisdiction. He also had been involved in several other Catholic movements and splinter churches. In 1953 he was under canonical oath to the Archbishop of Glastonbury in England.

Bishop Maxey in the spring of 1976 offered me several titles and documents, I wrote to Father Seraphim in London to see if Dr. Maxey had canonical powers to confer such titles - Father Seraphim wrote back; "We have not beard from Dr. Maxey in years" and he went on to state.

heard from Dr. Maxey in years" and he went on to state, "Dr. Maxey retired in 1953, another man has taken his place and he has not the faculties to ordain, consecrate, or any other priestly function other than to celebrate the Holy Mass. He is an inactive Bishop.

Bishop Maxey visited again in the fall, I had heard that Bishop Robert Ramm of Los Angeles had claimed to have been consecrated by Dr. Maxey the month earlier. When Maxey arrived, I asked him several times if it were true, he made a statement that he DID NOT CONSECRATE Rammun...I had it notorized. When I saw the consecration certificate of Ramm, I knew it to be a forged document. I sent it to England. Father Seraphim also declared it to be a forged document and again stated that "Maxey has no canonical jurisdiction." Their representative in northern California resides in Davis California, please contact him.

In 1977, I got word that an ordination of Paul Bernadino phoned Bernadino and asked who was the ordaining

Bishop, as I was opposed to the ordination. I asked if it were Maxey and Bernadino said "No!"

Dr. Maxey indeed and infact did come to San Francisco and he Ordained both Bernadino and Kopp. Again I contacted Father Seraphim in London to see if they had granted faculties to Maxey for such an ordination. The answer was "no". Dr. Maxey had ordained without proper episcopal jurisdiction thus making Kopp and Bernadino "illicite priests".

When the now Archbishop Seraphim visited the United States in the summer of 1978 I went to his residence and discussed Kopp and Bernadino. He again stated that the ordination was valid....BUT, UN-CANONICAL and that neither could function as priests.

An example is this: Joseph T. McGucken was Archishop of SF for the Roman Catholic Archdiocese. He resigned and now lives at St. Brendens. He cannot act in any epis copal capacity in this or any other diocese without the permission of the bishop of the diocese he intends to function in. Bishop Maxey did NOT receive the permissions. ion to ordain Kopp or Bernadino and in his Encyclical Letter of October 3, 1976, Mar Georgius of Glastonbury points out that while Dr. Maxey is in good standing, he does not have the faculties to ordain or consecrate.

Now, if anyone finds it necessary to prove all of this, let he or she, correspond with the proper authorities. The Roman Catholic Apostolic Delegation is in Washington D.C. They will be happy to tell you that neither Martin Donald LeRoy or Eugene Kopp are NOT PART OF the The Orthodox Episcopal Church of God (Church of God), wasf founded in nineteen hundred and sixxty-six in San Francisco. Services are held in

sixty-six in San Francisco. Services are held in San Francisco at 26 Seventh Street, with the mailing address for the Church being, Post Office Box 1528, San Francisco, California 94101. The Church of God, being a Christ-body, a voluntary association of peoples and churches who with faith, stand together to bring a bout the promelgation of the faith and the truths of the Christ Jesus of Nazareth, the only begotten Son of God. We hold fast to the true teachings of Christ Jesus, which were kept pure by such saitns of the Church as Arius, and Origen. We recognize that the finite being being finite is subject to error. And that the agent of redemption being the Divine Logos, the Son of God, our Father-Mother God, through a distinct, derivative and subordinate. The Logos is the educator, the Inspirer, and is incarnate, the redeemer of fallen souls, and through the force of free-will of the finite being, there is a faster process of a return to the Father-Mother God. The Logos being a medium of creation of the Father-Mother God was endowed with a free-will and was made the recipient of Divine Grace. The Logos became flesh in Christ and after the Logos had entered into Christ, the human soul with which that is is far better to destroy ones-self than to take the life

became flesh in Christ and after the Loghe was created, ceased to exist.

The Orthodox Episcopal Church of God teaches that life is eternal, as promised by our Father-Mother God in Heaven abaove, as to given to us by Christ Jesus of Nazareth, for our life is our Soul and our Soul is eternal, and the Soul, never having had a begining thus does not have an ending, thus it is eternal and tries for perfection to be at One with the Father Mother God above, the Creator of all the Universes.

The Gospel of Saint John the first Book of the Holy Scripture of the Church, contains within it all or the Universal Truths and the Key to Perfection and Oneness with the Father

ths and the Key to Perfection and Oneness with the Father Mother God. St. Arius, disciple of St. Paul of Samosata, and later to become Bishop of Alexandria in 398 AD thus making two Bishops of Alexandria, one of the monarchial line and St. Arius, who preached that the teachings of Jesus Christ of Nazareth must be kept pure and free of materialism

and must be set aside from those of the Apostles. For this, he was condemned by the anti-Christ body called the Council of Niceawhich ignored his pleadings for purificiation of the Holy Scriptures. Many tens of thousands of people followed Arius, renouncing the Church of Rome, in 336 AD and Arius was named Bishop of Alexandria of the Church of God. He was followed by Eusebius of Nicomedia who became Bishop of Alexandria and had the favor of Constantius, son of the anti-Christ leader of the Church of Rome, at least until the Second Council of Nicea in 381 when Athanasius, Bishop of Constantinople decreed that anyone holding to the pure Christ concept as taught by St. Arius and St. Origen, would be put to death. Thus, Eusebius fled to Caesarea and became Bishop of Judea and Nicomedia. During this time the teachings of Christ as taught by St. Arius were spread throughout Europe and St. Ulfilas was the messenger of the pure Word. After his death in 398 AD it was learned that he was greatly successful amongst the Goths, and the Nordics of the Baltic country areas of Lithuania, Latvia and Estonia. The churches in this area to later join with the ill-fated Russian Orthodox Churches. and must be set aside from those of the Apostles. For this,






