Grand Jury Investigation of the NO APOLOGIES! May 21st Riot

The election of Harry Britt to the Board of Supervisors may hang on statements regarding the May 21st "gay" riots at City Hall, allegedly, to protest the light sentence of former Supervisor Dan White who got only 7 years for two assassinations, (Mayor George Moscone and Supervisor Harvey Milk).

The new Grand Jury, as the former Grand Jury, has brought before it various people who were at City Hall the night of the riot and those who had information on the "conspiracy to riot" that May 21st night. Harry Britt, an appointed Member of the Board of Supervisors, defended the riots, on numerous occasions, much to the shock of many gays. Britt has repeatedly told people that he "had no regrets" about the actions by the rioters that night. He has told people that the anger that gays felt at the verdict had to be expressed. He said he would not apologize for any statements that he has made about the riots.

To which attorney Terence Hallinan, who has "credentials" in the field of radical politics, particularly at San Francisco State in 1969 and other areas, has replied; "If Harry Britt is re-elected to the Board of Supervisors, following his conduct at City Hall (May 21st), it would be like electing Nero to the Roman Senate after Rome burned."

Britt was brought before the Grand Jury this past summer, in fact he was number, two to testify, and he was followed by the Rev. Raymond Broshears who testified also. Results of the testimony will not be knorwn until the Grand Jury completes its report on May 21st.

Many gays, in fact a good majority are very angry at the so-called "May 21st Defense Committee" for it's issuance of the t-shirts which they are selling showing a burning San Francisco Police Car and the words, "No Apologies ", "May 21st, 1979", "San Francisco". This t-shirt sale by the "committee" is allegedly to raise funds, but many gay activists have said "it is more like to raise hell and bring down further troubles on our heads".


Most gays have expressed sadness and dismay at the actions of the gays and straights that night at City Hall. The damage to City Hall, the brutality which followed, all makes May 21st, a "night of infamy". What the outcome of the Grand Jury will be, is only speculative at this time, but many feel that if they hand down their verdict before the election in November, that Harry Britt will be a sure loser.

Britt, whose campaign is in trouble, what with two gay challengers and two "straight" challengers going at him head on (when they can find him, one candidate complained), and that is something Britt tries to avoid direct debate with the other candidates.

Many gays have charged that Britt "is using Harvey Milk's ghost to try and get elected because he can't do it on his own merits!"

Britt's campaign became a bit more controversial recently when reports began circulating that he lived with E. Lee Clifton (Richard Elmon) when he first moved to San Francisco, from Texas.





Richard Elmon, 3 Years!

OWNER OF MALE MODEL/ESCORT AGENCY FOUND GUILTY OF FOUR COUNTS BY THE JURY AND SENTENCED TO THREE YEARS E.Lee Clifton, 57, owner of the long established and respected, "Richard Elmon Male Models" was convicted of two counts of pimping and two counts of pandering by a Superior Court Jury and on the 31st of August in Dept. 10 of the Superior Court, Judge S. Lee Vavuris imposed a sentence of three years of each count, to run concurrently, which is to say that Clifton got three years, but the Judge suspended 2½ years of that and gave him 6 months in the County Jail, with 30 days off for time-served, and three years probation. for time-served, and three years probation. Clifton has filed a motion of appeal to the District Court of Appeals and is free on bail pending out come of his Appeal, which could take as long as six months or so. He was given an extremely high bail of seven thousand dollars.

The Judge, S. Lee Vavuris, shocked the courtroom spectators with his "sermon on the Bench" that early August morning, preaching at Elmon and at the few concern gays in the courtroom. His behaviour was outrageous and the statements bordered on the silly-side. But he did come off as an "Anita Bryant in a black robe with white hair", was the coment one spectator made as he strode from the courtroom.

All who sat through the two week trial by jury, agreed that defense attorney B.J. Beckwith made a fine defense, but the prosecution's case was too heavily stacked against Elmon Clifton. The SFPD Vice cops had seized tapes at the home of Elmon Clifton, and these tapes of conversations between Clifton and alleged clients of his Escort and Model business (now defunct), were played before the Jury, much to the obvious dismay of the defense. One courtroom spectator comented that Elmon Clifton "needed a Rosemary Woods" (ala Nixon in the White House tapes affair). Then three of Clifton's former models testified against him, including the one who turned Clifton into SFPD, a Marty Conway.

Elmon Clifton was not contrite at his sentencing at all, and was very hostile to even those who had shown support for his case.

647a P.C. Declared Constitutional by **Supreme Court**

HIGH COURT UPHOLDS STATE LAW BANNING LEWD CONDUCT State prohibition of solicitation of "lewd or dissolute" conduct is constitutional, the California Supreme Court ruled on Friday September 7th. (Pryor v. Municipal Court, L.A. 30901.) The decision was written by Justice Mathew O. Tobriner. The court said: "Defendant Don Pryor seeks prohibition to bar his trial on a charge of violating Penal Code (PC) section 647, subdivision (a). This section declares that a person is guilty of disorderly conduct, a misdemeanor. 'Who solicits anyone to engage in or who engages in lewd or dissolute conduct in any public place or in any place open to the public or exposed to public view'. We agree with the defendant that the phrase lewd or dissolute conduct as construed by past decisions is unconstitutionally vague.

"If however, we can reasonably constructionally vague."
we should not, and will not declare the enactment unconstitutional." "Consequently, rejecting prior interpretations of this statue, we adopt a limited and specific construction consistent with the present function of section 647 a; we construe that section to prohibit only the solicitation or commission of conduct in a public place or one open to the public or exposed to public view, which involved the touching of the genitals, buttocks, or female breast, for purposes of sexual arousal, gratification, annoyance or offence, by a person who knows or should know of the presence of persons who may be offended by the conduct. As so construed, 647a,, complies with constitutional standards, we therefore deny defendant's position for write of prohibition." Prover had allowed by standards; we therefore deny defendant's petition for writ of prohibition." Pryor had allegedly solicited an undercover vice cop in Los Angeles in 1976. The jury deadlocked and the Court declared a mistrial, thus the appeal to the Supreme Court, which upheld 647a. Another gay publication had a front page article which said it had been "overturned", which is false. Nor had it been declared "unconstitutional" as the other gay paper so stated. Paul Hardman was the author of it.


We have to urge that you do all you can to re-elect Lee to the Board of Supervisors in November, and work and pray that he will change his advisors and begin listening to all segments of the community.



Many people cannot understand what is going on about them, and many times this is because that person is "addicted" to one of the many different "drugs" that abound in our "streets" and in our businesses in San Francisco. Alcohol is a drug....just as heroin is a drug. The mind-altering drugs, such as PCP (Angel Dust....which means the more you use it the better your chances are of ending up dead...angel..get it?), and SPEED are taking their toll in the community. The dealers, many of them are planted and supported by the San Francisco Police Department and the Federales. What? you say!!?? Oh yes, they (the SFPD, etc.) supply their "finks" and "stoolies" plenty of the drugs to sell and to use just so they can keep them booked to them and to the drug which they supply. to use, just so they can keep them hooked to them and to the drug which they supply. They find sleep very difficult also, if not impossible, particularly during the "run". The liver and kidneys which filter impurities from the system are forced to over work. And this creates a situation much like operating a complex water pump and filter system without water....it just burns up. Putting water into the pump, drinking lots of water helps, but not as much as NOT using speed in the first place. Because of the massive stimulation of the nervous system by meth and because appetite and sleep patterns are disturbed, an eventual state of toxic psychosis occurs more often than not. This is characterized by hallucinations.....tremendous panic.....or fear reactions.....with added waves of despondency and depression. And then, after several "runs" like this, you will finally either kill yourself by overdosing...or by getting into a fight with someone, a strong characteristic of a "speed freak", and them possibly killing you. But in the end, if the other two don't kill you.....the ruination of the body will. Many speed-freaks die yearly in our town..... will a friend of yours be next? You can help them get off it.....if you would!

As to P.C.P., it too has horrible side effects, and the number of people who die from the usage of PCP is growing daily. Yet, the "executioners" continue seeling it, and the numnuts keep right on buying it. You are paying for your own execution when you buy speed or PCP or any other of the drugs. You are your own executioner is some ways. The dealers of these death-drugs should be killed on sight. They are the enemy of the people. They serve "the man", and anyone who falls for their line, is only helping to destroy themselves and keep the "man" informed by buying from his "finks". Think about it...a healthy drug free body is a "threat" to the "man" and to all the corrupticians who try and control us by controlling the system. Keep helthy n' help liberate yourself and all others as well. Drugs/The Man are the oppressors of all liberation movements, including gay liberation as well. Think about it.

Dear Editor:

As we all know, San Francisco and the Bay Area has been receiving 7,000 ailing, aged and illiterate Asian refugees a month. And now, President Carter has doubled that number. Of course, these refugees will immediately receive welfare, free medical care and housing, etc; all at the expense of American taxpayers. It should be noted that these refugees has never contributed a thing a thing to the economy of this country. In the meanwhile, many of our own poor, elderly, disabled and

unemployed citizens are struggling to survive.

The future does look bleak for gays and other minorities as well.

These refugees land in this country (they're flown here first-class) and given preferential treatment. Well, these immigrants come here, take all we offer and demand more. They don't bother to learn the English language, so we print ballot and other materials in their languages We even supply teachers at a big cost to the taxpayers

who don't have a word to say about it. It is true that we American-born people are descendants

of immigrants. But we must also remember that at that time there were no "WELCOME WAGONS" waiting at the docks. There was no such thing as welfare.....free housing....etc. They, the early Americans, were so thank ful to be in this country that they WORKED VERY HARD against all kinds of odds to help build this nation. Our lives today are regimented by big government. President Carter tells us how critical the gasoline problem is. We are told we must sacrifice, must conserve our resources, must not take unnecessary trips, etc. Yet Carter went off to Camp David and summoned his advisors there. HOMMES BOYS

ONE MAN FREED BY COURT OF ANY WRONG DOING WITH TEEN AGE YOUTHS.....TWO OTHERS MUST STAND TRIAL. The first round of the one-going legal battle in San Francisco's "Boy

Man Sex Witch Hunt" took place on Agust 27 & 28th in the court-room of Municipal Court Judge Albert C. Axelrod. The District Attorney, Joseph Freitas, Jr., acting thru his deputy, Kathleen Umrine, astounded all by asking the Court to declare that

the Prosecution's witnesses (hers) were "hostile" so that they could be "led" "cross examined" by the Prosecution itself.

The witnesses, Paul Hommes 15 and Phillip Hommes 14, brothers, were first granted immunity from prosecution by the Court upon the District Attorney's motion.

From that point on, Ms. Umrine proceeded to "hound" her own witnesses whenever they testified differently from the tape recorded statements which they had given earlier to Sgt. Arthur Gerrans of the SFPD Vice Crimes Unit and his associate Susan Pavlov.

The witnesses testified that they made the tape recorded statements inplicating several Bay Area men because they were asked to do so by their friend, in order to help him, a Robert "Bob" Benny, who resides at 798 Post Street, apt. 104 who was then in trouble with the law for the fraudulent use of a stolen credit card.

The Hommes brothers testified that they never had sex with one of the defendants and that they had masterbated one other defendant, and had permitted an act of oral copulation with the third defend-

failed to testify at the trial. The defendants were represented by attorney B.J. Beckwith. The Court ordered all charges dismissed as to one of the defendants. And certified the other two to the Superior Court for trial

Mr. Beckwith indicates that he expects a long jury trial in the matter, since Freitas's office seems "hell-bent on pursuing this election year witch-hunt."



"CRUISING"; Film Controversy Flares

(Special from the Homosexual Information Center in Los Angeles, written by Charles Lucas.)

The summer of 1969 is often regarded as a watershed in the fight for civil liberties and for the emergence of the "new" homosexual in America. Jaded, role-playing pat--rons of the Stonewall, a gay bar on Christopher Street in New York's Greenwich Village, turned against the police and rioted. The fact that the Stonewall was a dirty "rotten hole" that deserved to be closed, that it opera ted without a license and in violation of fire regulations, that it systematically expolited "drags" and "gays" by charging them \$3.00 to get in, because they were barred from the more respectable places is beside the point. With that act of civil disobedience the repression against all homosexuality was dramatized. "Gay Liberationists" suddenly found their courage and their voices, and joined the homosexual movement whose achievements went back some 20 years. From that time on the common objective of this movement of loosely connected and seperately run organizations was to establish equal rights for all persons who perform socially nonconforming sex acts and to eliminate discrimination on this basis in what-

Stonewall signalled a national coming out on a grand scale. Latent and guilt-ridden "gays" went public in a big way. They demonstrated, walked, marched, paraded, enfused with a sudden gay pride. They lobbied and whoop ed it up. The visibility of these former nonentities dismayed many, and disheartened others who suffered in the light of that visibility. But eventually the "new" homosexual was absorbed into the mainstream of the homo sexual movement where he closed ranks with the other diverse elements. This ability was the movement's strenght. We quickly discovered that despite our partisan and tactical differences we could work together for sexual

As the Stonewall decade drew to a close a united homosexual movement had the clout to take on the anti-gay orange juice crusaders and their lower class morality... And we demanded to be spared the insufferable hypocrisy of middle class respectablity too. West Coast groups were euphoric when the cause espoused by that gadfly on the rump of California legislation went down to defeat in his efforts to legislate against the homosexual teachers through a ballot box appeal to bigotry. The decade was one of enormous progress; it was a success story. Ten years ago, Wm. Friedkin was in New York City filming the play "The Boys In The Band". Shooting of the film took place not far from the site of the Stonewall. The story portrayed homosexual men as a class of stero-typical bitches filled with self-hate. But the play and the movie were good entertainment, and we had to laugh as

that the "camp" dialogue rang false to initiated ears. No gays---even in their giddiest moments----ever spoke like the boys in the band. The only ripple the movie caused among the general public was an occasional snicker accompanying the ads: ",,, Not A Musical."

Now, 10 years later, Wm. Friedkin is back in New York

filming "Cruising", a movie based on Gerald Walker's 1970 novel of the same title. The story deals with a particularly brutal, sordid murder involving homosexuals on both sides of the law. It impinges on an undercover cop who in the course of his work confronts his own homosexuality and his own homophobia as he investigates the grizzly murder. It looks upon a vile and miserable side of "gay life". The scenes are of leather bars, explicit back room sex, and the brutality of the neo-nazi element of

the "whips and chains and bondage bunch." But the representation is accurate. These tyles and situations do exist. They may not be ideal, but they are real. There are homocidal homosexuals.

And West Hollywood is full of mindless, levied and mustachioed clones-----who caricature themselves in real life far more than any movie could. So what?

Even if the characters and incidents in "Cruising" were entirely fictional----the hallucinations of a crazed mind--it could not affect its artistic creation.

So what are the "new" homosexuals who gave birth to gay liberation doing? They are busily engaged in their own form of bigotry. Shades of Anita Bryant!!!!!! These once blythe spirits are disgracefully frittering away their time and money protesting the filming of "Cru ising". Worse yet, they are trying to enlist the sympathies and support of other unwary movement groups. Lamentably enough, they have succeeded in some cases. To argue against and adversely criticize the completed product is one thing. But to try to block production of the movie is quite another, and intolerable. It is censorship. And censorship is always a worse evil that the evil it seeks to stamp out. To stop the filming of "Cruising" is no way to fight repression. Fortunately, the "Children of Christopher Street" did

not have their censorship act together at the time of the publication of Walker's book in 1970. But a problem arises since the book may be reissued with the film. Is our response to be a banning of the book???? Are we going to picket the publisher and the book stores along with the theatres where the film shows??? How effective

Would we demand that a film about the psychopath charged with over 30 murders in a Chicago suberb be sto

That publication of a book about him be banned?? Are we going to demand that the First Amendment to the U.S. Constitution be deep-sixed???

We do not advocate banning anything. Homosexuality not long ago was itself a victim of the censor.

All of this might not be so bad if New York's gay leaders had nothing better to do. But New York is way behind in gay rights. 22 states have removed criminal sancctions from consensual sex acts between adults.

In these states homosexual relations enjoy the same protection as heterosexual relations.

But in New York 'consensual sodomy" is still a crime. Sexual relationships between persons of the same sex are regarded as "deviate", and they are punishable by

New York's gay community might better address itself to eliminating discrimination of this sort; it can start by making its own "gay lifestyle legal"

However, to affect these kinds of changes takes a hell of alot more work than the present sensational project. And it is not as much fun. Fights through legislatures, councils and courts are long

and discouraging. They are costly. But the fight is underway in other parts of the country-----where homosexual groups are not so well organized and financed as the gay groups in New York claim to be.

They predict that their demonstrations against "Cruising" will prove to be another watershed in the gay rights

It may only be a touch of midsummer madness. So let's address ourselves to the real issues of 1979, and look forward to another decade.

What will be have accomplished by 1989? If Mr. Friedkin is making another film in New York in 1989, and it has homosexual characters and themes, will he, and will we, have changed enough to have them be positive? Considering the current drama surrounding "Cruising" we wonder:



ALBEE AGAIN!

America's somewhat self touted "Enfant Terrible" of the 60's, Edward Albee is around again, this time in a nicely mounted production of "A DELICATE BALANCE" (at the Berkeley Rep., Tues-Sun, 845-4700 for info). Like so much of Albee, the play works, or doesn't work depending on one's viewpoint, on several levels, with realism often taking second place to convoluted symbolism and where the spoken words often have far different meanings than one wo-uld at first think. Many self proclaimed intellectuals find this sort of thing "deep" or "exceptional true to life" or "cutting through to the essence of meaning." Sorry, I find it merely dull.

One very large bonus point is that in this play Albee finally does manage a realistically drawn character who is truly humorous and congradulations to Shirley Jac Wagner for a fine portrayal of a heavy and heavenly drinker.

The play won the Pulitzer in '67, a dubious honor, I'm afraid, considering some of their other wayout selections in the last decade or so and one I've always felt was largely given to make up for the committee's lack of courage in not awarding one to the highly controversial "Who's Afraid Of Virginia Wolfe?"

ALMOST RECOMMENDED

DATED DANCING.....

Nearly forty years separate Agnes De Mille's ballet in the original "Oklahoma" and Bob Fosse's "Dancin' (at the Orpheum under the Civic Light Opera auspices, Tues-Sun, 555-4002 for info) but the differences are a great deal more than merely chrono-logical. DeMille's work was innovative, a new concept of integrating dance into musicals while Fosse's is derivative, dated and, if not borderline bad taste, of a calibre better suited to Las Vegas than the Orpheum

Rather vaguely advertised as an over all look at dance throughout history, the show comes across instead as a series of unrelated production numbers interspersed with solos, duets, etc., to allow the other members of the company to change costumes but seemingly having no other point or inter-relation.

Few of the numbers are more than momentarily enjoyable: the rather obvious humor and dubious taste of "The Dream Barre" where a prototype "Penrod" pays more attention to his partners anatomy than to the anatomy of the dance, Gary Chap-man being the show stopper in "I've Got Them

Feelin' Too Good Today Blues" and the finale, a splashy production medly entitled "America" made up of ten patriotic songs including "Yankee Doodle Dandy", "Dixie" and "Gary Owen" Splashy and flashy, "Dancin' " isn't a bad show, just doesn't sustain interest consistently and although well polished and professionally performed, it

just barely...

The San Francisco Repatory's production of Shaw's "ARMS AND THE MAN" (at their theatre 19th & Collingwood, Thurs-Sun, thru September 30th, 863-4859 for info) suffered the night I saw it from the constantly blown lines, especially Fred Hartman in the male lead, whose sloppy performance overshadowed the fine work by the female cast members, in particular, Victoria Emory, who gives a gem of a characterization as the saucy maid. Perhaps the lack of tightness was due to the three day lay off.......... I saw it on a Thursday night....and one presumes the weekend performances played more evenly.

However, the unquestioned star of the evening was Shaw himself, whose incisive satire pricks bubble after romantic bubble. Written more than eighty years ago the names have changed (today "read" any Third World country for Bulgaria, air force for calvary, microwave oven for electric bell, workers for servants) but the basic ideas are as true as when the "Widow of Windsor" sulked in that gloomy

monstrosity. A not-so-innocent young girl's romantic love and virtue, or lack thereof, an empty headed, posturing, self-proclaimed social leader, (of a non-existant Society) a hen pecked husband and father, a preening, peacock of a young lover.....each drawn with cutting clarity.....are both real and unerring ly true to life. Counterpoint to these less than admirable souls is Shaw's idea of the practical man, a Swiss hotel keeper's son, whose pragmatism makes everyone else's romantic notions seem so much bilge water. A superb play given a somewhat better than average production. RECOMMENDED

HASTINGS & COMPANY DOUBLY EXTENDED...

We believe that all who have accepted the Lord Jesus Christ as their personal Saviour, believing that He truly is the only begotten Son of God, who came down from heaven, died for our sins, was buried and on the third day arose, and sets now at the right hand of the Father God Almighty, the Creator. Our faith in the teachings of the Holy Gospel, which was inspired by the Holy Spirit, our Book of Life, which requires faith, hope and charity and due observances of the ordinances of the local Church. Faith, as taught by our Lord Jesus Christ, is a virtue infused by God, whereby man accepts and believes without doubting, whatever God has revealed in the Church concerning true religion. Faith is a virtue infused by God, and following upon Faith, by it..... man puts his entire trust and confidence in the goodness of God, through our Lord Jesus Christ, and who looks for fulfillment of the Divine promises made to those who obey the Gospel.

Charity is a virtue infused by God, and likewise consequent upon faith, whereby man, loving God above all things for his own sake and his neighbour as himself for God's sake, yields up his will to a joyful obedience to the revealed Will of God in the Church.

The Church which God has revealed and established on this earth, to be the pillar and ground of the revealed Truth, and the continuing revelations of God, and is committed unto the Church the guardianship of the Holy Scriptures and the Holy Traditions and the powers of binding and loosing.

We believe in one God, the Father/Mother God Almighty, Creator of the heavens and the earth and of all things visible and invisible

We believe in one Lord Jesus Christ, the only begotten Son of the Father God, before all ages, God of God Light of Light, Very God of Very God, begotten not made, of one substance with the Father, by Whom

Who for us men and for our salvation came down from heaven and was Incarnate by the Holy Ghost of the Virgin Mary and was made man. And was crucified for us under Pontius Pilate, he suffered and was buried, and on the third day he arose and ascended into heaven and setteth on the right hand of God. And Christ shall come again, with glory, to judge the living and the dead; whose Kingdom shall have no end

..And I believe in the Holy Ghost, the Lord and Giver of all life, Who proceedeth from the Father/Mother God, Who with the Father and the Son is worshipped and glorified, Who spake by the Prophets, then and now. And we believe in one Catholic, Orthodox, and Episcopal Apostoblic Church of God. And we believe in one Baptism for the remission of sins and look for the Resurrection of the dead in Christ and in the Life in the world to come.

This is our sacred creed, which is sufficient for the establishment of truth, as much as it explicitly teaches the perfect doctrine of the Father, the Son and the Holy Ghost.

The Holy Scriptures are writings inspired by God and given to the Church of God for instruction and edification. The Church of God is therefore the custodian and the only Divinely appointed interpreter of the

We call for spiritual renewal daily, in each of our members, thru prayer, meditation, penance. We urge all to remember the Scripture, "Christ in us, the hope of glory" (Corinthians 1:27)

We pray for the reunification of the Church of God here on earth. We pray that all Churches shall join as one, as was the wish of our Lord Jesus Christ. We urge that all do unto others as ye would have them do unto you, for it is written, "As ye show, so shall ye reap."

Rt. Rev. Broshears by those who lead these various denominations in the Americas.



Our natural vision should lead us to say that there are many Churches within Christendom, we perceive by faith, that the Mystical Body of Christ is singular and united by a Mystery where there is mutual agreement in the Orthodox Faiths with the same Sacrifice and and the same Sacraments, altho the Rites differ.

In our present state of sinful division, there has arisen a wall not only between the great historic Communions themselves, as well as between the numerous smaller Rites n the Americas.

What may have originally served as insulation against the proads of heresy seems to presently produce isolation.... thusly, between those of us who are Orthodox by conviction and our brethren who are Orthodox by virtue of birth into a family with Orthodox heritage. Thus far, overtures from those of us of the "neo-Orthodox" in this country have been in vain

Thusly a conclave of Bishops in the Americas has been called for, with the hope and understanding that some unity may come of it. As of this date, few have expressed an interest in such a conclave being held. Some have said that "too many homosexuals are involved today, and we do wish to become identified with them'

The latter item, we fell is what is truly hold up such an mportant meeting from ever coming about. Tis true that too many of the Bishops "wear their homosexuality like a badge", and that this is indeed wrong. But the Lord Jesus Christ did not cast out any for any reason, so who



our Lord Jesus Christ? In the City of the Angeles in southern California these types do exist, as well as in the city of Chicago and in Houston and in Oklahoma City and in Davis California. They are vain persons who defile the Word of God, and who stain the cloth they wear with their bigotry and hate. We ask, how can one be a Bishop, yet be a bigot? A prince of the Church cannot be a bigot, they must be all things to all people, for if they are not, they are not serving God

In the past year, KGO-TV, channel 7, an ABC affiliate, has continually been "on the backs" of various denominations and churches as well as "cults" in northern California.


